We ran the following program to address it: Local News

Date: 4/13/23 **Time of Day:** 8:00 am and 12:00 pm **Duration:** 5 minutes

Brief description of program (format, participants, contents, etc.): According to the US Drought Monitor Colorado is in technical drought. Statewide, drought has ticked upward to include 44 percent of the state.

Issue: Severe Weather in Colorado

We ran the following program to address it: news and weather

Date: 04/25/23 **Time of Day:** all day

Brief description of program (format, participants, contents, etc.): the National Weather Service is warned about hazardous rainfall that was expected. Precipitation would transition to snow, strong winds and hail up to the size of nickels were possible.

Issue: Scam

We ran the following program to address it: News

Date: 4/27/23 **Time of Day:** 8:00 am and 12:00pm **Duration:** 10 min.

Brief description of program (format, participants, contents, etc.): Phone scam is targeting northeast Nebraskans. The Sheriff's Office is warning residents about scammers pretending to be law enforcement. Citizens are receiving calls saying they have warrants and need to pay the county with prepaid cards. This is a scam, the sheriff's office said they will never ask for money and not to fall for the scam.

Issue: Public Service Announcement - Water Warning for the City of Oakley

We ran the following program to address it: news

Date: 5/03/23 - 5/11/23 **Time of Day:** 8:00pm-5:00pm

Brief description of program (format, participants, contents, etc.): The City of Oakley is issuing a Drinking Water Warning. KDHE Testing confirmed that one of the City's municipal wells tested at above the 10 mg/L nitrate level limit.

Issue: Amber Alert

We ran the following program to address it: Warning and news

Date: 6/5/23 and 6/6/23 **Time of Day:** 1:37pm and 2:03pm and news **Duration:** 10 minutes

Brief description of program (format, participants, contents, etc.): The state of Kansas issued an Amber Alert. Four children were taken by their mother and are in imminent danger. On 6/6 at 3:19 p.m. the four juveniles were located, unharmed and mother taken into custody.

Issue: 90 degree temperatures mean hot playground equipment

We ran the following program to address it: Story

Date: 6/27/23 **Time of Day:** 11:40 am **Duration:** 10 minutes

Brief description of program (format, participants, contents, etc.): playground equipment can turn dangerous absorbing the heat. When the outdoor air temperature reaches 90 degrees, playground equipment can easily heat up to a dangerous 120 to 150 degrees, capable of causing first- or second-degree burns.
