The name of this corporation shall be Radio Bilingue, Inc.

II

The purposes for which this corporation is formed are:

- (a) The specific and primary purposes are to operate a non-profit educational radio station and to perform public services;
- (b) The general purposes and powers are:
  - (1) to sue and be sued;
  - (2) to make contracts;
- . (3) to receive property by devise or bequest, subject to the laws regulating the transfer of property by will, and otherwise acquire and hold all property, real or personal, including shares of stock, bonds and securities of other corporations:
- (4) to act as trustee under any trust incidental to the principal objects of the corporation, and to receive, hold, administer, and expend funds and property subject to such trust;
- (5) to convey, exchange, lease, mortgage, encumber, transfer upon trust, or otherwise dispose of all property, real or personal;
- (6) to borrow money, contract debts, and issue bonds, notes and debentures, and secure the payment of performance of its obligations;
- (7) to do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of the corporation;
- (8) notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubtantial degreee, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation;
- (9) no substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

III

This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of California and within the provisions of Section 2370ld of the Revenue and Tax Code of the State of California.

The authorized number and qualifications of members of the corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability to dues and assessments and the method of collection thereof, shall be as set forth in the By-laws.

## VII

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this organization shall ever be for the benefit of any director, officer or member thereof or to the benefit of any private persons. Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for educational purposed and which has established its tax exempt status under Section 501(c)(3) of the U.S. Internal Revenue Code. If this corporation holds any assets in trust, or the corporation is formed for charitable purposes, such assets shall be disposed of in such manner as may be directed by decree of the superior court of the county in which the corporation has its principal office, upon petition thereof by the Attorney General or by any person concerned in the liquidation, in a proceeding to which the Attorney General is a party.
