**Re: Time Brokerage Agreement – Second Short-Term Extension**

Dear Mr. Sarkisian:

Reference is made to that certain Time Brokerage Agreement (“TBA”), entered into as of December 15, 2016, by and between Univision Radio Stations Group, Inc. (f/k/a Univision Radio Los Angeles, Inc.) (“Univision”) and AJE Media, Inc. (“Programmer”), as extended by that certain letter agreement dated December 6, 2019 and as further extended by that certain letter agreement dated January 11, 2023 (with the TBA, the “Agreement”). Capitalized terms used but not defined herein have the meanings ascribed to them in the Agreement.

As you know, the current Term of the Agreement is scheduled to end on March 15, 2023. By this letter, Univision and Programmer confirm their mutual intention to extend the Term through the earlier of (i) the date on which the parties execute a new agreement for the brokerage of time on the Station or (ii) April 30, 2023 (“Second Temporary Renewal Term”). The parties agree that, during the Second Temporary Renewal Term, Programmer shall pay to Univision the year 3 monthly Programming Fee, which is [REDACTED]

Pursuant to the Section 73.1212(j) of the rules of the Federal Communications Commission (“FCC Rules”), Univision hereby notifies Programmer, and Programmer acknowledges, that a broadcast station is required to include, at the time of broadcast, an enhanced sponsorship identification disclosure where programming is aired pursuant to a lease of time on a broadcast station and has been provided by a “foreign governmental entity” as defined in Section 73.1212(j) of FCC Rules, as may be from time to time amended (“Foreign Governmental Entity”). Programmer represents and warrants that it (a) is not a Foreign Governmental Entity; (b) has no knowledge of any individual or entity in the chain of production or distribution provided by Programmer that qualifies as a Foreign Governmental Entity; and (c) is not aware of a Foreign Governmental Entity providing or promising to provide any money, service or other consideration as an inducement to air any program or program matter provided by Programmer pursuant to this Agreement. Programmer agrees that it will notify Univision promptly if any of program or program matter provided by Programmer pursuant to this Agreement is or will be provided by a Foreign Governmental Entity. In this case, Programmer will include the disclosures required under Section 73.1212(j) of the FCC Rules in such program or program matter and will provide Univision with copies of the disclosures and a list of programs (including the names, dates and times each program will air) at least ten (10) days prior to such programs being aired. Programmer will notify Univision within 24 hours if the as-aired programming deviates in any

way from the pre-air disclosures. Programmer agrees that Univision shall have the right to reject any program that does not, in the Station's reasonable discretion, satisfy the FCC Rules governing sponsorship identification of programming sponsored by, paid for, or furnished by a Foreign Governmental Entity.

The Parties agree that this letter satisfies all notice requirements under the Agreement and waive any claims with respect thereto regarding a deficiency or breach of the Agreement under such notice provisions.

We look forward to continuing our relationship with you, and anticipate providing you with a draft agreement setting forth the terms and conditions for a longer-term relationship for your consideration in the near future. In the meantime, we kindly request that you confirm your agreement to the extend the Agreement as set forth herein by signing this letter.
