Dear Mr. Kitchen:

This is in reference to the request filed on October 22, 2019. TMS requests an extension of the STA granted on May 2, 2019, to continue operating at night with parameters at variance to allow time to complete equipment repairs. In support of the request, TMS stated that additional time will be required to finish the repairs.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and TMS may continue to operate during nighttime hours with parameters at variance from licensed values and reduced power in order to maintain monitor points within licensed limits (with no change to the licensed daytime operation). TMS must reduce power or cease operation if

complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR §1.1310. TMS must submit an e-mail to my attention to certify the date the station resumed licensed operations per BL-20010122ANN with negligible changes (to verify an FCC Form 302 filing is not needed to update the operating parameters).

This authority expires on May 5, 2020.
