We aired the Craig city council meeting where the following issues and more were discussed.

- City Manager Brixius and Mayor Duran presented a Special Recognition to Police Chief Cochran
 for receiving the Law Enforcement Executive Recognition from the Colorado Association of
 Chiefs of Police.
- The renewal of a Liquor Store liquor license for Jimmy D's dba Eastside Liquors with regard to a liquor violation. After discussion, the renewal was approved.

 Discussion and denial of an appeal request for a Violation/Correction regarding the owner of the land storing items on their land that others did not want there. This included a public hearing with comments from citizens.

- Water and Wastewater Director, Carl Ray, presented information regarding Ordinance No. 1148, an ordinance amending the Craig Municipal Code to increase the water and wastewater rates to provide sufficient revenues to maintain the balance of Water and Wastewater Enterprise Funds.
- EDA Award # 05-79-06111, The Yampa River Corridor Project construction bid per the recommendation of Riverwise Engineering for Schedules A, B, C, and D in the amount of \$3,275,504.80, contingent upon EDA's approval was presented to council. After discussion, all 4 schedules of the Riverwise Engineering bids were approved.
- A resolution authorizing the award for two contracts for the Yampa River Corridor Project was approved.
