Program: Information You Can Use

Date: January 8, 2024

Time: 6a

Issue: Legal Issues/Politics

Duration of Discussion: 12 Minutes – No Guest. The Host discussed the recent decision regarding the Colorado Supreme Court decision to remove Donald Trump from the ballot in the 2024 presidential election. The Host discussed the legal and political implications which included the high probability that the US Supreme Court will weigh in on the decision.

Date January 15, 2024

Time: 6a

Issue: Legal Issues/Politics

Duration of Discussion: 12 Minutes – No Guest. The Host discussed the recent legislation from the Alabama senate that would justify a charge of murder against anyone who provides illicit drugs to an individual who overdoses and dies. The Host discussed the possible defenses to such a charge.

Duration of Discussion: 12 Minutes – No Guest. The Host discussed the State of Alabama's recent decision to use Nitro Hypoxia for executions. Alabama had previously paused executions after two executions encountered serious complications.

Duration of Discussion: 12 Minutes – No Guest. The Host discussed the Alabama Department of Transportation's announcement that ALDOT will accept claims from owners of vehicles damaged by potholes on I-459. It appears that several cars traveling along I-459 near Hoover were damaged last week. The Host provided the audience with the details to file claims with ALDOT.

Duration of Discussion: 12 Minutes – No Guest. The Host discussed how the controversial Alabama School Choice bill is now law. Parents may now transfer their students and the state education funds that follow them to any school they feel is best for their child's education. The opponents of the law believe that the law will result in the poorest schools receiving even less funds.

Duration of Discussion: 12 Minutes – No Guest. The Host discussed warnings from the Better Business Bureau regarding the recent rash of online romance scams. Several online dating sites are being used by scammers to lure unsuspecting lonely seniors into relationships. Once the connection is made the scammers use the level of trust they have built to borrow money and/or encourage fraudulent investments.

Duration of Discussion: 12 Minutes – No Guest. The Host warned audience members to investigate before purchasing Virtual Reality Headsets. Recent studies have shown that VR headsets cause eye problems because of the heavy weight placed on the face. As a result of the number of reported eye injuries, Apple has discontinued sales of its popular VR headsets.

Duration of Discussion: 12 Minutes – No Guest. The Host discussed the recent bills introduced in the AL senate and house of representatives that ban the sale of meats that are processed in laboratories. Alabama is one of two states that has made it illegal to produce, process or sell meats originating in laboratories.

Duration of Discussion: 12 Minutes – No Guest. The Host discussed the State Attorney General's release of a new, updated version of the victims notification system. The updated version of the System will notify victims of violent crime about any decisions related to their perpetrator. They will be informed of parole hearings, and/or early release requests.

The Host reminded audience members that it's the parents' responsibility to maintain control of their children.
