## **Section II. Responsive Programs**

## A. EDUCATION:

"News Story"—Broadcast on October 3<sup>rd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The Lafayette School Board District 4 seat is set to become "at-large." This comes after the current District Four board member announced his resignation at a board work session. Brian Wagner says he's leaving the school board after 17 years because he's moving out of state. He will be vacating his seat starting tomorrow, October fourth. The board is tasked with appointing his replacement. The board will soon accept letters of interest from the public.

- "News Story"—Broadcast on October 10<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A West Lafayette Junior Senior High School Alumnus is the winner of the Nobel Prize in Chemistry. Moungi Bawendi graduated from West Side in 1978. He will receive the prize for developing a method to chemically produce quantum dots. Quantum dots are used for colors in L-E-D lights to increase computer screen resolution. They're also used as an organic dye in biomedical science...which is useful for cancer cell imaging.
- "News Story"—Broadcast on October 25<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Purdue researcher was awarded the National Medal of Science on Tuesday. President Joe Biden gave the award to Gebisa Ejeta for his outstanding contributions to the science of plant genetics. Ejeta has been studying sorghum, which is an ancient grain used as a food source for humans and livestock. He created hybrids of sorghum that are resistant to severe drought. His aid in increasing sorghum production has helped feed millions of people in Africa.
- "News Story"—Broadcast on November 17<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. You might have noticed continued work on the Klondike campus as construction season wraps up. The project is still a long way from being done. A renovated Klondike Elementary School will feature new classrooms, a new media center and a revamped gym, cafeteria and office. Construction is on schedule for the new middle school near U.S. 231. The building will have a capacity for up to 750 students.
- "News Story"—Broadcast on November 20<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Southwestern Middle School dance was cut short on Friday after the discovery of a bullet. That's according to an email from Principal Sarah Gustin to parents. Gustin writes that a student found a bullet on the cafeteria floor. She adds police were immediately notified and the dance was ended early as a precaution. She emphasizes no direct threat was made. The Tippecanoe County Sherriff's Office declined to comment.
- "News Story"—Broadcast on December 14<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Lafayette Central Catholic's Tim Bordenet will be inducted into the National High School Baseball Coaches Association Hall of Fame in December of next year. Bordenet has been an invaluable leader for both the CC Athletic Department, and as head coach for the Knights baseball team. In 26 years, Bordenet has won 19 conference championships, 18 sectional titles, 16 regional championships... and 11 semi-state championships.

#### **B. COMMUNITY INVOLVEMENT:**

- "News Story"—Broadcast on October 2<sup>nd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The West Lafayette City Council will vote on a resolution opposing the controversial LEAP water pipeline project. As we've reported, this project would pump tens of millions of gallons of water from the Wabash River in Tippecanoe County to Lebanon. Many people are concerned that pumping too much water would cause negative ecological and economic-development impacts in Greater Lafayette.
- "News Story"—Broadcast on October 3<sup>rd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The Lafayette City Council also unanimously approved new apartment buildings near Columbian Park. The project will take five existing lots and develop them into five, four unit homes with parking areas accessed from an existing alley. The project is being led by New Leaf Builders in cooperation with the City Engineers Office, which will have final say on colors and materials. The hope is to design the complex to look as if it's been a part of the community for years.
- "News Story"—Broadcast on October 6<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The Municipal Superintendent for the town of Monon is on leave...and facing state charges. According to a post from Monon Utilities, the Department of Environmental Management is accusing Tony Rodgers of falsifying records at the town's wastewater plant. The utility says there's no indication that any of the actions resulted in any health concerns. We reached out to the town and Rodgers for comment but haven't heard back.
- "News Story"—Broadcast on October 9<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Lafayette Parks and Rec is inviting the public to celebrate the newly renovated Armstrong Park next week. As we've reported, the park is getting several improvements like new tennis nets, basketball courts, and revamped baseball fields. Park officials say a new playground is more than 6 thousand square feet with a rubber surface. The dedication ceremony happens at the playground next Tuesday at 2 p.m. The address is 809 Beck Lane in Lafayette.
- "News Story"—Broadcast on October 10<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The American Red Cross is urging you to attend one of several blood drives in Lafayette as the agency faces a nationwide blood shortage. The days, times and locations include: 1 to 6 this afternoon at Sunrise Christian, 909 East County Road 500 South. 10 a-m to 4 p-m tomorrow at the Lafayette Pride community center, 640 Main Street. And noon to six tomorrow night at Crestview Community Church, 1400 Ortman Lane.

- "News Story"—Broadcast on October 19th, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. CityBus is working to attract workers to Tippecanoe County by launching a ride-share program. The initiative, CityVan of Greater Lafayette, is a partnership with Commute with Enterprise. It could result in residents of Benton, Carroll, Clinton, Fountain, Montgomery, and White counties, who work in Tippecanoe County to use the program's services.
- "News Story"—Broadcast on October 24<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The candidates for at-large seats on the West Lafayette City Council will debate issues facing the city. Iris O'Donnell Bellisario...David Sanders...James Blanco, Patrick Flannelly, and Brian Russel will answer questions during a one-hour debate sponsored by the League of Women Voters. They'll be in the WLFI studios, taking questions from News 18's Jeff Smith and Marlee Thomas.
- "News Story"—Broadcast on October 27<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Tonight's the night for trick-or-treaters. Here's a few safety tips provided by the West Lafayette Police Department. First, candy that appears to have been opened or tampered with should be discarded immediately. Parents should also use location tracking on their child's phone or device. Having a well-lit costume allows traffic to better see pedestrians at night. Lastly, if a home doesn't have a porch light on, skip that house.
- "News Story"—Broadcast on November 3<sup>rd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Purdue engineering expert says the controversial LEAP water pipeline project might not be as bad as some people think. Keith Cherkauer, director of the Indiana Water Resources Center, says the wells won't go as deep as Lafayette and West Lafayette's, and the project will pull water from the Wabash River rather than deep underground aquifers. The concern for him and other people in the state who study water resources is how many developments can be supported.
- "News Story"—Broadcast on November 3<sup>rd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The Indiana Supreme Court is reprimanding Attorney General Todd Rokita for comments he made about a doctor who performed an abortion on a ten-year-old girl. Rokita was found to have violated professional conduct rules when he referred to Dr. Caitlin Bernard as "an abortion activist acting as a doctor with a history of failure to report." He's ordered to pay 250 dollars. Two justices rejected the reprimand...arguing the penalty was too low.
- "News Story"—Broadcast on November 6<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. More opposition is surfacing against the I-E-D-C LEAP Project. A resolution being considered tonight by the Lafayette City Council expresses concerns about the transfer of water from Tippecanoe to Boone counties. The council will vote on the resolution during a meeting at 6 tonight at Lafayette City Hall. As we've reported, the West Lafayette City Council passed a similar resolution last month.

- "News Story"—Broadcast on November 7<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Today is Election Day for municipal races across Indiana. Voting centers in Tippecanoe County are open from 6 this morning until 6 tonight. There are a few things you should remember today before heading to the polls. Clerk Julie Roush encourages citizens to use Indiana voters dot org to see who's on their ballot and where they can vote. Roush notes absentee ballot must be submitted by six tonight.
- "News Story"—Broadcast on November 7<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. You can cast your ballot at nine voting centers in Tippecanoe County. They include the Wellness Center, Faith West Community Center and Margerum City Hall in West Lafayette, Evangelical Covenant Church, the Tippecanoe County Fairgrounds, the Northend Community, Christ United Methodist Church and First Church of the Nazarene in Lafayette, and Gathering Point Church in Dayton.
- "News Story"—Broadcast on November 10<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The holidays are approaching and many people are getting ready to put their Christmas trees up. Members of Lafayette Noon Optimist are getting ready for their annual Christmas Tree Sale. Sales will begin at noon on Saturday November 18 and will continue till Christmas Eve or while supplies last. The trees are located at the lot of Original Frozen Custard, at 2319 Wallace Avenue in Lafayette.
- "News Story"—Broadcast on November 14<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Governor Eric Holcomb is ordering the Indiana Finance Authority to take over the controversial LEAP water pipeline project. The study was originally overseen by the Indiana Economic Development Corporation. Holcomb is instructing the I-F-A to accelerate the start of a planned comprehensive regional water study for north-central Indiana. It will examine watersheds covering 12 counties including Tippecanoe Benton, Cass, Carroll and Clinton.
- "News Story"—Broadcast on November 14<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Westminster Village is hosting its annual Soup Day fundraiser for Lafayette Urban Ministry. Meals cost 14 dollars and all proceeds are donated to LUM. You can choose from broccoli cheddar soup or chili. The meal also comes with a maple vinaigrette salad, dinner roll and a pumpkin cheesecake bar. The fundraiser happens from 4 to 6 Thursday night.
- "News Story"—Broadcast on November 17<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Lafayette resident is settling into her new home. It's thanks to a partnership between Habitat for Humanity and Lafayette School Corporation called "The House the Schools Built." LSC administrators, teachers and staff volunteered their time over the summer to help build the house. Habitat hosted a house blessing yesterday featuring local officials to welcome Tina Hamilton into her new home. Hamilton says she's thankful.

- "News Story"—Broadcast on November 20<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Tippecanoe County commissioners will vote on an ordinance that would block the LEAP water pipeline. As we've reported, the ordinance would block anyone from exporting more than five million gallons of water a day to anywhere outside of the county. The local law would also block radial collector wells. Commissioners will vote on a first reading of the ordinance at 10 this morning at the Tippecanoe County Office Building.
- "News Story"—Broadcast on December 11<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Several local kids will have a merrier Christmas this year. It's thanks to Wabash Township Fire Department's first ever Shop with a firefighter event over the weekend. Firefighters paired up with local kids at the West Lafayette to help cross off items on their Christmas wish lists. Presents ranged from new winter wardrobes to popular toys. Captain Drew Hampton says the department hopes to host the event again next year.
- "News Story"—Broadcast on December 14<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The Indiana State Police Lafayette Post is recognizing Lieutenant Tom McKee for 30 years of service. McKee began as a detective in 2001 and was promoted to Investigative Squad Leader in 2004 and then to District Investigative Commander in 2009. He's been the District Commander since 2014. McKee is also a Purdue graduate and served in the Marine Corps. He lives in Warren County.
- "News Story"—Broadcast on December 20<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. State leaders are pausing the LEAP pipeline until a water study is finished and independently reviewed. The decision comes after a high-level meeting at the Purdue Airport between state and local officials. The pipeline could move millions of gallons of water a day from Tippecanoe County to an industrial park near Lebanon. A water study is happening right now to see if the pipeline is possible. Governor Eric Holcomb says a third party will review the results.
- "News Story"—Broadcast on December 21<sup>st</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Loving Heart Animal Shelter is asking for donations to prevent a possible closure. The shelter posted to social media -- asking for help with utility and animal-care costs. Loving Heart is a no-kill shelter located in Lafayette, right off Veterans Memorial Parkway. The organization has rescued more than 7-thousand animals since opening in 2000.
- "News Story"—Broadcast on December 21<sup>st</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. L-T-H-C and the Salvation Army hosted a memorial honoring those experiencing homelessness who died this year. Every year, on December 21st, National Homeless Person's Day is recognized across the country. The memorial happened in the middle of 12th street between the two service buildings. President and CEO of LTHC, Jennifer Layton, says 15 people experiencing homelessness died in Tippecanoe County this year.

### C. HEALTH AND WELFARE:

"News Story"—Broadcast on October 2<sup>nd</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. And authorities are still trying to figure out what caused a semi-truck to catch fire over the weekend. It happened on U.S. 41 South near the intersection with State Road 26 in Fountain County. Witnesses say they saw the driver drying to unhitch a smoking trailer, which soon became engulfed in flames. The fire was put out and no one was hurt.

"News Story"—Broadcast on October 4<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Lafayette woman is dead after a crash on the east side of Dayton. It happened just before 8:30 yesterday morning on State Road 38 and Delaware Street. Authorities say a car driven by a 25 year-old woman was traveling west bound and tried to pass a vehicle in a no passing zone. As she approached an eastbound vehicle, she lost control and crashed into a tree. The 3 year-old in the car suffered minor injuries but is expected to recover.

"News Story"—Broadcast on October 6<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. In an update to a fatal crash in Dayton, the Tippecanoe County coroner says a Lafayette woman died from blunt force trauma to the head and neck. The crash happened Tuesday morning at State Road 38 and Delaware Street in Dayton. Police say McClure was westbound and tried to pass a vehicle in a no-passing zone, then lost control as she approached an oncoming car and crashed into a tree.

"News Story"—Broadcast on October 10<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The Tippecanoe County coroner is still working to identify a passenger killed in a fiery hit-and-run crash on I-65. Coroner Carrie Costello released the man's preliminary autopsy results yesterday, saying he died from multiple blunt force and thermal injuries. As we've reported, the single-car crash happened around 3:30 Sunday morning near the 170 mile marker. Police believe the driver, 35-year-old Max Obando-Vanegas, was driving under the influence.

"News Story"—Broadcast on October 11<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. One person is dead after a wreck at about 11:40 a-m yesterday on U.S. 52 south of Veterans Memorial Parkway. Deputies say a pickup truck belonging to James

Weldon of Lafayette was broken down on the side of the north bound lane. Weldon was hit by Jeep while standing outside of his truck. First responders found him pinned under his truck with severe injuries. He was pronounced dead at the scene.

- "News Story"—Broadcast on October 11<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The passenger who was killed in a fiery hit-and-run crash on I-65 near Lafayette has been identified as 54-year-old Louis Kerr Junior of Indianapolis. The single-car crash happened around 3:30 Sunday morning in the northbound lanes near the 170 mile marker. Indiana State Police say a car ran off the east side of the road and hit a guard rail in the median. ISP says the driver, 35-year-old Max Obando-Vanegas, was driving under the influence.
- "News Story"—Broadcast on October 24<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A Bunker Hill woman is dead after a crash in Miami County. It happened just before five o'clock yesterday afternoon near Grissom Air Force Base at U-S 31 and State Road 218. Indiana State Police say 84-year-old Audry Boyer was t-boned at the intersection and pronounced dead at the scene. A helicopter rushed the driver of the other vehicle to a Fort Wayne hospital. The investigation is ongoing, but drugs and alcohol are not believed to be factors.
- "News Story"—Broadcast on October 25<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A 19-year-old Fair Oaks man died Monday in a late-night crash in Newton County. It happened on County Road 600 East in Roselawn. Witnesses told deputies the man was speeding with no lights on, then lost control while making a pass and trying to avoid a head-on collision with an oncoming vehicle. The man's car hit several mailboxes and a culvert before rolling several times. He was pronounced dead at the scene.
- "News Story"—Broadcast on October 25<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A moped driver is at an Indianapolis hospital after hitting a semi-truck yesterday afternoon in Lafayette. Witnesses say 52-year-old Scott Forsythe of Lafayette reportedly ran a red light and hit a semi at 18th and Greenbush Streets. He was initially taken to a local hospital before being flown to Indianapolis. Forsythe remains in critical condition as of this morning. The semi driver wasn't hurt. The crash is still under investigation.
- "News Story"—Broadcast on October 27<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. A fatal crash killed three people in northeastern Montgomery County. Details are slim at this time, but here's what we know so far. The crash happened yesterday afternoon at the intersection of county roads 500 East and 500 South near Darlington. The Crawfordsville Fire Department says 3 people were killed and a helicopter was called to the scene. It's unknown how the crash happened or how many vehicles were involved.
- "News Story"—Broadcast on October 30<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Authorities are investigating what caused a crash involving a car and a train. It happened at the railroad crossing on Wilson Street late last night. The collision

badly damaged the car and left it flipped upside down and resting on its roof. But nobody was hurt and the crossing is back open as of this morning. That's according to the Delphi Police Department's Facebook page. The crash remains under investigation.

- "News Story"—Broadcast on November 6<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The FAA is investigating a plane crash yesterday at the Glendale Airport in Kokomo. The Howard County Sheriff's Office says "an experimental aircraft" hit a golf cart and sent it tumbling while coming in for a landing. A woman in the golf cart was knocked unconscious and flown to the hospital with undescribed injuries. The pilot wasn't hurt. Police say a gust of wind caused the plane to drift into the golf cart, which was parked on the side of the runway.
- "News Story"—Broadcast on November 7<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. Officials have released the cause of a fire inside the press box at the Frankfort High School football field. The Frankfort Fire Department ruled the fire accidental due to an electrical issue. In a joint news release with F-F-D, Superintendent Matt Rhoda says Community Schools of Frankfort is moving forward to plans to demolish the press box and build a new one. As we've reported, the fire happened Halloween night. No one was hurt.
- "News Story"—Broadcast on November 8<sup>th</sup>, 6:00, 7:00, 8:00, and 9:00 AM Duration: 15 seconds. The White County Sheriff's Office is investigating a fatal wreck involving a car and semi. It happened on State Road 43 near Reynolds yesterday afternoon. Police say the car veered off-center and the semi driver tried to get out of the way, but was unable to avoid a crash. The crash killed Benton County residents, 56-year-old Kimberly Burge and 17-year-old Jaden Harvey.

Prosecutors later dropped murder charges against three of the suspects in exchange for plea deals. Adkins will be the third person sentenced in the case. He faces a possible 25-year prison sentence on a charge of burglary with a deadly weapon.

Knarr's wife told police she saw Kite rush into their apartment with a knife and stab her husband in the chest.
