Order/Production Requirements (Cont'd):

If you have commercials produced elsewhere and supply us with a dub, the dub must be of acceptable broadcast quality. Dubs on CD or sent via email are preferred. Cassettes are not allowed. "Home produced" spots are not allowed. The station reserves the right to refuse any dub that does not meet appropriate quality standards.

This station broadcasts only 30-second and 60-second commercials. Longer lengths are not permitted.

Rates:

Rates may change at station discretion.

Any political candidate desiring to run advertising that does not meet the requirements outlined in "APPLICABILITY" (above), must do so at the applicable regular rate.

All rates are "net to station." To calculate commissionable rate to agencies, divide the rate by .85.

Make Good/Rebates:
