Family Stations, Inc. ("FSI") is a nonprofit, tax exempt entity under Section 501(c)(3) of the IRA Code. Attached as Exhibit A is a copy of a letter from the IRS demonstrating FSI's status.

On behalf of FSI, we are attaching Exhibit B, the broadcast stations, including broadcast auxiliary stations, licensed to FSI which are exempt from payment of regulatory fees which are due September 24, 2015. Due to the continuing difficulty relating to the imposition of regulatory fees on FSI, FSI has been advised by Commission staff to submit this information annually to the Commission so as to avoid this wrongful imposition of regulatory fees on FSI.
