**Re: Insulation of Unitholder Interest**

Dear Mr. Lawyer:

Reference is made to that certain Amended and Restated Limited Liability Company Agreement by and among the Unitholders of OTA Broadcasting, LLC (the "Company"), dated as of October 5, 2011 (the "Agreement"). Capitalized terms not defined herein have the meanings specified in the Agreement.

In order to ensure that, in your capacity as a Unitholder, you are insulated from any deemed "attributable interest" in the Company under the Communications Act of 1934, as amended, and the rules, regulations and published policies of the Federal Communications Commission promulgated thereunder (collectively, the "Communications Laws"), effective immediately, and notwithstanding any other provision of the Agreement, you agree that you shall not:


- (i) act as an employee of the Company;
- (ii) serve, in any material capacity, as an independent contractor or agent of the Company;
- (iii) communicate on matters pertaining to the day-to-day operations of the Company with any officer, director, partner, member, agent, representative or employee of the Company;
- (iv) perform any services for, or relating to, the Company;
- (v) become actively involved in the management or operation of the Company; or
- (vi) vote for the addition or removal of any other Unitholder.

Furthermore, and for the avoidance of doubt, you agree that you will not take any action that you know would cause a violation by the Company or any of its affiliates of the Communications Laws.


