Section I. Issues

The station has identified the following issues as significant issues facing our community in this quarter:

- A. HOUSING AVAILABILITY – The lack of available housing in our area for low and median income
- B. BIOP – Environmental land use regulations and the effect on our community
- C. STATE GOVERNMENT – Information on State Senate business
- D. LOCAL EVENTS – Current events in our area

Section II. Responsive Programs

The station has broadcast programming dealing with each of the above-referenced issues. Programming dealing with each issue is set out below.

A. HOUSING AVAILABILITY

“ISSUES AND ANSWERS” – Broadcast on 4/1/17, 4/15/17, 5/20/17, & 6/3/17; Duration 3.5 minutes. A discussion with Erin Skaar of the Tillamook county housing task force about the lack of available housing in our county. Not just low income housing but the lack of median income housing which would attract qualified workers to businesses in the community.

B. BIOP – BIOLOGICAL OPINION

“ISSUES AND ANSWERS” – Broadcast on 4/8/17, 4/22/17 & 5/27/17; Duration 3.5 minutes. Commissioner David Yamamoto explains the NOAA Fisheries’ biological opinion in consultation with FEMA flood insurance program. There is a lawsuit proposed by environmental groups that says that the flood insurance program isn’t doing enough to protect endangered salmon and river habitat. The rules and regulations within this biological opinion would devastate Tillamook county and the effects felt in our county would be worse than anywhere else in Oregon.

C. STATE GOVERNMENT

“THIS WEEK WITH SENATOR BETSY JOHNSON” – Broadcast every Saturday morning at 9:00am; Duration 60 minutes. Senator Johnson discusses the current events in our state capitol and around the state. She discusses issues currently facing the legislature and the potential effects

of pending and recent legislation. She updates her constituents on matters that may concern them and answers questions from listeners submitted to her.

D. LOCAL EVENTS

“JUNE DAIRY PARADE PROMO” – KTIL AM broadcast an ROS schedule of advertisements promoting the June Dairy Parade, the official kickoff to summer in Tillamook. In all 50 minutes of airtime was used.

“HARLEM AMBASSADORS PROMO” – KTIL AM broadcast an ROS schedule of advertisements promoting the Harlem Ambassador’s event in Tillamook, a fundraiser for the Tillamook County Women’s Resource Center. Air time totaled 16 minutes.

“SAFE BOATING CAMPAIGN” – KTIL AM broadcast an ROS schedule of advertisements encouraging safe boating practicing and especially focusing on life jacket usage on water craft. Total air time 18 minutes.

KTIL AM ALSO AIRED LOCAL NEWSCASTS DAILY WEEKDAYS, 2.5 MINUTES IN DURATION EACH, TOTALING 23h 47m. KTIL AM AIRED PSAs THROUGHOUT EVERY DAY ADDRESSING MANY DIFFERENT TOPICS INCLUDING SOME OF THE ONES HIGHLIGHTED IN THE LONGER FORM PROGRAMMING. PSA TOTAL TIME 20h:30m.
