PUBLIC AFFAIRS RELATED PROGRAM DESCRIPTIONS

Devine Intervention – Monday-Friday 0600-0900 (August 23rd)

Guest was Neven Conrad. He discussed the Fort Dodge Baseball Association's loss of a building during a fire earlier this year. They also discussed sports as education, change of contractor for road work on S. 18th St., Patterson Field, and problems had with Carstonson Construction.

Devine Intervention – 0600-0900 (July 27th)

Guest was Terry Moehnke. He discussed downtown parking meters, not putting them around the library, questions Dr. Moehnke had with the meters we currently have, uncollected parking fines, and repairing downtown parking lots.

Devine Intervention – 0600-0900 (August 19th)

Guests were Tim Krayenbrink and Neven Mulholland. They discussed economic development state wide, tax abatements, tax rates, and other economic incentives. They also discussed how Fort Dodge competes on a state and national level for businesses to come to town.

Devine Intervention – 0600-0900

Guest was Julie Thorson. She spoke on the building of an Alzheimer's unit on the campus. It will have 32 rooms and will sit where the former Tompkin's Memorial Health Center once stood. She spoke about how the demand is increasing for Alzheimer's care. She explained that they can personalize areas of the building to suit the needs of the patients. She also discussed making the building secure with a secure courtyard.

The following summarizes a representative sample of programming that provided the most significant treatment of community issues during the past quarter. Programming frequently deals with more than one issue.

Coverage Addressing the Following Issues:

1. Iowa State Patrol investigates fatal accident on Highway 169. 23-year-old Brett Neal was killed when another vehicle ran a stop sign and hit the Neal vehicle.
2. SERT team executes search warrants. The 18 month investigation wrapped up with several arrests for drug crimes and gang participation.
3. Fort Dodge police arrested a person with a knife at WalMart. The suspect threatened himself and officers but was taken into custody without incident.

4. The director of the Fort Dodge Public Library resigned. He first became director in May 2015. The Assistant Director, Rita Schmidt, will serve as acting director
5. Tax statements due. The final day to pay taxes without interest has arrived and taxes are due by the end of the business day

SERT team arrests several on drug charges	September 29 th , 2016	1300	:30	An 18 month long investigation ends with several arrests. Police arrested and charge several people with drug offenses and gang participation.
Man with knife arrested at WalMart	July 29 th , 2016	0700	:30	Police were called to WalMart on report of a man with a gun. The man was agitated and threatening, but police remained calm. He was taken into custody without incident
Library director resigns	July 29 th , 2016	0600	:30	Greg Romer resigns as director of the Fort Dodge Public Library
Taxes Due	September 30 th , 2016	0600 (all day)	:30	Webster County Treasurer reminds citizens that taxes are due. This was the final day without interest.
