#### Quarterly Issues Programs List for Station KART July 1 – September 30, 2016 Placed in Public File October 10, 2016

#### Section I. Issues

The station has identified the following issues as significant issues facing our community in this quarter:

**A. Crime/Public Safety:** Recent thefts, robberies, drug crimes, and violent crimes affecting the Magic Valley with police seeking the public's help in catching the suspects.

**B. Military:** Information updates about a local soldier and his upcoming military trial and other military and veteran information.

**C. Highway/Utility Repairs:** The status of highway, freeway, and utility repairs and improvements in our areas, including bridges. Utility repairs may affect customers and/or affect traffic patterns.

- **D. Traffic Accidents:** Increase number of traffic accidents as the community heads into the summer, including road closures due to accidents, causes, and possible preventions to avoid injury and/or death.
- E. Education: Issues relating to public school education in our community.
- F. Growth: New businesses opening and others closing in the Magic Valley.
- **G. Politics:** Local politics affecting the public and voter information for the March presidential primaries and democratic caucus; statewide politics relating to Idaho's legislative session; national politics affecting rights to citizens.
- H. Fish and Game/State Fires on BLM Land: Seasonal information. Statewide fires on BLM land including updates on crews and acres burned including campsites and road closures due to fires.
- I. Local Commendations: Local citizens have made positive impacts in their community.
- J. Medical/Fire/Emergency Services: Local medical issues affecting the public and animals, such as influenza outbreaks (humans, parvo outbreaks (animals), change in hospital procedures, and hospital happenings, fire information for the area, residential and/or wildfires affecting the public.

**K. Community Events:** Local non-profit organizations and the College of Southern Idaho frequently place public service announcements on our station. These events are fundraising events, free to the public, or an event that raises awareness for the community.

**L. Consumer Recalls/Information:** Issues relating to consumer product recalls and other information on products that may affect the community.

M. National News: National news stories which directly and indirectly affect the community.

#### News Report July 1, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

The Minidoka County coroner has confirmed police suspicions that a double shooting Sunday was a murder-suicide. According to reports, coroner Lucky Bourn ruled Kelli Joann York's death a homicide and Lauren Jackson's death a suicide. Detectives suspected the deaths were connected to a domestic dispute.

Richi Rojas, of Twin Falls, a Home Depot employee, has been charged with stealing about \$3,000 from his employer by making fake returns and pocketing the cash and store credit. Rojas was arraigned Wednesday in Twin Falls County Magistrate Court on a felony count of grand theft and six felony counts of burglary.

#### News Report July 5, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Police disassembled a pipe bomb Thursday found at a gravel pit at 800 S. 150 E. southeast of Burley. The bomb had a half-burned fuse and was full of black powder. The Twin Falls Police Department bomb squad was called to assist with the device and the team used a robot to disassemble it.

On Friday, Twin Falls County Prosecutor Grant Loebs filed the motion to dismiss the rape charge against KMVT meteorologist Jack Holland based on additional information investigators got from witnesses who came forward after the preliminary hearing.

Thomas Pickett, who was awaiting transport to State Hospital South, was arrested on battery after allegedly throwing a punch at a health care worker. Pickett appeared in court Friday on the felony charge. Pickett's preliminary hearing is set for July 8. His bond is set at \$10,000.

According to reports, after police confirmed that Kettler had an active warrant, a search of her pursed turned up methamphetamine, marijuana, oxycodone, drug paraphernalia and a small notebook with a ledger allegedly used for tracking the sale of drugs. Twin Falls chiropractor Robert Johnson has been charged on four misdemeanor counts of sexual exploitation by a medical care provider. Johnson is accused in engaging in unwanted sexual contact with four women during massages. Johnson owned and operated Brain Core Therapy of Southern Idaho on Blue Lakes Blvd. N. Police are still seeking other potential victims who Johnson may have touched inappropriately. Johnson was arraigned Tuesday in Twin Falls County Magistrate Court.

## News Report July 8, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

A love triangle took a violent twist last week when Ashley Howell jealous of the affair between her friend and her husband, Tyler Howell, convinced her husband into inviting the woman over. According to reports Ashley then allegedly beat her with a wooden baseball bat while her husband watched. Both Ashley and Tyler have been charged with felony counts of aggravated battery and conspiracy to commit aggravated battery in Jerome County Magistrate Court.

## News Report July 10, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

More details have emerged from the Rupert murder-suicide last month that claimed the lives of 47 year old Kelli Joann York and her ex-boyfriend Lauren Jackson who according to police turned the gun on himself after fatally shooting York. Rupert police now say Jackson left behind a suicide note that apologized to those he hurt in the tragedy. After viewing surveillance videos and other evidence, Authorities now believe Jackson kidnapped York from her car, drove her against her will to and then forced her into his home, and then shot her six times while she was on the phone with 911.

A Burley man will spend 18 years to life behind bars after pleading guilty to second-degree murder in Cassia County District court on Friday. 34 year old Jose Lara has been convicted of strangling his then 25 year old wife Joann Lara to death at the couple's home in 2012. Lara was originally found

incompetent to defend himself when first charged with the crime, but that decision was reversed in 2014. Lara's sentencing is scheduled for August 30th.

## News Report July 12, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

A Jerome man convicted of sexually abusing an 11 year old girl at least twice last year will spend a minimum of seven years in prison. 68 year old Loyd Ray Wehrli was sentenced Monday in District Court. Throughout the case, prosecutors argued that Wehrli was a pedophile and a predator who abused the girl for years. In May, he pleaded guilty to two felony counts of sexual abuse of a minor under 16 after prosecutors originally charged him with two counts of lewd conduct with a minor under 16.

One of three men charged in an execution style shooting in Lincoln County last year will walk free from the charges in exchange for his testimony. 23 year old Eric Lopez was to appear in court for his preliminary hearing on Monday alongside the other two men charged in the case, but instead he was called as the second witness for the state. Lopez was originally charged with robbery, intimidating a witness and two counts of kidnapping in the case, but instead testified against David Gonzales Ceballos and Antonio "Buji" Jacob Gallegos in exchange for immunity.

## News Report July 14, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

A 38 year old Twin Falls man is behind bars after he allegedly threatened to beat and kill employees at a local Pizza Hut with a wrench. Seth Samuel Brooks was arraigned in Twin Falls County Magistrate court Tuesday on a felony count of aggravated assault. An employee who was behind the Pizza Hut on break said a silver Mitsubishi drove at her aggressively. Brooks got out of the vehicle, and then started yelling at the employee, accusing her of poisoning his pizza and threatened to beat and kill her with a wrench he pulled out of his car. His preliminary hearing is scheduled for July 22nd.

## News Report July 18, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Donald Schaeffer, of Twin Falls, is facing a felony burglary charge for stealing items out of another man's trailer and selling them at Pawn One in Twin Falls. According to reports Schaeffer the man reported a value of \$1,000 in stolen items from his trailer. The stolen items included electronics, DVDS, and video games.Schaeffer's bond is set for \$10,000 and his court date is scheduled for July 22nd.

## News Report July 19, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Yesterday evening Cassia County commissioners approved four new vehicles for the sheriff's office. According to reports, Cassia County Sheriff Jay Heward requested money to buy two new patrol cars for the city division to be paid for out of city contract funds, a patrol truck for the county and a sport utility vehicle for court transports at a cost of \$70,000 to be funded by the county.

The Twin Falls City Council accepted a bid to buy police body cameras from Taser International and discussed the 2017 budget. Reports say, City Manager Travis Rothweiler unveiled his proposal a week ago, and Council members will discuss it over the next few meetings before likely voting to adopt a budget at the end of August.

Holman Escobar, moving company worker, was arrested Sunday after admitting to stealing from a customer. Escobar was charged with felony grand theft by possession of stolen property after Idaho State Police allegedly found jewelry, valued over \$1,000, in his possession. According to reports,

Escobar admitted to taking the property with the intent to sell when he was arrested. His preliminary hearing is set for July 29th.

# News Report July 20, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Georgina Zamora, of Jerome, a former Producers Livestock employee who is accused of working with former state brand inspector Justin Archer, of Kimberly, to steal more than \$6,500 from her employer has pleaded guilty to a felony count of grand theft. Zamora is accused of writing a check to Archer who allegedly told police he kept half the money and gave half to Zamora. Zamora is set for sentencing Sep. 12th.

Jay Galentine, of Twin Falls, who was arrested late last year on drug possession charges was arraigned in court yesterday on a new charge stemming from the drug search warrant. Galentine was arraigned in Twin Falls County court on a felony possession of a controlled substance with intent to deliver. His preliminary hearing is set for July 29that the Twin Falls County Courthouse. His bond is set at \$1,000.

Reports say, a vandal pulled sprinkler pivot stops from the ground at two different Jerome County farms and left it them, then manually started the pivots. Without the stop in the way, the pivots were free to keep rolling. An attempt was made at a third farm with no success. The Jerome County Sheriff's Office says they have no leads on a suspect. The vandal caused about \$5,000 in damage between the three farms.

## News Report July 21, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

A preliminary hearing scheduled for Heyburn police officer Jeremiah Justesen is off. Justesen, already set for trials in separate battery and domestic battery cases, was arraigned in June on a charge of intimidating a witness and 27 no-contact order violations. Justesen's case is under advisement to allow the judge time to research the statutes being argued by the prosecution and defense. While the case is under review, Justesen's trials for domestic battery and misdemeanor battery where he is separately accused of grabbing a boy by the neck and putting him in a headlock in January have been moved to September 20th.

A recent small hike in break-ins in Rupert has officers reminding the public to keep their doors locked. From July 12th through the 17th, police responded to six calls of break-ins in homes and vehicles left unlock and with valuables in plain sight. According to reports, law enforcement thinks the break-ins are crimes of opportunity.

Juan Palmer, of Buhl, was arrested on warrant stemming from a grand theft charge after he allegedly stole his neighbor vehicle in late June. During the arrest, police found the man in violation of probation and parole, and in possession of a controlled substance.

## News Report July 22, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

"Kelly" Chacon was sentenced in May to 18 months in federal prison after the Internal Revenue Service found she prepared more than 2,500 falsified income tax returns for clients at her business, Kelly's Tax Service, in Burley. Now her insurance-producer license has been revoked by the Idaho Department of Insurance. According to reports, the IRS Criminal Investigations division found that between 2008 and 2011, Chacon and her employees prepared tax returns claiming the "child tax credit" and the "additional tax credit" for non-qualifying clients — this increased their returns and revenue for Chacon's business.

Reports say, Twin Falls County Prosecuting Attorney Grant Loebs issued an update early yesterday about the case of an alleged sexual assault of a 5-year-old girl at the Fawnbrook Apartments in Twin Falls. Loebs said investigators are continuing to gather new evidence and that the "nature and extent" of the charges against two boys involved may change as a result. The statement comes one day after leaders in the anti-refugee movement announced they were coming to speak and rally in Twin Falls next month, and as state lawmakers in other parts of the state have taken an interest in the case.

# News Report July 22, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

A speeding vehicle crashed into a field and through a fence on Rose Street North near Borah Avenue West in Twin Falls Wednesday night after a Twin Falls County Sheriff's deputy attempted to stop the vehicle. Both occupants fled from the vehicle, but authorities could not locate the individuals. Reports say that law enforcement identified Daniel "Pete" Bounds, of Buhl, as the possible driver of the vehicle. Bounds is believed to be in possession of multiple firearms and a hand grenade. A Twin Falls jury acquitted Fred Paiz after a three-day trial on charges of aggravated battery and aggravated assault. Paiz was accused in the Sep. 1stshooting of Marcus Loya at Harry Barry Park. But surveillance video showed him buying milk at Wal-Mart late at night Aug. 31st. After the jury returned its not-guilty verdicts on both charges Thursday and nearly 11 months in jail, Paiz was released from jail.

According to reports, Jerry Kimball was unaware of Jacob Marshall's plan to ambush and murder Kent Storrer last July 25th. A judge ruled, yesterday that Steven McRae, Kimball's attorney, would be granted access to Marshall's psychological evaluation. Kimball, is charged with six felonies in the case including murder and conspiracy to commit murder. He's accused of driving Marshall to Storrer's home, where they met Storrer and his son-in-law, Jasper Qualls, to test-drive a car Qualls advertised on Craigslist.

## News Report July 27, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Robert Andreason, of Burley, the man who sexually abused a 16-year-old who later had his child pleaded guilty yesterday and will likely spend at least three years in prison. Andreason was charged in May 2013 with sexual battery by lewd or lascivious acts of a minor child, rape, battery and intimidating a witness. The judge ordered a psychosexual evaluation for Andreason and set his sentencing in Cassia County for Sept. 13th.

According to reports, Twin Falls County Prosecutors say, Jody Neaderhiser, of Eden, was driving drunk with a blood alcohol level more than three times the legal limit to drive in Idaho — when he ran a stop sign and caused the crash that killed his passenger and longtime girlfriend Evette Phillips on Memorial Day just south of the Hansen Bridge. Neaderhiser was arraigned yesterday in Twin Falls County Magistrate Court on a felony count of vehicular manslaughter.

A couple accused of driving with 10 children in a van while high on pain medication is now facing charges in a string of home burglaries in Lincoln County. Michael and Lynn Von Berndt, were arrested yesterday afternoon in Jerome after authorities asked for the public's help in finding the wanted couple earlier in the day. According to reports, the couple will each be charged with six counts of burglary, six counts of conspiracy to commit burglary and one count of possession of a controlled substance. Lynn will also be charged with three counts of petit theft.

## News Report July 28, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Chad Steube, of Twin Falls, was arraigned yesterday on misdemeanor second degree driving under the influence, reckless driving and eluding a police officer. Allegedly, Twin Falls City Police attempted to pull Steube over on July 18th after being observed going about 80mph on Blue Lakes Blvd. instead Steube fled from police. According to reports, Steube eventually struck the patrol car and suffered only minor injuries. Steube's preliminary hearing is set for Sept. 7that the Twin Falls County Courthouse.

## News Report July 31, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Police arrested Mulugeta Mana, of Twin Falls, yesterday, on suspicion of aggravated battery, after he reportedly attacked another man with a knife behind Washington Street Pawn. According to reports, this was not Mana's first arrest this week. He was arrested Tuesday and arraigned Wednesday on misdemeanor counts of trespassing and failing to present identification for liquor.

Teresa Martinez, the second woman in a welfare fraud case was sentenced in Cassia County District Court to one to 10 years on a felony charge of public assistance fraud by means of a false statement. Under a plea deal, two additional charges of fraudulent procurement of public assistance and aiding a person to conceal property to qualify for assistance were dismissed. Martinez was one of three sisters charged with public assistance fraud after the Idaho Department of Health and Welfare said the three women scammed more than \$221,000 in public-assistance benefits.

A Twin Falls mother is seeking the community's help to find her missing 17-year-old daughter. Bryanna Cano, who turned 17 two days before she went missing, was last seen by her family about 10 a.m. July 19th. Anyone with information about Bryanna's whereabouts can contact Twin Falls city dispatch at 735-4357.

## News Report August 1, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

John Howard, the 18-year-old Dietrich High School football player charged in an alleged locker room sexual assault of a black, mentally disabled teammate, has waived his right to a preliminary hearing, which was set for Friday. Howard will likely be arraigned in district court later this month. Howard's co-defendant, Tanner Ward, is set for a jury trial on September 21st.

On Thursday Twin Falls police arrested Mulugeta Mana, 32, after he allegedly attacked another man with a knife near Washington Street Pawn. During his arraignment Friday on a felony count of aggravated battery with a deadly weapon, Mana refused the help of an attorney and told Judge Redman many times that he didn't want to be or need to be informed of the charges against him. According to reports, Twin Falls County Deputy Prosecutor Suzanne Craig requested his bond be set at \$1 million, citing Mana's various other charges between Twin Falls and Salt Lake. Mana reportedly told judge Redman that he could make is bond \$100 million, he didn't care. So the judge set Mana's bond at \$100 million and he is being held at the Twin Falls County Jail and is set for a preliminary hearing Aug. 4th.

## News Report August 3, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Two Elmore County deputies shot Matthew David Conrad, of Hammett, who reportedly stole a pickup, led officers on a chase, attempted to carjack three different vehicles and then pointed a firearm at the deputies. I-84 was closed in both directions between Hammett and Mountain Home for several hours. Investigators located the victims of the attempted carjackings, but they still want to talk to any other witnesses. Witnesses who have not yet talked to police are asked to call Idaho State Police District 3 Investigations at 208-884-7110.

Jacob Lyn Marshall was sentenced to 70 years to life in prison yesterday. Marshall pleaded guilty in June to the murder of Kent Storrer, accepting a plea deal that will likely keep him in prison his entire life; the soonest he could be paroled would be 2085 at age 90.

Police are seeking the public's help to find missing 14-year-old, Anni Gwin, who was last seen by her family about 2 a.m. Monday. They believe Gwin ran away with 43-year-old Charles Isaac "Ike" McLaughlin of Silver Springs, Nev. According to reports, police believe Gwin went with McLaughlin willingly. Reports also say, McLaughlin is believed to be driving a black 2000 Chevrolet Impala with Idaho license plates 2T 27538. Gwin has at least two piercings in her bottom lip, a tattoo of three small music notes behind her ear and a tattoo of a large treble clef on her forearm. She's also travelling with a brown puppy.

Seth Newbry is charged with fraudulent use of a credit card, which, according to reports, police say he stole from a customer at Johnny Carino's where Newbry was the victim's waiter. After she paid, she said he never returned her card, and she didn't notice until the following day. By that time, she said her account had a charge of \$107.44 at Fred Meyer. Police investigated the transaction, and used security footage to get a picture of the fraudulent purchase. Newbry's preliminary hearing is set for Aug. 12th.

Sixteen year old Sandy Moore was allegedly taken from her home in the night in Sheridan, Montanan, by Rodney Zahn. Sandy is described as 5-foot, 6-inches tall, weighing 116 pounds with brown hair and eyes, and wears glasses. The teenager was last seen wearing a white shirt with black short sleeves and jeans. The child is mentally delayed, according to the National Center for Missing and Exploited Children website. They are believed to be driving a 1987 black Ford pickup, with a white toolbox and a green bicycle in the back, bearing Montana license plate 3-50558B. The truck was also believed to be pulling a tan and white fifth wheel trailer with a red generator and a blue cover on the back of the trailer. According to his plea agreement, he'll be sentenced to 15 years in prison with a fixed minimum of five years.

Mohammed Hussein Eldai was arraigned yesterday in Twin Falls County Magistrate Court on a charge of sexual abuse of a vulnerable adult. According to reports, the woman, who lives with her mother because of her disability, told police she went for a walk Saturday but became hot and tired and stopped to lie down on the sidewalk for a nap. That's when Eldai found the woman and told her she could rest at his home. The woman reportedly accepted and that's when the crime allegedly took place.

Joshua Winmill, of Rupert, has been charged with felony aggravated battery, aggravated assault, domestic violence, battery inflicting traumatic injury, a domestic battery enhancement for committing a crime with children present, and attempted strangulation after, according to reports, police say, he forced a woman to drive into oncoming traffic, kept her imprisoned in a bedroom and forced her and four children to lie on the floor while he brandished a gun and threatened to kill them.

Jesus Perez, of Heyburn, has been arrested and federally charged with drug trafficking. According to reports, U.S. Attorney Wendy Olson said Perez was arrested Aug. 3rdand arraigned on charges yesterday in federal court. Desind is being held at the Mini-Cassia Criminal Justice Center on a \$75,000 bond. The maximum penalty for sexual abuse is 25 years in prison, and the maximum penalty for lewd conduct is life in prison.

Homeowners can apply to receive a 50-percent match, up to \$1,500, for repairing sidewalks, curbs and gutters that don't meet Americans with Disabilities Act regulations.

July 1 is the day most laws passed during the year's Idaho legislative session take effect. Here are a few of this year's changes. With a few limited exceptions, Idaho residents won't need a concealed carry permit anymore. The 2016-2017 budget bills begin, and that means the funding for a planned behavioral health crisis center in Twin Falls gets released. Amendments to the state's animal cruelty law that define torture and draw a distinction between companion and production animals will take effect. Cities and counties in Idaho will be barred from setting their own minimum wage laws, and neither will they be able to set regulations banning plastic bags, takeout boxes or other "auxiliary containers."

A fire burning east of Boise has grown to nearly 4500 acres and was 50 percent contained yesterday afternoon. Four more hotshot crews were requested and an air tanker was flying to assist to help with what is being called the Mile Marker 14 fire. According to reports, five crews and four hotshot crews are working to contain the blaze just off Highway 21 heading toward Idaho City. The fire is believed to be human caused and is still under investigation. The area should be avoided if at all possible. For up-to-date road and travel conditions please contact the Idaho Department of Transportation information line.

Fire crews are fighting a central Idaho wildfire eight miles north of Idaho City and campers in the area have been evacuated. The fire had grown to more than 500 acres by yesterday afternoon. An area closure is in effect, and includes all National Forest System lands within the boundary map beginning at the Junction of Bear Run Road and Main Street in Idaho City. More than 200 firefighters were battling the fire. Additional resources, including four hotshot crews, have been requested.

## News Report July 22, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Reports say, hot temperatures and dry conditions pushed a fire burning near Idaho City to more than 1,300 acres in size yesterday. Nearly 300 firefighters, including five hotshot crews and five helicopters, are working the blaze, which was 20% contained last night. Further south, closer to Boise, crews made good progress on the wildfire that destroyed three structures and burned 4300 acres near Hilltop Station on Highway 21 this week. Thanks to cooler temperatures and higher humidity, overnight, that fire was 80% contained as of last night.

Fire crews are working around the clock in their efforts to contain the Pioneer Fire burning north of Idaho City. Officials shut down a 25-mile stretch of Idaho 21 just north of Idaho City and south of Lowman. More than 900 fire personnel are now working to contain the blaze, which is 33 percent contained.

The Pioneer Fire, north of Idaho City, grew to nearly 13,000 acres yesterday and crossed Highway 21 north of China Creek. Nearly, 1,000 firefighters are working to extinguish the wildfire that started on July 18. The fire is considered 35 percent contained. According to reports, the U.S. Forest Service is urging people to keep their drones out of the sky.

Fire crews from the Salmon Track and Rock Creek Fire Departments were called to a brush fire north of Nat Soo Pah Hot Springs. According to reports, Lori Steward with Twin Falls County says, fire crews were called to 2800 East and 2500 North, about 13 miles south of Twin Falls yesterday afternoon. At the time of this report, no structures were in danger and no other information was available.

## News Report August 1, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

The Pioneer Fire burning timber in rugged terrain between Idaho City and Lowman and pushed by winds expanded to 42 square miles or over 27,000 acres Sunday as firefighters had to abandon fire lines

and drones once again interfered with aircraft operations. About 1,200 firefighters are battling the fire that has now expanded to the east and north with embers igniting new fires up to a third of a mile away. The blaze grew by almost 9,000 acres since Saturday evening and is only 27 percent contained. Highway 21 is closed 6 miles north of Idaho City to south of Lowman, there is now an extensive closure of the Boise National Forest as well.

## News Report August 2, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

The Blaine County Board of Commissioners recently approved nearly \$500,000 in funding for the \$1.5 million Deer Creek Watershed Restoration Project. The Deer Creek Watershed, located north of Hailey, was badly damaged during the 2013 Beaver Creek Fire and the heavy rains that followed. The Idaho Conservation League and Trout Unlimited partnered with the U.S Forest Service and applied to the Land Water and Wildlife Program for the grant. Those groups, along with 5B Restoration Coalition and the National Forest Foundation, have already raised more than \$1 million for the project.

The Pioneer Fire, burning eight miles north of Idaho City, has now grown to nearly 60 square miles or over 38,000 acres and is only 30% contained at the time of this report. It's the third largest wildfire in the country. Firefighters are doing back burning along the northern and southern flank to help prevent the fire from spreading into Idaho City and Lowman. Residents in Lowman have already been informed they may have to evacuate. Although the blaze is over 100 miles away, parts of the Magic Valley have been affected by the smoke from the fire. According to reports, those individuals with respiratory problems such as asthma or COPD may experience breathing issues and are to exercise caution when going outdoors.

# News Report August 3, 2016 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Firefighters continue their efforts along the northern flank of the Pioneer Fire as it continues to grow closer to Lowman. According to reports, officials are saying that the wildfire is just three miles away from the town, but no evacuations are in place at this time. At last check the Pioneer fire has grown to over 42,000 acres at the time of this report.

According to reports protests were also held in several other cities across the country Thursday night after a Minnesota officer fatally shot Philando Castile, on Wednesday, while he was in a car with a woman and a child. The aftermath of the shooting was live streamed in a widely shared Facebook video. A day earlier, Alton Sterling was shot in Louisiana after being pinned to the pavement by two white officers.

That, too, was captured on a cell phone video. Due to the attacks on police in Dallas, law enforcement officials remain on high alert.

According to reports, authorities said Rahami is "directly linked" to bombings Saturday in New York City and Seaside Park, New Jersey, and is believed to be connected to pipe bombs found Sunday night in Elizabeth, New Jersey.

The lone suspect in the fatal shooting of five people, Friday night at a Macy's store at the Cascade Mall in Burlington, north of Seattle has been charged with five counts of first degree murder. Arcan Cetin was taken into custody Saturday night after a nearly 24-hour manhunt. Authorities arrested Cetin as he walked down the street near his home in Oak Harbor, Washington.

Arnold Palmer, a seven-time major winner who brought golf to the masses and became the most beloved figure in the game, died Sunday from complications with heart problems. He was 87.

Two children and a teacher were shot at an elementary school playground in Townville, South Carolina. The suspected shooter, a teenager was quickly taken down by an unarmed volunteer firefighter.
