Quarterly Issues Programs List for Station KBAR January 1 – March 31, 2016 Placed in Public File April 10, 2016

Section I. Issues

The station has identified the following issues as significant issues facing our community in this quarter:

A. Crime: Recent thefts, robberies, drug crimes, and violent crimes affecting the Magic Valley with police seeking the public's help in catching the suspects.

B. Military: Information updates about a local soldier and his upcoming military trial and other military and veteran information.

C. Highway/Utility Repairs: The status of highway, freeway, and utility repairs and improvements in our areas, including bridges. Utility repairs may affect customers and/or affect traffic patterns.

D. Education: Issues relating to public school education in our community.

E. Growth: New businesses opening in the Magic Valley.

F. Politics: Local politics affecting the public and voter information for the March presidential primaries and democratic caucus; statewide politics relating to Idaho's legislative session; national politics affecting rights to citizens.

G. Fish and Game: Seasonal road closures by Idaho Fish and Game due to migration, fish stocked in local waters, and Fish and Game phone scam warning.

H. Local Commendations: Local citizens have made positive impacts in their community.

I. Medical: Local medical issues affecting the public, such as influenza outbreaks, change in hospital procedures, and hospital happenings.

J. Community Events: Local non-profit organizations and the College of Southern Idaho frequently place public service announcements on our station. These events are fundraising events, free to the public, or an event that raises awareness for the community.

Section II. Responsive Programs

The station broadcasts news and public announcements with each of the above-referenced issues. Programming dealing with each issue is set out below.

A. Crime:

News Report January 4 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute The state attorney general's office is prosecuting Savannah Armstrong, of Jerome, for defrauding the state's Medicaid program of \$633.84. Armstrong was arraigned Wednesday in Twin Falls County Magistrate Court on felony counts of provider fraud and forgery and a misdemeanor count of petit theft. Armstrong, who was employed by A Caring Hand Home Health Care in Twin Falls, is accused of routinely lying about her hours and the services she provided for an 84-year-old man she was caring for in late 2014 and is also accused of forging the signature of the elderly man's wife.

News Report January 4 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Jerome Police are investigating the discovery of a dead body outside the Crest Motel in Jerome early Sunday morning. According to reports it appeared the victim was a male wearing light colored shorts who had collapsed in front of one of the motel rooms.

News Report January 4 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute The Twin Falls County Sheriff's Office continues its investigation of the infant found in a diaper bag early New Year's Eve morning. Sheriff's deputies were so moved by the event, they believed the girl deserved a better name than 'Baby Jane Doe'. They have named her 'Angel Rose.' Mike Park, the owner of Parke's Magic Valley Funeral Home on Kimberly Road in Twin Falls, has offered to donate his services so that the community can gather together and send the infant girl to rest with a proper service.

News Report January 4 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute The deadline for prosecutors to file their intent to seek the death penalty against Jacob Marshall of Twin Falls has been extended two more months. Marshall is charged with six felony counts including murder and murder conspiracy in the July 25th slaying of Kent Storrer. The case of Marshall's accomplice, Jerry Kimball, of Twin Falls, is in limbo until the death penalty decision is made in Marshall's case. There are currently no scheduled hearings for Kimball.

News Report January 5 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Clayton Garro, of Burley, who is accused of fracturing a 3-month-old girl's eye socket causing her brain to bleed, has made a plea deal with the Cassia County prosecutor. Garro was charged with felony injury to a child in March. He was released from jail in May after his \$75,000 bond was reduced to \$1,500.Under the plea agreement, Garro will enter an Alford plea, which means he does not admit to all the elements of the charge but the state may have enough evidence to convict him. The prosecutor will recommend Garro enter a therapeutic program directed by the Idaho Department of Correction with a possible sentence of three to eight years in prison if he fails the program. If Garro does well in the program, he could be released on probation rather than face prison time.

News Report January 5 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute The man who died outside a Jerome motel Sunday morning has been identified as David Mair of Jerome. According to reports, the Jerome county coroner says that his death was attributed to natural causes. There were no indications that a crime had been committed to cause Mair's death.

News Report January 5 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute An Oregon man has been charged after a November crash that killed Robert Paulson of Rupert. Joseph Murray, of Pendleton Oregon, is charged with misdemeanor vehicular manslaughter in the death of Paulson. A pretrial conference is set in the case at 11 a.m., this morning in Minidoka County Fifth District Magistrate Court.

News Report January 6 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Mexican citizen, Antonio Beltran, who pleaded guilty to rape in 2006 in Twin Falls was arrested in Texas. He pleaded guilty to rape in 2006, and was sentenced to one to four years in prison. Beltran was released in 2009 and was deported after his prison sentence was over. He was also deported in both 2014 and 2015. Beltran now faces a federal charge of reentry after deportation, which carries a penalty of up to 20 years in prison.

News Report January 7 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute7

The Jerome County Sheriff's Office has reported that the Monastery of the Ascension of Jerome has reported two burglaries in the last 30 days. In the first burglary someone entered the gift shop and stole an undisclosed amount of cash from the cash drawer. In second burglary, someone stole an ornate golden Tabernacle. Reports say the tabernacle that was taken has an estimated value between twenty and forty thousand dollars, but that an individual would have a difficult time re-selling it. Anyone with information about the burglaries is asked to call the sheriff's office at 644-2735.

News Report January 7 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Jesus Valdez, of Burley, has pleaded guilty to sexually abusing two boys for several years.Valdez was originally charged with three counts of sexual battery and lewd conduct with a child under 16 but accepted a plea agreement Tuesday for two counts of sexual battery. Prosecutors are set to recommend a prison sentence of three to 15 years for each count. Valdez's sentencing is set for March 1st.

A Twin Falls police officer used a Taser on Kirk Mullins, of Filer, after he allegedly failed to show his before that Mullins was of possession of a controlled substance with intent to deliver, felony counts of eluding and destruction of evidence and a misdemeanor count of resisting officers.

News Report January 11 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Sergio Maldonado, of Washington, allegedly flew to Texas, picked up nearly five pounds methamphetamine and was driving it to Seattle in a rental car when an Idaho State Police trooper discovered the drugs in Jerome County on December 11th. Maldonado is charged with one felony count of trafficking more than 400 grams of methamphetamine. A preliminary hearing, held last Wednesday, was ruled that there was enough evidence to the case over to district court.

News Report January 11 - Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Eugenio Caliz, of Jerome was arrested May 19th and arraigned the next day on one count lewd conduct with a child under 16. But that case was dismissed last Tuesday without prejudice leaving the prosecutor's office the option of re-filing the case. New charges were filed the same day. Caliz was arraigned Wednesday in Jerome County Magistrate court on the two new felony counts of lewd conduct with a minor under 16 and sexual abuse of a child under 16. The lewd conduct charge is punishable by up to life in prison, while the sexual abuse charge is punishable by up to 25 years in prison.

The Cassia County Sheriff's Office is searching for two suspects in an armed robbery at a Burley gas station early Sunday morning. Reports say two men, wearing bandanas, driving a red Dodge extended-cab pickup truck that appeared to be lifted and have fourwheel drive capabilities, and carrying a silver revolver and a medium sized red and white cooler fled with an undisclosed amount of cash from Bobcat Corner on West Main Street in Burley. If you have any information on the robbery you are asked to call the Cassia County Sheriff's Office.

all from Burley. Reports say the five were seen in several departments including the Jewelry, Electronics, Toys, Sporting Goods, and clothing departments. A total of 74-items were recovered with a value of \$844.56.

The Cassia County Sheriff's Office is asking the public to help identify two men who robbed Bobcat Corner convenience store Sunday in west Burley. They drove a Red Dodge extended cab truck, which was reported stolen, and later recovered in southwest Burley. The sheriff's office has released photos of the suspects taken from surveillance cameras at the store. Police ask the public not to confront the men if they're spotted but to instead immediately call 911 or contact the Cassia County Sheriff's Office.

Prosecutors also added a persistent violator charge to the case. This means that if Kincaid is convicted of any charges in the case, it is his third felony conviction and he would face up to life in prison.

Idaho State Police spotted the SUV matching the description of a vehicle reported stolen in Twin Falls County. An officer noticed the vehicle after it stopped and its driver walked away. After confirming it was the vehicle reported stolen, authorities set up a perimeter in the 3rd Ave. W and N. Cedar St. area of Jerome. Reports say that ISP hasn't accused or suspected the person of stealing the vehicle at this time, but the area search with the secured perimeter

is a standard operating procedure. Police were unable to find the man.

A Twin Falls County Sheriff's Office pursuit ended with a crash and two arrests near downtown Twin Falls Wednesday night. During the pursuit, the driver turned off the Jeep's headlights as it sped toward Shoshone Street. As the Jeep turned onto Shoshone, the driver lost control, swerved several times and rolled. Both the driver and passenger got out and ran. Lawrence Johnson and Kugar Parrott, both of Salt Lake were arrested. Reports say the Jeep was stolen from Midvale, Utah and was involved in a hit and run crash on Second Avenue East and Ketchum Street just before the police chase. Parrott is charged with felony eluding and theft by possession of stolen property. Johnson is charged with controlled substance and obstructing police.

Prosecutors have dropped the case against a Wendell man accused of leaving a crash that killed a 2-year-old boy in Jerome on Sep. 12, 2014. Reports say, Sergio Garcia, the toddler's father, said prosecutors told him Wednesday there wasn't enough evidence to continue with the case. Bernave Avila was charged with one felony count of leaving the scene of an accident resulting in injury or death. He was arraigned Aug. 31stalmost a year after the death of Damian Garcia. The case has been dismissed without prejudice, which means the prosecutor can refile charges at a later date.

Katie Pingree, one of four people charged with robbing Tigre Martinez hours before he found dead in his home has pleaded guilty to a robbery charge and agreed to cooperate in the prosecution of the other three people charged in the case. The plea deal is a rule 11 agreement, meaning District Judge Richard Bevan will be bound during sentencing by conditions of the deal. Pingree has agreed to serve three to five years in prison.

Detectives from the Mini-Cassia Drug Task Force arrested Melvin Smith, of WestValley,Utah and Lenny Dale Bruemmer, of Salt Lake City on charges of traffickingcocaine.Reports say police seized more than a pound of cocaine that detectives say wasbroughtfrom Utah and was to be distributed in Idaho. The men were arraigned Mondayeach on onecount of trafficking cocaine and bail was set at \$100,000.

News Report January 18 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Juan Arellano, a Paul man who is serving 22 years to life in prison for fatally shooting his wife in 2010 now says he might not have pleaded guilty to first-degree murder if he had better legal advice. Arellano was set to appear in Cassia County Court this month, but an evidence hearing has been moved to March 4th. Attorneys will now review the presentence investigation for use in Arellano's post-conviction case. If prosecutors win, his original sentence will stand. But a judge could order a trial on the issue of deficient counsel.

Prosecutors willsuggestGorham spend 3 ½ to 10 years in prison. Gorham also agreed to pay a fine — themaximumfor grand theft is \$10,000 — and pay restitution to his victims. His sentencing isscheduledfor Feb. 29th.

hearing is scheduled for Jan. 29th. He is scheduled for trial on April 6th for the October burglaries.

Police say a string of break-ins at Magic Valley churches and non-profits may be connected, and they're asking church leaders to be on the look-out for suspicious behavior. The Islamic Center of Twin Falls was vandalized with graffiti December 7th; the food pantry Safe Harbor was broken into and ransacked Christmas Eve and again December 26thor 27th; the Monastery of the Ascension in Jerome had cash stolen from the gift shop in December and a golden Tabernacle stolen in January; and LDS church buildings on Eastland Drive and Harrison Street in Twin Falls were both burglarized within about a week in early January. Both are currently being held in the Twin Falls County jail and are likely facing more serious gun and drug charges in Jerome County after deputies there found nearly three pounds of methamphetamine and two guns in a hotel room where the women stayed over the weekend.

Reports say that Jessica Mitchell and DeOrr Kunz Sr. have been "less than truthful."Bowerman says that he believes the parents know the location of DeOrr Kunz Jr. and whether he's dead or alive. At this time the couple has not been arrested and no warrants have been issued.

Police arrested one suspect and are searching for two others considered armed and dangerous in connection to a shooting in the desert southwest of Shoshone. Reports say the men are wanted in the shooting of a Hispanic man "left for dead" in the desert about 4 a.m. Saturday. The victim managed to call 911 from a cell phone about 9:30 a.m. The victim was taken to a hospital with multiple gunshot wounds and was in critical condition in the intensive care unit Monday morning. He is expected to survive. Authorities are withholding the victim's name and the name of the hospital because of threats made to him, his wife and his family.

News Report January 26 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Cassia County Prosecutors have charged a Burley couple after doctors say they broke a 5month-old baby's leg and wrist. Taylor Bruce and Juan Rebollozo, were both charged with felony injury to a child and aggravated battery causing great bodily harm. Each has a preliminary hearing set for January 29thin Cassia County Magistrate Court and is being held at the Mini-Cassia Criminal Justice center on a \$150,000 bond.

News Report January 27 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute A manhunt is underway for two men in a kidnapping and execution-style shooting in the desert southwest of Shoshone. Reports say David Gonzalez, is wanted for attempted murder and two kidnapping charges in the shooting. Gonzalez is about 5 feet 10 inches tall, 170 pounds with brown eyes and black hair. He's believed to be armed and dangerous. Erik Lopez, of Wendell, was arrested Sunday night and charged with three felony counts in connection to the shooting. The Lincoln County Sheriff's Office is pursuing a third suspect, believed to be a Hispanic man. Prosecutors say Gonzalez, Lopez and the unidentified man allegedly left Francisco Bravo to die in the desert after shooting him early Saturday morning.

News Report January 27 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Minidoka County Deputy Prosecutor Alan Goodman has resigned following a drunken driving charge issued the night of Monday, January 18th. According to reports, Goodman was pulled over in Rupert by an Idaho State Police trooper after failing to signal before turning. Goodman allegedly failed the sobriety tests and his blood-alcohol level was 0.17. Goodman will be arraigned the first part of next month. A special prosecutor will be appointed to the case in addition to a new judge because of the conflict of interest.

News Report January 27 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Twin Falls Police are seeking to return about \$10,000 in stolen items to their rightful owners after arresting Gerami Secord, of Twin Falls, for felony grand theft. While serving a search warrant for drugs and stolen construction equipment last week, Twin Falls officers say they found more than \$20,000 worth of stolen items in Secord's home. Haney was arraigned Thursday in Twin Falls County Magistrate Court on a felony count of robbery. Worring was arraigned on a felony count of aiding and abetting robbery.

News Report January 29 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Police have arrested Omar Trejo for grand theft, fraudulent use of a credit card and forgery. According to reports, Trejo went to the victim's house to ask about a job and allegedly stole two blank checks, \$120, and a credit card while the victim wasn't looking. Reports say Trejo spent about \$500 on the victim's credit card and attempted to cash a check for \$1200 at First Federal. The Senate Education Committee unanimously signed off on two bills Monday to create a new system to supervise and fund school broadband in Idaho. The first bill would create a grant fund to provide school districts with state money to cover up to 10 percent of what they need for broadband infrastructure projects. The second bill would create an eight-member "Education Opportunity Resource Committee," consisting of some state officials and local superintendents, to distribute broadband money and provide assistance to school districts. The bills now go to the full Senate.

No charges have been filed against owners Bernard and Roza Saul, but the FBI conducted a lengthy investigation stemming from a routine inspection at a Caldwell company. They say the Sauls repeatedly bought nonorganic seed and resold it as organic, which commands higher prices.

News Report February 24 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute Three resolutions to implement last year's deal between the Eastern Snake Plain Aquifer's surface- and groundwater users, and to commit the state to help fund recharge statewide, sailed through the House Resources Committee without opposition yesterday. All three will now go to the full House.

The bill's supporters pitched it as a way to ensure women have access to more information to help them decide whether to terminate a pregnancy. Idaho already has a 24-hour waiting period for abortions, and women must receive statedirected counseling including information on medical and potential emotional risks associated with abortion, and medical risks associated with carrying a baby to term. **News Report March 2 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute** On Monday The Idaho House passed a law stiffening penalties for animal cruelty charges involving pets. The latest bill mandates a psychological evaluation of an offender before sentencing. The bill makes torturing a companion animal a felony on a second offense, or on a first offense if the offender has been convicted of a violent crime against a person within the previous 10 years. The bill also protects all animals, including farm animals, from being killed, maimed, starved, beaten cruelly or otherwise abused. It now goes to the Senate.

Idaho is one step closer to joining a small group of states that require abortion providers to give women information on accessing ultrasound services. The Idaho House voted 56-13 yesterday to advance legislation that would require the state's Department of Health and Welfare to compile a list of providers that offer free ultrasounds for women seeking abortions. The list would be part of the informed consent brochures abortion providers are required to distribute.

The state Legislature's budget-writing committee approved funding for emergency mental health centers in Twin Falls and Boise. The move is an important first step to bring a center to the Magic Valley, where leaders say a crisis center is badly needed to relieve pressure on emergency rooms and reduce the number of mentally ill people who end up in jail. The centers provide a temporary place for people with mental health or drug problems to go for a day and be connected with longer-term services.

Another bill to get rid of the need for a concealed carry permit within city limits, this time with House GOP leadership support, was introduced yesterday. The bill would allow anybody to carry concealed within city limits who is older than 21 and not otherwise barred from owning a gun. The committee voted to print the bill, clearing the way for a hearing. A growing number of states are dissolving requirements for a concealed carry permit, and similar bills have been introduced in a few other statehouses this year. The idea is called "constitutional carry" by its supporters.
