This responds to a letter dated March 28, 2011, authored by Susan L. Kimmel, Deputy Chief, Disability Rights Office/Consumer & Governmental Affairs Bureau, transmitting to us a copy of a complaint filed by Ms. Donna Smith, 1920 Huntington Blvd., Lot 60D, Fort Scott, KS 66701. The complaint states that on "02/04/2010" ¹ at "20:00:00: PM" she first "lost all sound, then closed captioning went off. Sound came back on late that night but closed captioning never did." Ms. Smith stated that the television station she was watching was KOAM-TV via SuddenLink cable.²

Pursuant to Ms. Kimmel's directive, we wrote Ms. Smith to acknowledge receipt of the FCC's notice and her complaint. I asked Ms. Smith to call me at 417-624-0233 or email me at dthomas@koamtv.com to verify that 2010 is the correct year so we can thoroughly investigate your complaint. Ms. Smith verified that the date on which she lost closed captions was in 2011, not 2010. See the attached copy of her email dated April 5, 2011, in which she states that the closed captioning difficulty occurred in 2011. Ms Smith also states that she wrote the FCC and "told them you had taken care of it."

Based on the corrected date, we reviewed our Mass Logger for the date February 4, 2011. We checked random times between 7 pm and 11 pm with extra emphasis on the 8:00 pm hour and found KOAM-TV was transmitting both audio and closed captioning. We contacted SuddenLink and they acknowledged problems with their system in early February 2011. I was informed that SuddenLink found they had a modulator problem and replaced the modulator during the second week of February.

Later found to be 2011, not 2010.
