Cook County officials agreed with a collection of local property owners that a stringent environmental review process needs to take place before a gravel pit and asphalt plant can be built near a protected trout stream.

A federal inspection this year of the Birchwood Apartments in Grand Marais found “substantial water damage to ceilings, walls, flooring, and personal property” in more than one-third of the units at the local housing complex.

In a letter dated Jan. 26 from the United States Department of Agriculture (USDA) that was sent to Birchwood owner Lilean Sedlacek, officials from the federal agency share both a list of concerns and expectations to address the deficiencies at Birchwood. The inspection report was obtained by WTIP through a request under the Freedom of Information Act. The inspection by USDA staff took place Jan. 24.

Efforts to reduce wildfire fuel while simultaneously sequestering carbon are underway in the Superior National Forest.

Researchers at the Natural Resources Research Institute (NRRI) recently conducted a demonstration project to convert balsam fir into a soil-enhancing, carbon-sequestering material called biochar.

Biochar is produced by heating biomass material in a low or no-oxygen environment. “You’re not combusting material. You’re paralyzing it,” said Brian Barry, the chemist and project lead for the NRRI demonstration project.

Cook County officials could spend nearly \$30 million over the next several years updating buildings and other property it owns. Before they decide how much to spend, county officials want to hear from the public on any decisions regarding the proposal.

Over the next five years, the county anticipates spending between \$13.4 million and \$30 million to upgrade building systems that are nearing or have exceeded their expected lifetimes, according to Commissioner Stacey Hawkins. If approved, the county would essentially take out loans, most often referred to as bonds in county documents, to pay for the facility upgrades and changes, she said. These loans, Hawkins said during a recent interview with WTIP, would be paid back using local taxpayer dollars.

The extent of those changes will depend heavily on the county receiving a federal grant of \$25 million. The city council meeting on Feb. 8 included a variety of agenda items, including a variance request, the North House Folk School annual update, and a discussion regarding the 5th Avenue project.

During the open forum, Anna Hamilton of Hamilton Habitats, a non-profit organization providing affordable housing, spoke about her frustration with infrastructure costs.

Hamilton said the Pebble Hill project, on the corner of the Gunflint Trail and County Road 7, cost \$53,000 to connect to city sewer and water. She is currently working on developing property west of the Homestead Cooperative, and the estimated cost to access and connect to city sewer and water for the two lots is \$80,000.

The plan was released towards the end of December 2022 and will guide wolf management in Minnesota for the next ten years.

The updated wolf management plan provides a historical look at wolves in Minnesota and includes guidance on wolf population monitoring, population management, depredation control, public safety, and more. The plan also sets out a framework for future decisions regarding a wolf hunting or trapping season should the wolf be removed from the federal Endangered Species Act (ESA).

Sustained 60 mph winds lasted nearly 48 hours in areas of Cook County. During the intense storm, the Grand Marais harbor recorded wind gusts at 74 miles an hour. Twiest said, “Which is, in my mind, just nuts.”

Twiest said Arrowhead Cooperative received the first call of a power outage near Colvill and up to the Canadian border on Friday, Dec. 23, at 8 a.m.
