Host provided more details about the overpass damage and asked if the trucker’s insurance would cover the cost and why didn’t the driver have a lead car with a high stick. Driver should have had a special height permit which makes it his fault.

Description: Discussion began on the cost of a replacement bridge for the Chamber Way overpass, and will it really cost \$70 million and not start for 7-years? Host believes listeners should start a phone calling campaign to put pressure on DOT to do the job sooner.

Description: Caller brought out that the governor of the state is in charge of the DOT so pressure would need to be put on him to get the Chamber Way overpass project going sooner.
