KQDY provides its listeners with programming and public service announcements that address issues of concern to our local community. Among the issues determined to be of most concern to the community during the preceding calendar quarter were:

- **ADDICTION:** Drug & Alcohol Use: The Effects at Work, Home & On the Roads.
- **AGRICULTURE:** Chief Economist and Acting Deputy Under Secretary for Farm Production and Conservation at the United States Department of Agriculture.
- **CHAMBER SUMMIT:** President and CEO of the Greater North Dakota Chamber to discuss the upcoming North Dakota Chamber Policy Summit
- **DAPL REBUILDING:** Major General Alan Dohrmann, Adjutant General of the North Dakota National Guard and Director of the North Dakota Department of Emergency Services
- **FLOOD RELIEF:** The worst natural disaster in US history. The devastation and flooding in the Texas region from Hurricane Harvey.
