KQDY provides its listeners with programming and public service announcements that address issues of concern to our local community. Among the issues determined to be of most concern to the community during the preceding calendar quarter were:

- **BLUE-GREEN ALGAE:** N.D. GAME & FISH FISHERIES CHIEF, ABOUT THE TOXIC/LETHAL EFFECTS OF BLUE-GREEN ALGAE PRESENT IN CERTAIN LAKES AND WATERS.
- **DAKOTA ACCESS PIPELINE:** PUBLIC SERVICE COMMISSION'S REVIEW OF WHAT LED TO GRANTING THE PERMIT TO BUILD DAPL.
- **DAPL:** DAKOTA ACCESS PIPELINE PROTESTS, LAW ENFORCEMENT REACTION.
- **EDUCATION:** STATE SUPERINTENDENT OF PUBLIC INSTRUCTION, ABOUT AN EDUCATION REFORM FILM, "MOST LIKELY TO SUCCEED," SCREENING ACROSS N.D., ABOUT HOW THE NATION'S EDUCATION SYSTEM SHOULD BE REFORMED.
- **FILL THE BUS:** FILL THE BUS EVENT TO COLLECT SCHOOL SUPPLIES FOR NEEDS STUDENTS. NUMBERS SUPPORTED, THEIR PARTICIPATION IN OTHER PROGRAMS SUCH AS SCHOOL LUNCHESES, ETC.
- **HEMP:** ONE OF FIVE FARMERS IN N.D. WITH PERMISSION TO GROW A HEMP CROP, IN AN EXPERIMENTAL PROGRAM.
- **LABOR:** LABOR ISSUES, IN OBSERVANCE OF LABOR DAY.
- **MEDICAL MARIJUANA INITIATIVE:** CHAIRMAN OF THE N.D. MEDICAL MARIJUANA INITIATIVE, ABOUT IT, AND THE STATE HEALTH DEPARTMENT'S COST ESTIMATES TO IMPLEMENT.
- **MULTICULTURAL EDUCATION:** AN AMERICAN INDIAN EDUCATIONAL SUMMIT COMING UP AT THE STATE CAPITOL.
- **NATIVE AMERICANS AND OIL:** MHA NATION TRIBAL COUNCILMAN ON THE DAKOTA ACCESS PIPELINE PROTESTS, AND OTHER OIL SOURCES NEAR TRIBAL LAND.
- **SPECIAL SESSION:** N.D. LEGISLATURE CALLED A SPECIAL LEGISLATIVE SESSION TO DEAL WITH BUDGET SHORTFALL, AND THE NEED FOR CUTS.
- **UAV/DRONES:** DEVELOPING TECHNOLOGY AND CORRESPONDING LAW WITH RESPECT TO REMOTE-FLOWN AIRCRAFT.
