## CHIEF OPERATOR DESIGNATION INCLUDING DELEGATION OF AUTHORITY

This Chief Operator Designation Including Delegation of Authority ("Designation and Delegation") is entered into between Evangel World Prayer Center, Inc. dba WJDE ("Licensee"), Mr. Tom Fawbush ("Chief Operator") and Mr Clinton Hooper ("Designee"), for the purpose of designating Mr. Hooper as responsible for assisting the Chief Operator in his duties with respect to WBNA-TV, Louisville, Kentucky (Facility ID No. 61026) ("the Station"), effective February 1<sup>st</sup>, 2013:

1. The Chief Operator will be ultimately responsible for all duties required of the Chief Operator of the station under the Communications Act of 1934, as amended ("the Act") and the rules, regulations and policies ("the Rules") of the Federal Communications Commission ("FCC" or "Commission"). The Chief Operator, will be on duty for whatever number of hours each week are necessary to keep the Station's technical operations in compliance with the FCC authorization and otherwise to meet the obligations of a Chief Operator as defined by the Act and Rules.

2. Designee, under the supervision of the Chief Operator, will be on duty for whatever number of hours each week are necessary to assist the Chief Operator in keeping the Station's technical operations in compliance with the FCC authorization. Designee will not order, purchase or charge anything to or for the Station without the express authority of the Chief Operator.

3. In the event Designee is unavailable or unable to act, the Chief Operator will designate another qualified individual as the Acting Designee on a temporary basis.
