These should be coded as LOCAL DIRECT POLITICAL ISSUE spots, 5x/day 30s spots ON EVERY CUMULUS STATION, Mon-Sun (not auto-weekly) 5a-Midnight full rotation, fully pre-emptible without notice P90, starting this Wednesday March 30 and running through September 6. It is a no-charge order.

This order WILL NOT impact your LUR given the broad rotation; also the FCC confirmed that this issue order on behalf of the industry should not be considered in setting your LUR for other political orders.
