**III. RECRUITMENT INITIATIVES**

	<b>Type of Recruitment Initiative (Menu Selection)</b>	Brief Description of Activity
1	Internships program at corporate office	SEU continued its internship program for high school and college students to allow them to learn about various broadcasting jobs and to gain work experience necessary in the real world. 1 college student interned in the production studio throughout the late fall on 2022 , applying her knowledge in real life situation for radio editing, sound mastering, etc.
2	Provided Training to employee participant to gain experience for future advancement.	SEU continued to provide training to the production studio employee which resulted in him hosting his own program segment since spring of 2023. SEU Station Chief Engineer along with Station Program Director trained a contracted worker in the daily technical procedures (readings and check points for the proper station operation). The individual was promoted to employee status last quarter of 2022 and is Chief operator at location.
3	Participate and sponsor (media sponsor) Community Event	This SEU played a role as media sponsor for the following events: Taste of Polonia (September 2 – 5, 2022) hosted by the Copernicus Foundation, Polonia Cup (May 19) organized by the Polish American Chamber of Commerce and The Copernicus Foundation, The Holy Trinity Polish Mission (June 4) for their “Annual Family Fest”, The Gift from the Heart Foundation Annual “Cruise for Charity” (June 25), The Polish Highlanders Alliance of North America’s Annual “Grand Fest” (July 9). Station Manager, Newsroom Director and On-Air Host were on hand to provide media training prior to on-air real-time interviews with organization leaders and event participants. Station personnel connected with students of Polish descent & other persons present at these events to talk about various jobs in broadcasting, the internship program and handed out applications to interested individuals.
4	Mentorship program with the Polish American Chamber of Commerce	SEU continues to work with the organization on participating in the mentorship program to offer mentorship for broadcast industry students of Polish decent, however the program is not operational yet and cannot admit any participants.

5	Self-reliance Association Job Fair	Station Manager participated in a job fair organized by the Ukrainian American SelfReliance Association on April 27
