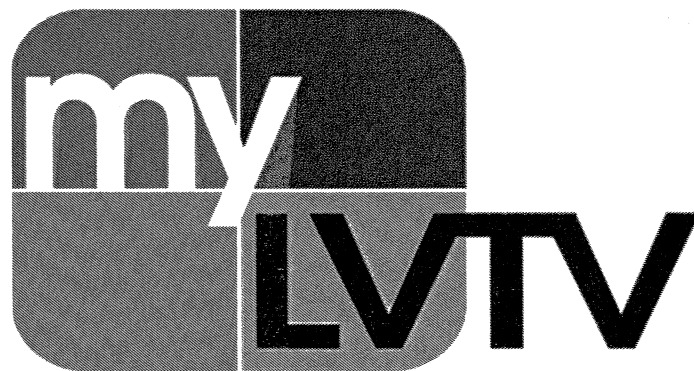

Fill out the Market, Call Letters and Broadcast week

Each program should have its own row.

Each day should have a line below, even if filled with "No KIDS 0-12 Program Scheduled" in the Program Title Column

Two signatures are required for each row "No KIDS 0-12 Program Scheduled".

Signature is confirming none are scheduled

Two signatures are required for each row with a KIDS 0-12.

Signature is confirming that the log is within commercial time limitations

KIDS 0-12

Commercial Time Limitations Apply

Monday through Friday there is a limit of 12 minutes per clock hour

Saturday and Sunday there is a limit of 10 and one half minutes per clock hour

No Host Selling Permitted

EXCEPTION: Net/Barter time can be filled in with a * for CBS and THIS Stations. No local time available

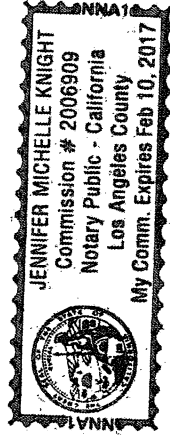
