Flint (WBSF-TV) Licensee, Inc.'s Response to February 14, 2019 EEO Audit Letter

Flint (WBSF-TV) Licensee, Inc. ("Licensee"), licensee of broadcast television station WBSF(TV), Bay City, MI (Facility ID 82627) (the "Station"), hereby responds to the letter from Lewis Pulley, Assistant Chief of the Federal Communications Commission's Policy Division, Media Bureau, dated February 14, 2019.

Licensee hereby advises the Commission that the Station's employment unit employs fewer than five full-time employees. A list of the Licensee's full-time employees at the Station (identified by job title) and the number of hours each is regularly assigned to work per week, is attached hereto as Exhibit A.

The Audit Letter's Question 3(e) asks Licensee to

Disclose any pending or resolved complaints involving the Station filed during the Station's current license term before anybody having competent jurisdiction under federal, state, territorial or local law, alleging unlawful discrimination in the employment practices of the Unit on the basis of race, color, religion, national origin, or sex. For each such complaint, provide: (1) a brief description of the allegations and issues involved; (2) the names of the complainant and other persons involved; (3) the date the complaint was filed; (4) the court or agency before which it is pending or by which it was resolved; (5) the file or case number; and (6) the disposition and date thereof or current status. Note that all complaints must be reported, regardless of their status or disposition.

In response to Question 3(e), Licensee hereby certifies that it has not received any discrimination-related complaints during the Station's current license term.
