I have what I hope is good news. Americas Pac has finally secured funding to renew its strong program of non-candidate political-issue advertising in Montana in support of U.S. Senatorial candidate Matthew Rosendale (R: MT). Our ads mention Mr. Rosendale but carry no endorsement by any candidate, candidate's representative or organization created to elect a candidate. As an IEO (Independent Expenditures Organization), Americas Pac is allowed to place this type of advertising.

I have attached proposals for both of your stations that recently ran our ads in the Shelby market. If you find the terms offered satisfactory, sign and date at the bottom of each run sheet and e-mail it back to me to signal your acceptance of the terms.

For clarity's sake, let me reproduce the general content of the schedules here in the text of the e-mail. On both stations, the advertising run is flighted to start on Wednesday, July 4, 2018 and conclude on Tuesday, September 4, 2018. On stations KSEN-AM 1150 and KZIN-FM 96.7, the schedule consists of 4 spots in each drivetime daypart on weekdays (Mon-Fri). On both stations, 8 spots per weekday is equivalent to 40 spots per (full) week. The schedules contain a partial week on both ends of the run and 8 full weeks in the middle of the run. The partial weeks together comprise one full week, so this adds to 9 weeks at 40 spots per full week, for a total of 360 spots on each station. The proposed total net allocation on station KSEN-AM 1150 is \$14,760.00. The proposed total net allocation on station KZIN-FM 96.7 is \$14,760.00. The proposed aggregate total net allocation to Townsquare Media Billings from these Shelby stations is \$29,520.00.

I must draw your attention to an oddity whereby almost all the weekly spot totals run vertically rather than horizontally on the run sheets. I apologize abjectly for this annoyance. I represent Americas Pac directly; thus, no advertising commission intrudes in the calculations above and the monetary amounts reflect the net allocation due to the station or broadcast group.
