## NOTICE TO ASSIGNEE/TRANSFEREE:

Enclosed is the FCC Form 732 notifying you of Commission consent to assignment/transfer of control of the construction permit and/or license of the station(s) described therein.

Consummation. A voluntary assignment/transfer of control must be consummated within ninety (90) days of the date of the Commission grant of consent. Upon consummation, the assignee/transferee should immediately file a consummation notice as to the exact date of consummation (i.e., the date on which the acts necessary to effectuate the assignment /transfer of control were completed). The consummation notice should be filed electronically in CDBS or by mail to the FCC Office of Secretary, 445 12<sup>th</sup> Street, SW, Washington, DC 20554. It is important that the consummation notice include the station's official address so that all Commission correspondence comes to the immediate attention of the licensee. Only one mailing address may be maintained for each station.

Extension of time to consummate. Extensions for up to an additional ninety (90) days to consummate are routinely granted. Subsequent extension requests must be accompanied by a good cause showing and certification that all representations contained in the original application remain true and accurate. All requests for extension should be filed electronically in CDBS or by mail to the FCC Office of Secretary at the address listed above.

Electronically-filed consummation notifications and requests for extension of time to consummate must be submitted through the Media Bureau's CDBS online electronic forms system. For more information regarding these electronic filings, refer to the February 28, 2006, Public Notice, DA 06-472, Media Bureau Announces New Features in CDBS.

Ownership Report. Within thirty (30) days after consummation of the transaction, the new permittee or licensee of the AM, FM, or TV Broadcast station must submit an Ownership Report (FCC Form 323 for commercial entities; FCC Form 323-E for noncommercial entities) reporting all changes as required by 47 C.F.R. §73.3615. A post-consummation Ownership Report is not required if the authorized assignment or transfer of control only involved an LPFM radio station or an FM Translator radio station. If the assignment/transfer of control was involuntary, as a result of a death or court action, an Ownership Report must be filed to demonstrate that all Commission rule requirements have been met and reported. Electronic filing via CDBS is required for all Form 323 and Form 323-E filings. Detailed instructions for accessing, completing, and submitting the Form 323 and Form 323-E are available in CDBS.
