Felon fires shots during police pursuit:

On Tuesday, February 23, 2021, a Deemer resident called the Sheriff's Office and reported that his vehicle was stolen. The caller stated that James Michael Franklin had stolen his blue Nissan Versa. The caller described the car thief as dangerous and said he was armed with a stolen .9mm pistol.
