Dear Affiliate:

In response to your recent request, this is to certify that HSNi, LLC (“Network”), during the calendar quarter ending March 31, 2024:

- 1) provided closed captioning services on its HSN and HSN2 programming services in compliance with the applicable closed captioning regulations of the Federal Communications Commission (“FCC”).
- 2) had no programs originally produced or broadcast primarily for an audience of children 12 years old and under.
