BEASLEY SAID ON THE CLINTON FIRE DEPT YOU NEED TO BE AT LEAST 21 YEARS OLD, YOU NEED TO HAVE A DESIRE, WOULD BE ON A PROBATION FOR A YEAR, FIRE EQUIPMENT IS VERY EXPENSE TOO.</p> <p>MR.
