In accordance with the requirements of Section 76.64 (k) of Title 47 of the Code of Federal Regulations (CFR), this letter is provided as notice of the intention of Skitter Cable TV, a wholly owned subsidiary of Skitter, Inc., to commence cable television service as a “cable system” as defined in 37 U.S.C. §201.17 and 47 U.S.C. §522(7) within the **Lexington, KY** DMA and desires to include station **WKHA** Primary and Secondary (Multicast) Signals in its channel offering.

The location of the Skitter Cable TV, LLC head end is **20 Laynesville Road, Harold, KY 41635**.


