1/6/15	Constitution al Electoral college System Under Attack	Jim Schneider / Trent England	Trent England serves as Vice President for Strategic Initiatives at the Oklahoma Council of Public Affairs and directs the Center for the Constitution & Freedom. Trent is National Coordinator for Liberty Foundation of America and an adjunct fellow of the Freedom Foundation and has directed the foundation's 'Save Our States' project. He is a contributor to two books,'The Heritage Guide to the Constitution' and 'One Nation Under Arrest: How Crazy Laws, Rogue Prosecutors and Activist Judges Threaten Your Liberty.'
			How does the electoral college system work? As Trent described it, near the beginning of Article 2 Section 1 of the Constitution it tells us how the president is to be elected. It's to be state-by-state. The political power is distributed exactly the same as it is in Congress. The smallest states get 3 electoral votes based upon their two members of the U.S. Senate and their single member of the House. On the other end of the scale you have a large state like New York that has 2 Senators and 27 House members for a total of 29 electoral votes. Each state is then given the power to decide how to represent itself with those votes and according to Trent, this is what the popular vote/electoral college controversy is all about.
			The state holds an election between the candidates for president and whoever gets the most votes in that state gets all the electoral votes from that state. Thomas Jefferson came up with that idea because it maximized the political impact of Virginia in his day.
			There are two exceptions. In Nebraska and Maine they break up

			their electoral votes. They do the same with two of their electoral votes but they apportion out the electoral votes that represent each congressional district. This means that in 2012, President Obama won a single electoral vote from Nebraska. The main point to remember is that under the electoral college system, each state gets to represent itself. Trent believes that the national popular vote is an attempt to trick states into giving away their electoral votes based upon the nationwide outcome.
			Would a national popular vote affect the Constitution? Does the concept of a national popular vote bring more power to the people in terms of the democratic strength of their votes as we might be led to believe or is it actually just the opposite? Who are the movers and shakers in the national popular vote movement? These are just a few questions that are answered on this vital edition of Crosstalk.

	Leadership		Yesterday, the new Congress reappointed John Boehner as the Speaker of the House. He obtained 216 votes. If you're thinking that when you divide 435 House members by 2 you don't get 216. That's a good observation but as Genevieve noted, he only needed a majority of the votes that were cast. So of the 408 votes that were cast, he received 216.
			Interestingly, 24 members of his own party voted for someone else and 'present' was voted by one other member. About 29 would have been needed to force the vote to a second ballot. Forcing a second ballot could have caused Republican leadership to say that they'd agree to the demands of some congressional conservatives in return for the necessary votes to reappoint Boehner.
			This particular vote should not be overlooked because as Genevieve pointed out, Boehner had more people from his own party choosing not to vote for him than any current speaker running for reelection in over 100 years.
			Could it be that conservatives in Congress know or at least sense that John Boehner (and Mitch McConnell in the Senate) aren't ready or willing to fight hard for the issues that swept Republicans in during the last election? After all, it doesn't appear that Republicans made the gains they did because the public wants Boehner to simply tinker with Obamacare or drag his feet on the issue of executive amnesty.
			In response, Boehner is said to be retaliating against conservatives by removing some who didn't vote for him from key committees. Vic had Genevieve comment on that issue along with getting her perspective on Representative Steve King (who said he couldn't honor his oath to support the Constitution and vote for Mr. Boehner), the power of the House to shut down Obamacare, the initiatives she feels the House and the Senate will be taking up early in this term and more.
1/8/15	State Forces Teen to Undergo Chemo Treatment	Vic Eliason	Vic began this edition of Crosstalk by presenting listeners with details regarding chemotherapy and his own experiences with it. He described it as a poison that destroys fast growing cells such as cancer. The problem is that this also destroys cells that are good for the human body such as blood cells. Side effects include but are not limited to the numbing of toes and finger tips along

			with the loss of hair.
			With that background in place, Vic went on to present details from Fox News regarding a 17 year old named Casandra who was diagnosed with Hodgkin's Lymphoma in September of last year. The recommended treatment for her disease includes chemotherapy but she decided she didn't want to undergo that process and her mother supported her in the decision. Last November a trial court granted a petition of the Department
			of Children and Families for an order to have temporary custody of Casandra and direct her mother to provide and cooperate with medical care under DCF's supervision as recommended by attending doctors.
			Casandra and her mother began complying with the order as Casandra received her first two treatments in November. Then she ran away from home to avoid further treatments.
			Upon returning she refused treatment. At a hearing where Casandra's doctors testified, the trial court ordered that she be removed from her parents home and remain under DCF custody and also authorized the DCF to make all necessary medical decisions for her.
			In an appeal, Casandra and her mother claimed that unless it can be found that they are incompetent, the trial court violated their constitutional rights in allowing the DCF to substitute its judgment for theirs and permitting DCF to force Casandra to receive medical treatment against her will.
			They also noted that the state should recognize the mature minor doctrine. This requires that before the court can force a 17 year old to receive medical treatment against their will, it must first determine that the minor isn't sufficiently mature to be legally allowed to make their own medical decisions.
			The Connecticut Supreme Court upheld a prior ruling that Casandra cannot refuse chemo treatments. The state argued that Casandra lacked competency which extended to maturity and that they did not believe she understood the severity of her situation.
			Should the court be allowed to override the decision of a 17 year old girl who is about to turn 18, especially over the authority of her parents? Many listeners stepped up to participate in this critical Crosstalk discussion.

1/12/1 5	Fire Chief Fired for His Faith	Jim Schneider	In September of 2013, the Oregon bake shop known as 'Sweet Cakes by Melissa' was closed after the owner refused to bake a cake for a lesbian wedding. She has faced having to pay a \$150,000 fine for violating Oregon's anti-discrimination law.
			Last week a judge ruled that the state of Washington has the authority to bring a consumer protection lawsuit against a florist who refused to provide flowers for a homosexual wedding. The shop could be held liable for violating the Consumer Protection Act. The business owner is being sued and the state attorney general is asking for a permanent injunction against the owner and her shop to comply with the law.
			These are just two examples of growing persecution, attacks on free speech and bigotry against people who were merely trying to run their businesses or execute their employment while following the tenets of their Christian faith.
			This edition of Crosstalk focuses primarily on the details surrounding the removal of Atlanta Fire Chief Kevin Cochran. Cochran was terminated from his duties following a city investigation. The complaint by Mayor Kasim Reed deals with a pro-family book that Cochran authored for his men's Bible study that upholds the biblical view of sexuality and contradicts the homosexual agenda.

			2 Boston officers kicked, punched and choked by 6 teenagers while they were making an arrest.
			On December 28th, Fox News reported that a Los Angeles police department patrol car was fired on in an unprovoked

attack that also put police officers around that city on tactical alert. --On New Years Day 2 West Virginia police officers were injured in a shootout after a traffic stop involving a stolen SUV and a truck with 2 dead bodies inside. CNSNews.com reported that the officers were conducting the stop when the driver of the truck shot at them with a handgun wounding both officers. --Fox News ran a year-end story reporting that gun deaths of officers jumped 56% n 2014 and included 15 ambush assaults. Overall, officers killed in the line of duty in 2014 saw a 24% jump from the previous year. Are we headed toward mob rule and anarchy? What about those men and women who place their lives on the line everyday to maintain the safety of the public? Joining Jim to look into these questions was Jim Kouri. Kouri writes the Law Enforcement Examiner. He is the 5th Vice President and Public Information Officer of the National Association of Chiefs of Police and has served on the National Drug Task Force. He has trained police and security officers around the country. Kouri began by reflecting on the killing of officers Wenjian Liu and Rafael Ramos calling it one of the most tragic shootings in the history of New York City. He took exception to some of the coverage based upon what he feels was political correctness. He indicated that Ismaaivl Brinsley was a black male who traveled from Baltimore to New York specifically to kill law enforcement officers. In addition, he was Muslim born and raised. He had a Facebook page where instead of his last name he had the name 'Mohammed'. It also showed that he was very extreme regarding his Islamic ideology and his desire to wage jihad against the United States. Kouri sees a connection between Islam and the uprisings around the nation. It's shown in the contrast between certain factors in place before Bill de Blasio became mayor and after. Before his tenure a program was put in place after 9-11 where the NYPD monitored certain individuals and mosques. There was a special investigative unit, certain individuals were kept under surveillance and complaints were noted from citizens regarding possible suspected terror related activities. The Council on American-Islamic Relations (CAIR) and other Islamic groups put pressure on Mayor de Blasio and the city did away with the entire program. Kouri continued by presenting his view on racial profiling, how he feels about officers literally turning their backs on Mayor de Blasio, his perspective on illegal aliens who are jumping on the anti-police bandwagon and more. 1/14/1 Jim Religious Emily Fuentes is the director of communications at Open Doors Persecution Schneider / 5 USA, an organization that began its efforts in 1955. Today they are in more than 60 nations around the world bringing the voices **Escalates Emily** of the religiously persecuted to the attention of Americans. **Fuentes** After describing the factors that cause nations to be placed on their World Watch List, Emily followed up by stating that she feels 2014 was an unprecedented year for persecution worldwide, even more than any time in recent history. Some of the persecution stories that made the news included: --ISIS specifically targeting and killing Christians in Iraq and

			Syria.
			Thousands of Christians killed in Nigeria by the Islamic group known as Boko Haram.
			Kim Jong Un stepping up his deliberate attacks and executions of Christians in North Korea, the nation that is #1 on the World Watch List and that is estimated to be holding at least 50,000 Christians.
			The story of Meriam Ibrahim in Sudan.
			Those stories Emily noted that didn't make the news included:
			The rise of persecution in central Asia as shown by near daily house raids against Christians.
			Relatively peaceful African nations in the past rising up the World Watch List.
			For 40 out of 50 of the countries on the World Watch List, Islamic extremism was the driving force.
			Other points worth noting from the program include:
			Number 2 on the list is Somalia where the terrorist group known as Al Shabab still has control over much of the nation.
			The rise of persecution in the nations of Djibouti, Tanzania, India and Sub-Sahara Africa.
			The decline of Sri Lanka, the United Arab Emirates and Kuwait on the World Watch List. Emily pointed out that while there may have been slight improvements in these nations, the drops are due to the fact that persecution has become that much worse in other nations.
			Mexico comes in at #38 with most of the persecution coming from the drug cartels who see Christians as a threat to their business.
			The discussion continued with mention of Turkey, Azerbaijan, China and what you can do to help the persecuted church around the globe.

He is the author of the book: 'Bearing Arms: Our Rights, Our Duties & Our Freedoms.' He has also authored a civil government textbook: 'The Constitutional Recipe for Freedom: Twelve Principles of Liberty Today's Politicians Don't Want You to Know.'
			This edition of Crosstalk covered many aspects of gun ownership, especially as it pertains to registration and confiscation. Below are just some of the related issues that Vic and Erich look at:
			Operation Choke Point. Erich noted that this is another example of President Obama using his phone and pen to try and implement his agenda without legislation from Congress. The operation puts the squeeze on banks and credit lending agencies, telling them that they can't lend or process credit card transactions for anyone in the gun industry.
			A planned attack on the U.S. Capitol by an ISIS sympathizer was recently stopped. Incidents like this are a concern for Erich

			on one level because of gun-free zones that are in place around America. He indicated that if you go back to the 1950's, all but 2 of the public mass shootings in our nation have occurred in gun free zones where people can't defend themselves.
			Have you ever heard someone claim that Jesus would never allow the use of weaponry? Erich presents an interesting answer straight from Scripture.
			The FBI has reported that gun sales skyrocketed in December with 2.3 million background checks being conducted. Erich believes this may be due to concern over riots and high crime. At the same time, for the last 6 years, President Obama's attacks on the 2nd amendment have been driving people to go to the gun stores to buy firearms because people may be thinking they better get one now before they lose the chance in the future.
			A Navy retiree had his guns confiscated after being treated for insomnia. He was mistakenly diagnosed as mentally unstable.
			An Alabama middle school principal sent a letter home to parents to have kids bring an 8 ounce canned good to contribute to the school arsenal. If an intruder would visit the school, children could thwart the intruder by throwing the cans at him.
			An anti-gun public service announcement encourages kids to break the law by stealing their parent's guns and turning them in to teachers.
			The Virginia Governor has proposed some new regulations impacting gun shows and others pertaining to concealed carry permits.
			The VA is offering free gun locks for former military members but wants key personal information as well. Is this gun registry in disguise?
			Some cities in Pennsylvania are openly defying state law that forbids municipalities from regulating firearms.
			In December the Senate confirmed Dr. Vivek Murthy as the new surgeon general. He supports gun control and considers gun violence a public health issue. Will his office become a platform for gun control?
			In Missouri there's a proposal to fund body cameras for police officers by putting a tax on handgun and ammunition purchases.

			The broadcast began with Paul discussing how the gospel has been reduced to a number of simple questions which include: Do you know you are a sinner? Would you like to go to heaven? Would you like to pray and ask Jesus Christ to come into your heart? If the respondent prays that prayer, we then ask if he/she was sincere. If the respondent says 'yes' to these questions, we declare the individual to be born-again. Paul pointed out how this is not the gospel of Jesus Christ 'and that methodology and evangelism has done more to hurt this country than every heresy introduced by every cult combined.
			This is just the beginning as Paul expounds on other aspects of the true gospel. For example, there's the importance of the need for preaching on sin so that people see the contrast of where they stand eternally in the light of God's perfection. From there he moves on to explain the concepts of justification, grace and propitiation.

She and her family have a ministry called Tomorrow's Forefathers, with the goal of equipping families to be grounded in the Word and fruitful for Christ's kingdom. She, along with her older siblings coauthored, 'Making Brothers and Sisters Best Friends'. She also enjoys arranging witnessing and outreach events in her community and speaks at family conferences. Her latest book is, 'Will Our Generation Speak? A Call to be Bold with the Gospel'.
			Grace began by noting how the Bible says all of us are responsible for communicating the gospel so no one can say we don't have the gift to share God's Word. Nonetheless, many Christians have concerns about their part in this process. For example, someone might say'I just can't do it.' Or maybe your response might be, 'I don't have the right personality for this.' Gospel sharing is not dependent upon personality but obedience. In fact, as Grace noted, sometimes a quiet person is actually a very effective witness for the gospel because such individuals tend to listen, and are calm and natural with people.
			Maybe you've always felt that you have to develop a friendship with each person first. This is not necessary because if you had to develop a friendship first, that would limit the number of people you can reach.
			As the program continued, Grace described the concept of 'listen but lead,' how to overcome fear, leaving a 'stone in the shoe,' handling people who are less than friendly, how to stay encouraged and much more.

Calvin Beisner is the founder and national spokesman of the Cornwall Alliance for the Stewardship of Creation. He is an interdisciplinary scholar specializing on the application of biblical worldview, theology and ethics to economics, environmental stewardship, political philosophy, public policy and apologetics. Dr. Beisner has testified as an expert witness on the theology, ethics, science and economics of climate change policy before the U.S. Senate Environment and Public Works Committee and the Energy and Environment Subcommittee of the U.S. House of Representatives Committee on Energy and Commerce.
			This broadcast began with Jim mentioning how the U.N. is

			showing scary videos about climate change disasters that could happen in 2050. Dr. Beisner noted that what's so ironic about this is that if they're showing the videos now, the disasters they're predicting have to be already happening which means they're not the result of any climate change that happens between now and 2050.
			Dr. Beisner informed listeners that there has been no increase in the observed frequency or intensity of any kind of severe weather events over the period of alleged, man-made global warming. In fact, as far as hurricanes are concerned, the U.S. is in the longest period on record since the last landfall of a category 3 or higher hurricane in the Atlantic basin.
			One of the highlights of the program was an audio clip from Secretary of State John Kerry who recently claimed that confronting climate change is a responsibility laid down in Scripture and that the U.S., along with Muslim nations, share a stewardship perspective as it pertains to the earth.
			Dr. Beisner pointed out that Muslim countries have environmental disasters taking place far worse than anything we have going on in the Western world. This is due to the fact that Islamic societies do not generate governments that respect private property, personal liberties and that are responsive to democratic forces.
			In its own materials regarding attempts to cut power plant carbon dioxide emissions by 30% by 2030, the EPA acknowledges that this would only reduce global average temperatures by two-hundredths of a degree Celsius. This effort would come at a cost of about 50 billion dollars per year while reducing total employment in the U.S. by about 250,000. In addition the reduction in carbon dioxide would reduce the earth's crop yields, an effect that would be very harmful to the poor.
			Dr. Beisner also provided background to the latest Cornwall Alliance declaration for the protection of the poor, John Kerry's flawed science regarding greenhouse gasses, how current global warming philosophies lead to rising energy prices, his call to action for all Christians and much more.

This means that just telling our youngsters to 'turn it down' won't cut it. Parents need to know what their children are listening to and why. If what they're listening to doesn't reflect a biblical worldview, it will produce another result. Remember that ideas, even when communicated via music, have consequences. What consequences do you want your children to face?

	Vic gave a number of examples demonstrating the power of music and how it can motivate people to do various things and live in certain ways. Usama opened by noting how jihadi Muslims in America are trying to do everything they can to force the barbaric laws of Sharia on Americans. He is the founder and president of Shiloh Israel Children's Fund dedicated to healing the trauma of children who have been victims of terrorist attacks as well as rebuilding the biblical heartland of Israel. He is author of the following books: Peace for Peace: Israel in the New Middle East, The Islamic Tsunami: Israel and America in the Age of Obama and his latest, Sparks from Zion.
			There currently exists considerable controversy regarding Israeli Prime Minister Benjamin Netanyahu's scheduled visit to the U.S. where he has been invited by congressional leaders to address a joint session of Congress. He is being snubbed by the White House with President Obama refusing to meet with him.
			Speaker of the House John Boehner invited Netanyahu after the recent terrorist attack on France. Interestingly, John Kerry and President Obama were absent from the Paris post-attack rally.
			David pointed to other political issues that exist behind this controversy as well. For example, in Israel, Netanyahu received a lot of criticism for accepting the invitation to speak to the U.S. Congress because the speaking date is just a few weeks before Israeli elections.

			About 7-1/2 years ago Answers in Genesis opened the Creation Museum in northern Kentucky. Before they had actually opened the museum they already had a strategic plan regarding what they had planned on doing next. One of the ideas was to build a life-size Noah's Ark with walk-through exhibits. Ken indicated that phase one of the project is under way and the ark will be open next year.
			Kentucky offers a tax incentive program to help bring tourism/economic impact dollars to the state. If a business qualifies in the sense that the state feels they will bring such income into the state, there's a rebate or a certain percentage taken off the sales tax generated within the qualifying facility.
			Answers in Genesis applied for this. They qualified but the state denied it due to their belief that AiG is too religious and due to what they deemed as 'proselytizing'. This amounts to viewpoint discrimination. The Freedom From Religion Foundation also put pressure on the state as well and Ken believes that they were a key in getting the State of Kentucky to change their mind.
			Answers in Genesis has announced that a discrimination lawsuit will be pursued against the State of Kentucky.
			This is the month of the birthday of Charles Darwin. Over the years an Evolution Weekend was established. As of this Crosstalk broadcast, those involved were boasting participation by 412 congregations in 45 states and D.C. and 13 countries. At the same time they were also boasting about a clergy letter project

			in which they allege that 12,991 current and retired clergy members had signed a statement affirming evolution as truth while denying a literal interpretation of Scripture. Jim Schneider / Barbara Loe Fisher	Should parents have the right to choose whether or not they want their children vaccinated or does refusal to have one's children vaccinated put the public health at risk? Joining Jim to discuss this topic was Barbara Loe Fisher. Barbara is the president of the National Vaccine Information Center, a non-profit organization she co-founded with parents of DT vaccine injured children in 1983. For over 30 years she has led a national grassroots movement and public information campaign to institute vaccine safety reforms and informed consent protections in the public health system. Barbara is the author of numerous articles and books including, 'Reforming Vaccine Policy & Law: A Guide' published in 2014. She is the mother of three grown children. Her oldest son suffered a convulsion, collapse and brain inflammation within hours of his fourth DPT shot in 1980 when he was 2-1/2 years old and was left with multiple learning disabilities and attention deficit disorder.
			Many media stories surfaced after it was reported that visitors to Disneyland contracted measles and presumably infected people in other states. On Monday it was reported that at least 100 measles cases originated at the theme park.
			Barbara said we've haven't received full information from the CDC regarding these measles cases that they claim are connected (92% of them) to an original source case. That original source case has not been identified.
			The reason Barbara sees this as important is because last year there were 644 cases of reported measles in the U.S. Some of these involved outbreaks in various areas yet we didn't see the kind of media frenzy that we're seeing surrounding the Disney case. So now there have been op-ed pieces saying that people who have not followed the government recommended vaccine schedule should be sent to jail or should be sued in court.
			One of the reasons why this reaction is disturbing is because out of the first 52 cases said to be associated with Disneyland, 6 individuals had been vaccinated and 4 individuals had at least 2 Measles, Mumps, Rubella (MMR) shots. We also know that in the Disney case the majority of the individuals involved were over 20 years old.
			Barbara noted that there's talk in the scientific literature about waning immunity; meaning that you can get vaccinated but the vaccination only gives you a certain number of years of immunity. So while originally it was thought that one MMR would give you lifelong immunity, in the late '80's it was discovered that this isn't true. Now it's looking like 2 shots may not be sufficient and that some scientists are actually calling for a third MMR shot.

			Part of the problem is that there have been more vaccines added to the recommended schedule in the last few decades. In the 80's the schedule was 23 doses of 7 vaccines, one of which was the MMR. Now the schedule involves 69 doses of 16 vaccines between the day of birth and age 18 with 49 of those doses coming before age 6. On this edition of Crosstalk you'll also hear about the concerns over a possible connection between measles and autism, the use
			of human fetal cell lines in some vaccines, the use of mercury preservatives in vaccines, the legal immunity of vaccine manufacturers and doctors, the demonizing of parents who want to make selective vaccine choices for their children, the necessity for informed consent protections for consumers in vaccine laws and much more.

Some are calling it the largest trade deal in history accounting for 40% of the world economy yet there is much secrecy surrounding it.
	-		Joining Jim to discuss this treaty was Rick Manning. Rick is president of Americans for Limited Government. They are a non-partisan organization working to identify, expose and work with Congress and state legislatures to prevent the continued expansion of government.
			The Trans-Pacific Partnership is a treaty that is being negotiated between the Obama administration and 12 Pacific Rim nations. It includes Canada, Mexico, Peru, Brunei, Malaysia, Vietnam, Japan and others. What this does is basically give most favored nation trading status to these nations. As a result, they'll have better access to our markets, lower tariffs for the goods they sell here and that will allow them to be able to increase exports to the United States.
			Looking at this treaty from a religious liberty perspective, Rick indicated that there are nations in this deal such as Brunei (that practices Sharia law), Malaysia (that has a very poor human rights record) and Vietnam that would be given access to U.S. markets for economic reasons with no concessions for religious liberties and the expansion of freedom in those nations.
			This treaty would have an impact on many aspects of American life from labor to environmental, the clothing you wear, Internet use and more and as a result Rick is concerned that Congress is considering not giving this trade agreement full vetting using the constitutional required power to ratify it with a two-thirds vote in the Senate. He's concerned that legislators are attempting to slip this through by casting something called the Trade Promotion Authority. This allows a simple majority vote in the House and the Senate rather than the normally required two-thirds vote.
			Keep in mind that Congress cannot amend this. Also, if passed, a treaty overrides all other laws in the U.S. therefore the Trans-Pacific Partnership would become the law of the land.
			Why would this new Congress suddenly decide to grant fast-track trade authority to President Obama when there's been controversy over his use of executive amnesty? Rick pointed out that this is not free trade, it's managed trade so why does there appear to be excitement about this partnership even among some Republicans when it hasn't been fully drafted yet? Find out

			This past Fall, Indonesia received a new president who has executed 6 people by firing squad to show his strict stance on drug dealers. Andrew and one of his friends are next on the list for execution. This was scheduled for this weekend although there has been some postponement due to various appeals with the hope that he can have his sentence changed to life in prison so he can help change the lives of prisoners.
			Twila Brase is the president and co-founder of Citizens' Council for Health Freedom which exists to protect health care choices and patient privacy. Twila is a certified public health nurse and health care freedom advocate and through her daily Health Freedom Minute addresses crucial health issues, patient privacy and health care reform.
			The deadline for open enrollment in Obamacare is coming up on the 15th. Twila began by warning listeners that they need to know the difference between coverage and care. This is because she believes Obamacare is little more than an expanded version of Medicaid for the middle-class on a sliding fee scale and she doesn't want to expand that kind of dependency into people's lives.
			She says that if you enroll, you'll find that deductibles are high, co-pays are high, co-insurance is high and the network is narrow. So many people say what they actually end up with through Obamacare is not a policy but something for a catastrophe because of how much they end up paying out-of-pocket.
			If you choose not to enroll, there are options that include paying for a policy out of the exchange such as private employer coverage, filing an exemption (there are 9, one of which is to become part of a cost-sharing organization) or pay the penalty tax.
			Ever wonder about the line labeled, 'Health Care Individual Responsibility' on your tax forms? This is the individual mandate in Obamacare. It requires you to have this coverage, to pay the tax or find an exemption. In other words, the IRS requires that you put in whatever you have claimed. If you have no exemption you will be paying the penalty for last year of \$95 or up to 1% of your income, whichever is greater.

Listeners may remember that it was back in 2006 when Alabama voters passed a constitutional amendment defining marriage as being between one man and one woman by 82%.
			Last week, a federal district judge in southern Alabama issued a single ruling claiming that the marriage laws were struck down. In response, some of the probate judges were being told by the ACLU and others that they needed to issue same-sex marriage licenses around the state. The stay on the decision was lifted on February 9th and the Supreme Court of the U.S. refused to extend that stay while it's in litigation.
			On Monday the 9th, some people obtained same-sex marriage licenses. However, on Sunday evening, Chief Justice Roy Moore of the Alabama Supreme Court issued an administrative order to all probate judges saying that they had no authority and that they were prohibited from issuing such licenses because it's not the law of the state. According to Mat, most but not all probate judges are following that administrative order.
			Liberty Counsel currently has a case pending before the Alabama Supreme Court asking the entire court to weigh in on this and to order the few probate judges that have issued same-sex marriage licenses to cease and desist.

	Hold		Joining Jim to discuss this was William Gheen, the president and spokesman of ALIPAC (Americans for Legal Immigration). Since 2004 he has been fighting against illegal immigration and any form of amnesty for illegal aliens.
			President Obama took some executive actions in 2014 that he's claimed he had the legal right to take as other presidents have done. According to William, no prior president has ever attempted to give amnesty to millions of illegal immigrants through memos. These are not executive orders but instead they are memos or rules by dictate. This is illegal and violates a host of existing federal laws including laws that make it illegal to assist illegal immigrants to stay in the U.S. unlawfully and laws against hiring them.
			This is very unusual when you consider the fact that President Obama himself said at least 22 times that he didn't have the authority to take the action that he executed.

			Interestingly only 18 California measles cases (not vaccinated) occurred in school aged children, children whose parents would have been eligible to exercise a non-medical exemption. So the mass hysteria in the news is all about 18 children who weren't vaccinated. The result is that 12 states have introduced legislation in the last week to take away the religious and conscientious exemptions in all state laws which leaves only a very narrow medical exemption.

From 1990-1993 he was the deputy chief at the Federal Communications Commission's office of plans and policy.
			Net neutrality refers to the idea that all the content on the Internet should be treated the same way. While on the surface this may sound reasonable, the American marketplace provides varying levels of choice in areas such as technical and pricing option categories and James argues that the Internet should be no different.
			While James doesn't see a conscious plan to censor speech or control content via net neutrality legislation, he does believe it sets the stage for that and puts the FCC and the federal government in what he referred to as 'the critical path' for approving what is transmitted via the Internet.
			Where does Congress and President Obama stand on this issue? Does the impetus for net neutrality legislation involve purely practical considerations or is there a political element? Is there any merit to FCC Commissioner Ajit Pai's allegation that the FCC is misleading the public about the plan? If these rules stand, what will be the impact on the Internet here is America? These and other questions are discussed on this vital edition of Crosstalk.

			Barronelle met and became friends with a man named Rob Ingersoll about 10 years ago. While understanding Barronelle's religious stance, he nonetheless identified himself to her as a homosexual. Knowing these things about each other they became good friends and worked well together.
			In 2012 Washington began to recognize same-sex marriage legally. Not long after that, Rob came into the store and requested that Barronelle do his wedding. She politely told Rob that she couldn't do the wedding due to her relationship with Christ. She did, however, recommend 3 other florists.
			Once Rob left the store, Barronelle thought they would remain friends. Shortly after that, however, the attorney general in the State of Washington heard about this story through the media and sued her both personally and professionally.
			The suit has been ongoing for the past two years. Unfortunately more pressure has been added to Barronelle's case because the ACLU is also suing her so she is liable for both the attorney fees of the ACLU as well as those for the attorney general, an amount that will reach into seven figures should this go up through the appellate process.

Mat is the Dean at the Liberty School of Law.
			Mat began by commenting on the recent speech by Israeli Prime Minister Benjamin Netanyahu before a joint session of Congress. He described the dire situation in which Israel finds itself regarding Iran's nuclear aspirations. In other words, this speech was not about his election and Mat believes Netanyahu would have come here with or without the election. He was cut out of deals, cut out of negotiations, he had top Israeli intelligence information leaked by our administration and he found out that President Obama was involved in secret negotiations with the Iranian regime.
			Mat then commented on the 'tug of war' going on between the U.S. Supreme Court and the Alabama Supreme Court. Liberty Counsel filed a petition at the Alabama Supreme Court to stop the probate judges from issuing same-sex marriage licenses. You may recall that Chief Justice Roy Moore issued an administrative order saying that the probate judges must follow Alabama law stating that marriage is between a man and a woman. Many probate judges did just that but then there was another opinion issued and soon some probate judges began issuing same-sex marriage licenses. Liberty Counsel filed suit against approximately 5 of the probate judges and went straight to the Alabama Supreme Court. They issued a lengthy opinion that Mat feels is solid as it pertains to the rule of law, the intersection between state and federal courts and marriage. It ultimately says that probate judges must cease from issuing same-sex marriage licenses. As Mat proved to listeners, regardless of what homosexual activists might say or write, the federal judge who is at the core of this situation knows she doesn't have the authority to force same-sex marriage on the state of Alabama.
			Mat also covered the circumstances surrounding the case of King vs. Burwell. This deals with the federal subsidies aspect of the Affordable Care Act (Obamacare). The original law never contemplated states opting out of the system. A state could opt out and not have a state exchange but if they did so they would not get federal Medicare/Medicaid funding. When the Supreme Court received the Obamacare case, Chief Justice John Roberts literally rewrote the statute saying that states can opt out and by doing so they don't give up their federal funding for Medicare/Medicaid. The result? Some states opted out anyway while keeping their Medicare/Medicaid funding and they have no state run exchanges. So now if someone needs to purchase insurance, in more than half the states there are no exchanges. In response, the federal government created their own federal run exchanges.
			So if you're in a state that doesn't have a state exchange, can you get the same federal subsidy? According to Mat, the plain reading of the law says no, that you have to be in a state that has a state run exchange. That's the argument before the Supreme Court.

Keep in mind that Israeli Prime Minister Benjamin Netanyahu, when speaking before a joint session of the U.S. Congress, said the following:

In a speech delivered last month to commanders and other Iranian Air Force personnel, Grand Ayatollah Ali Khamenei, Iran's Supreme Leader and Commander in Chief, communicated that they shut down uranium enrichment for a while in order to reach a deal with the U.S. He accused the U.S. and its allies of being greedy in negotiations and asserted that they will not submit to greed and tyranny. The audience responded in Arabic with the following chant:

"Allahu Akbar, Allahu Akbar, Allahu Akbar! Khamenei is the leader! Death to the enemies of the leadership! Death to America! Death to England! Death to hypocrites! Death to Israel!"

In spite of such evidence, Jay Johnson, the Department of Homeland Security Secretary who spoke at a recent conference of violent extremism, has sided with President Obama about not getting to the root of the terrorism that's taking place. He said that he is going to give voice to the plight of Muslims living in the U.S. He also said he is committing himself to speak out about Islam as being about peace and brotherhood.

From there, Jim noted other facts showing how Islam is successfully infiltrating many aspects of American society and how it's often given special treatment at the local, state and national levels. For example:

3/11/1 5	Islamic Indoctrinati on in U.S. Schools	Jim Schneider / Usama Dakdok	Usama Dakdok is the founder of the Straight Way of Grace Ministry. He was born and raised in Egypt in a Christian home. While in government schools he learned about Islam just as every other student does in a Muslim country. He eventually studied for a university degree in Egypt which included the study of Sharia (Islamic law). He came to America in 1992. He began the Straight Way of Grace Ministry as he travels across the

nation with his passionate desire of revealing the truth about Islam. His focus is twofold: to equip the church to minister to Muslims and to warn all Americans about the deceptive methods being used by Muslims that lead so many into the cult of Islam. Usama has done a word for word translation of the Qur'an in English and has authored books such as, 'Exposing the Truth About the Our'an' along with producing a daily radio program on VCY America entitled, 'Revealing the Truth About Islam.' Usama began by noting how many Americans are claiming that ISIS is radical and evil while at the same time teaching the slogan on the black ISIS flag to students. This slogan is the first of the five pillars of Islam called the Shahada. It says, 'There is no god but Allah, Mohammed is the messenger of Allah.' Some will claim that this is just the teaching of history. Usama has no problem with teaching the history of Islam as long as it's done right. In other words, teach the truth that by the Shahada, Mohammed and his followers killed millions of Christians and Jews. Is this being accomplished? The main segment of discussion dealt with 2 textbooks: 'World History—Connections to Today' by Prentice Hall and 'The Earth and Its Peoples-A Global History.' Some textual portions that Jim read communicate the following ideas: Muslims profess faith in the same God as that worshiped by Jews and Christians. Christian missionaries, like the Apostle Paul, added ideas to Christ's message from sources such as Plato, the Stoics and other Greek thinkers. While jihad does sometimes result in war, it's a struggle in the service of God to spread or defend Islam or to overcome immorality. Under Islamic law, Muslim women were better off than women under the religious codes of Christianity and Judaism. Usama uses his background to show why these ideas and others that are presented by these texts have no basis in fact from the perspective of the Qur'an, Islamic history and current Islamic culture. This means that portions of the Islamic information from these books appears to be propaganda designed for the purpose of Islamic indoctrination. Michael Berry is Senior Counsel and Director of Military Affairs for 3/12/1 Navy Jim Liberty Institute. He joined Liberty Institute in 2013 after serving Schneider / Chaplain 5 for seven years as an attorney with the U.S. Marine Corp. From Under Michael 2009 until 2013, Mr. Berry served as an appellate litigator, Attack for Berry arguing numerous cases before various federal appeals courts. From 2009 to 2012, he served as an adjunct professor of law at His Faith the United States Naval Academy. As Director of Military Affairs for Liberty Institute, Mr. Berry's practice focuses on religious liberty within the armed forces. As a recognized subject-matter expert, he has testified before Congress on matters affecting religious liberty in the armed forces. Wes Modder has been a Navy Chaplain for 15 years. Prior to that he was in the Marine Corps with a combined total of about 19-1/2 years of service and he is eligible for retirement in September of this year.

			Less than 1% of chaplains earn the distinction of being able to serve with our special forces unit and Chaplain Modder did just that. He was the force chaplain for Naval Special Warfare Command. That command oversees our Navy Seal teams so deployment overseas for Seal support is involved. He was also the chaplain for the Naval Special Warfare Center where recruits go to become Seals. He's been called a national asset, the best of the best, a consummate professional and praised for his sound judgment from a 'who's who' list of Navy personnel. According to Michael, sailors would come to Chaplain Modder in private, confidential, pastoral counseling sessions and ask the chaplain questions regarding his faith. His honest answers were handed over to the Navy culminating in a December 6th visit by one of his young officers and two equal opportunity officers. 			Minnesota is dealing with 3 policies that have come up at the local level. The first one was taken up last Fall by the Minnesota State High School League, the entity that governs competitive athletics at the high school level. They were going to force schools to adopt a policy that says that if a biological boy feels he is a girl, he should be allowed to play on the all-girls team. That includes using the girls locker room/shower facilities as well as travel with the girls team. In response, Child Protection League Action took out a full-page ad in the Minneapolis Star-Tribune alerting the public. This generated 10,000 e-mails to the Minnesota State High School League.
			150 people showed up at a meeting regarding this topic. It was tabled and taken up again in December after the election. Nine drafts later it had been watered down so much, an appeals process was passed that allowed local schools to have their own policy. However, if the individual school doesn't determine things the way the league thinks it should be, that transgender student can appeal to the league and the league will have the final say in the matter.
			2 more policies have come up since that time. The Minneapolis public schools quietly adopted a similar policy based upon the same language. Michele noted that the St. Paul public schools will vote at their school board meeting tonight to pass a policy that is broader than that of the Minnesota State High School League idea. This policy would also include gender, nonconforming students which includes those students who say they are neither male nor female.
			In response to public outrage, members of the Minnesota legislature have drafted HF-1546 (SF-1543 in the Senate) which says two things: You cannot allow biological males to play on female-only teams. The second part of this bill communicates that schools must keep separate boys and girls bathrooms based upon biology. In essence, the schools don't have to do any more than what they're already doing.
			Michele encouraged people to go to the Child Protection League Action website (www.cplaction.com) where you can see information regarding the Students Physical Privacy Act. She indicated that this bill is being held up by leadership in the House so if listeners want to see this bill move forward, they must contact their legislators.

			If legislators don't act, these policies will go into effect next Fall and unless there's some court action, more and more schools will adopt them and the normalizing of gender confusion will continue in the school system.

Israel has about 10 different parties that are elected to be in the Knesset (Israel's parliament) each year. So unlike voting in the U.S., in Israel they don't vote for an individual, they vote for a political party. At the end of the election the president of Israel (whose position is mostly ceremonial) meets with the heads of the political parties that were elected to the Knesset and the head of each of those parties recommends who they think should form the next governing coalition. In the case of the recent election, Benjamin Netanyahu won reelection so it's his responsibility to form the new governing coalition. He does this by meeting with the heads of each of the
			political parties, negotiates with them and after this process is complete, he decides who is to be given certain tasks in the government such as Minister of Defense, Minister of Finance, etc. That completes the governing coalition of the majority of the Knesset.
			David believes Netanyahu's reelection sends a multifaceted signal to the world. On one hand you have the message that the policies of Israel will move politically to the 'right.' 3/30	States Push Doctor Assisted Suicide Laws	Vic Eliason / Dr. David Stevens	Dr. David Stevens is the chief Executive Officer of the Christian Medical & Dental Society, a national organization of Christian doctors that seek to change hearts in healthcare. Dr. Stevens is the author of 'Jesus MD: A Doctor Examines the Great Physician' and 'Beyond Medicine: What Else You need to Know to be a Healthcare Missionary.' Dr. Stevens has helped develop an evangelism training program that teaches thousands of doctors and others how to share their faith in a healthcare setting.
			Doctor (physician) assisted suicide says that when a patient is terminally ill and the doctor believes they only have only 6 months to live, the patient can request a lethal prescription. This must be done through 2 oral requests and 1 written request. This process requires that the doctor lie on the death certificate in 3 states and say that the patient died by their disease and not of suicide.
			Isn't this a contradiction to the Hippocratic Oath? Yes it is but as Vic pointed out, in order to prevent doctor assisted suicide from looking so grotesque, they gave it a label: death with dignity. Dr. Stevens responded by informing listeners that verbal engineering always precedes social engineering. We see this from the organization once named The Hemlock Society. Obviously having a name derived from a poison wasn't very marketable so now they call themselves Compassion and Choices.
			Dr. Stevens summarized this program very well when he explained that doctor assisted suicide isn't about giving patients the right to die, it's about giving doctors the right to kill. It's an attempt to wrap the respectability of healthcare around an idea that we've looked on with disfavor in our culture ever since this nation was formed.
			Dr. Stevens believes compassion is not a handful of lethal pills. Compassion involves coming alongside someone and helping them bear their burden. Doctor assisted suicide is an escape from compassion for those who are around the patient.
3/31	LGBT's Intolerant Hatred of Christianity	Jim Schneider / Mat Staver	Since late last week when Indiana Governor Mike Pence signed into law the state's Religious Freedom Restoration Act (SB-101), the LGBT activist community and left-leaning groups have been in a frenzy. Their response shows how America has become entrenched in an extremist, left-wing, anti-Christian and anti-God mentality that appears to want nothing more than to trample the religious freedoms established in our Constitution.
			Joining Jim Schneider to discuss this issue was Mat Staver, the founder and chairman of Liberty Counsel and chairman of Liberty Counsel Action. Mat holds Bachelor, Master and Juris Doctorate degrees and an Honorary Doctorate of Laws and a Doctorate of Divinity. He has argued two landmark cases before the United States Supreme Court as lead counsel and written numerous

briefs before the High Court. Mat has argued in numerous state and federal courts across the country and has over 230 published legal opinions. He has authored hundreds of popular articles, eight scholarly law review publications, numerous brochures and booklets and 11 books, most of which focus on constitutional law. His two most recent books are, 'Eternal Vigilance: Knowing and Protecting Your Religious Freedom' which is the most comprehensive book ever written on religious liberty and 'Same-Sex Marriage: Putting Every Household at Risk.'

Indiana's new law has historic precedent that goes back to the 1990's. In 1993, the Federal Religious Freedom Restoration Act was overwhelmingly approved by Congress and signed into law by Democrat President Bill Clinton. After that time, individual states began to form their own similar restoration acts modeled after the federal law.

So now, with 20 years of history behind it, Indiana signed their version and LGBT activists and a segment of the media are acting as though Christians will be allowed to deny homosexuals the right to buy a hamburger at their local fast food restaurant. Instead, as Mat described it, the law is about allowing individuals to refrain from participation, celebration and promotion of anything that is contrary to their religious beliefs.

Should a Jewish print shop be required to print 'Death to Israel' signs? If the LGBT community were correct in their argumentation, logical consistency would demand that such signs be printed and Mat said that this example is not an over-exaggeration. In fact, he indicated that this would mean a printing company owned by an African-American individual would be viewed as showing wrongful discrimination by refusing a job to print literature promoting a pro-KKK rally.

As Mat described it, '...you see this intolerant homosexual agenda that's now coming out-of-the-closet if you will, and revealing their intolerance against any person of faith. They want no religious freedom, no accommodation for someone who has a sincerely held religious belief that does not agree with their lifestyle.'
