Brad Mattes is the CEO of Life Issues Institute, internationally headquartered in Cincinnati, Ohio. The organization was established to serve the educational needs of the pro-family movement. Brad is also president of the International Right to Life Federation and works with other countries to establish a prolife educational and counseling presence. Brad also serves on the Board of Directors of the Terri Schiavo Life and Hope Network.
			Jahi McMath is a youngster who went into Children's Hospital in Oakland, California, on December 9th to have a tonsillectomy to help her with sleep apnea. Before the surgery she was very fearful and told her mother that something bad was going to happen.
			Looking back, this fear appeared prophetic because when they woke her up from the surgery she began to hemorrhage. Jahi went into cardiac arrest and three days later the doctors told her mother that Jahi is brain dead and that they were removing her from life support. Her family won a last minute extension on a restraining order preventing the hospital from removing Jahi's ventilator
			A County Superior Court Judge has given the family until 5pm, on January 7th to appeal to a higher court to find another facility willing to take care of her. There is one available but Jahi will need a tracheotomy and a feeding tube so she can be safely transported to New York where the other facility is located. Unfortunately, according to media accounts, Children's Hospital will not allow surgery to be performed on what they term to be a dead body.
1/6/14	Learning	Jim	Jim began this edition of Crosstalk with two updates:
	Disabilities Is There Hope	Schneider / Steve Shapiro	As noted on the January 3rd edition of the program, 13 year old Jahi McMath, underwent tonsil surgery and other procedures on December 9th at Children's Hospital in Oakland, California, in order to treat sleep apnea. After suffering complications she went into cardiac arrest and was placed on a ventilator. On the 11th, doctors diagnosed her as legally brain dead. The family asked to keep her on the ventilator but the hospital wanted it removed. Due in part to calls from Crosstalk listeners, the hospital has agreed to allow a team to transfer Jahi to another facility.
			On December 20th, U.S. District Judge Robert Shelby ruled that Utah's ban on homosexual marriage violates the constitutional rights of gay and lesbian couples. Since that time more than 900 gay and lesbian couples have entered into so-called same-sex

			marriage. This morning the U.S. Supreme Court put same-sex marriage on hold in Utah while a federal appeals court more fully considers the issue.  Steve Shapiro holds a Masters Degree in Special Education and an Undergraduate Degree in Rehabilitation Psychology from the University of Kansas. After graduating in 1975, Steve taught for several years in a private school coordinating special education services and needs. In 1979 he moved to Oklahoma with a desire to expand his knowledge in order to help students struggling with Dyslexia, learning disabilities and reading problems. It was during this time Steve met an optometrist specializing in children with learning and reading difficulties and began using a unique developmental training program. He formed a center for the purpose of effectively helping students overcome learning and reading disabilities. This center later became 'The Learning Connection' and is based in Colorado Springs. He has two books, 'The Learning Connection' and 'Falling Through the Cracks.'
			20-30% of school age children today suffer from some kind of learning disability. In the realm of such disabilities there's the short attention span problems associated with Attention Deficit Disorder to the backward letter or number writing of Dyslexia to the various behavioral characteristics caused by Autism.
			What's exciting about Steve's approach to this problem is that he's discovered that these difficulties do not always neatly fit the brain disorder categories medical science has given them. He's found that certain symptoms can be signs of visual challenges that can be overcome. In fact, Steve has found that even adults can benefit from his vision processing program, a system that does not require the use of Ritalin or other drugs.
1/7/14	The True Gospel	Gordon Morris / Pastor Paul Washer	This Crosstalk featured Paul Washer who originally became a missionary to Peru where he founded the Heartcry Missionary Society. Today he works at his home church in Alabama, but he also speaks periodically in other locations, as he did in February, 2008 at a VCY America rally.
			The broadcast began with Paul discussing how the gospel has been reduced to a number of simple questions which include: Do you know you are a sinner? Would you like to go to heaven? Would you like to pray and ask Jesus Christ to come into your heart? If the respondent prays that prayer, we then ask if he/she was sincere. If the respondent says 'yes' to these questions, we declare the individual to be born-again. Paul pointed out how this is not the gospel of Jesus Christ 'and that methodology and evangelism has done more to hurt this country than every heresy introduced by every cult combined.
			This is just the beginning as Paul expounds on other aspects of the true gospel. For example, there's the importance of the need for preaching on sin so that people see the contrast of where they stand eternally in the light of God's perfection. From there he moves on to explain the concepts of justification, grace and propitiation.

She is a certified public health nurse and a health care freedom advocate. She has provided testimony before legislative bodies on health care related issues. She is also the daily speaker on the feature program 'Health Freedom Minute,' and she gave an update on what is happening with Obamacare. She highlighted some of the problems with the website 'Healthcare.gov.' She said the health care exchanges are nothing

			more than centers for redistribution of everyone's wealth. There are less than 2 million people enrolled in the exchanges.
			Twila's website is' cchfreedom.org.' There is a wealth of information for the individual consumer on this website. You may also subscribe to the CCH Newsletter on that website. Democrats are blaming Republicans for the low enrollment numbers on the exchanges. They are accused of giving out false information that the law was repealled. If you go on Medicaid, and you die, the government can come in and take your estate to pay back your use of Medicaid, before your children can receive their inheritance.
			34 states have refused to participate in the heath care exchanges. It could all come down to a battle of states' rights versus federal government power. If you decide this year not to take the health care, the government can tax you next year for your penalty of not having health care coverage. They can deduct out of your tax refund however much they feel you are required to pay. She counsels people to reduce their exemptions and have less taken out of their payroll checks so that they may even have to pay a little next year on taxes rather than allowing the government to control their tax refund. If you receive a penalty, you can pay that out of your own pocket, instead of the IRS having control of your tax refund.

The Utah Governor has said the state will not recognize the same-sex marriages. There have been a number of states collecting signatures for succession from the United States.
			'Life Site News' reports on the Jahi McMath case in which the 13-year-old girl went into cardiac arrest and was declared brain dead by the Children's Hospital of Oakland, California due to complications resulting from a routine tonsilectomy. She has since been moved to another health care facility and is beginning to heal once she received the care she needed.
			At 'Hercules High School' in the bay area just 10 miles north of Berkeley California, a 16-year-old transgender sophomore who was the center of an alleged bullying case due to his/her gender confusion has now been charged with battery and bullying against a girl at the school.
			In a California elementary school a 6-year-old child was told he could not pass out candy canes with the story of the candy cane relating to Christ attached to them. The teacher went to the principal's office, came back to the class, and told the little boy that 'Jesus is not alowed in school.' The teacher tore the messages off of each candy cane, and the little boy was then allowed to hand out the candy. If anyone is threatened by such religious persecution, Vic encouraged them to call "Liberty Counsel" for pro-bono litigation services. Their number is 1-800-671-1776.
			A Satanic group unveiled the design for the Oklahoma capital of a monument to Satan. Satan is posed in front of a pentagram, sitting on a throne with smiling children surrounding him. Children will be allowed to sit on his lap and meditate or contemplate. For almost 60 years, Open Doors has worked in the world's most oppressive and restrictive countries, strengthening Christians to stand strong in the face of persecution and equipping them to shine Christ's light in these places.
	2014		Last week, Open Doors released its 2014 World Watch List of 50 countries that are the worst persecutors of Christians. Jerry noted they do this list so that Christians become aware of what's happening in the world to their brothers and sisters in the faith and also how we can pray better for them.
			There were 2,123 recorded killings of Christians last year. In addition, two-thirds of the countries on the World Watch List this year saw a growth in persecution in 2013.
			While 9 of the top 10 nations persecute Christians due to Muslim terrorism, the #1 nation on the list appearing for the 12th straight time is North Korea. Jim and Jerry looked at this nation

			in detail discussing why persecution is so prevalent there.
			2 surprises included the Central African Republic, a nation that last year was not on the list but is now listed at the #16 spot and the South American nation of Colombia, a nation that jumped from #46 to #25.
1/14/1	The Legacy of Ariel Sharon	Vic Eliason / David Rubin	After 8 years in a coma, the former Prime Minister of Israel, Ariel Sharon, has passed away at 85, immediately setting into motion an intense dialogue in Israel about Sharon's larger than life legacy. Political commentator and Israeli spokesman David Rubin has chosen not to ignore the complexities of this legend, whose charismatic personality was often a lightning rod for fierce debate within Israeli society.
			David is a former mayor of Shiloh, Israel, in the region of Samaria known to most of the world as the West Bank. He is the founder and president of Shiloh Israel Children's Fund dedicated to healing the trauma of children who have been victims of terrorist attacks. He is the author of three books including, 'Peace for Peace: Israel in the New Middle East' and 'The Islamic Tsunami: Israel and America in the Age of Obama.'
			According to David, Ariel Sharon was a complex figure; a tremendous military hero who saved Israel from destruction during the Yom Kippur War in 1973 after Israel had been attacked by surprise by the nation of Egypt. Vic also pointed to Sharon's efforts during the 1956 Suez Crisis, the Six Day War in 1967 and the 1982 War.
			Although Sharon was a great military and political leader, David also admitted that there were problems during Sharon's tenure as Prime Minister. So while he considers Sharon to have been a great builder of the controversial settlements he was also a great destroyer of them as well as Sharon eventually adopted the leftwing policy to unilaterally withdraw from the Gaza Strip and turn it over to the Palestinian Authority. Mat believes this is the result of last year's decision where Justice Kennedy was the swing vote and authored the decision. In that decision he used the phrase 'equal protection' but didn't use the equal protection analysis.
			In their discussion of the main topic, it was noted that on Black Friday the IRS sent out proposed regulations that would increase their power over $501(c)(4)$ organizations. These are non profit organizations but contributions to them are not tax deductible.
			Historically, c4's can do more lobbying than c3's and this is why the new regulations are so oppressive because they will not allow c4's to use words like 'oppose', 'vote', 'support', "'defeat', or 'reject'. 			What is Common Core? Common Core is a set of never-tested federal standards for education written by two Washington lobbyist groups, the National Governors Association and the Council of Chief State School Officers (C.C.S.S.O.). These two groups were funded by about 150 million dollars by the Bill and Melinda Gates Foundation.
			How did Common Core get imposed on the states? According to Dr. Pesta, back in 2009, President Obama created the "Race to the Top" program. Through this program, the government offered billions of dollars in taxpayer money called the 'Stimulus for Education' to states for their struggling education budgets. If a state accepted the money, they had to adopt Common Core education standards when they were finally written.
			One particularly disturbing factor is the national sexuality standards that were developed by the National Department of Health. Rather than being introduced as a separate series of knowledge bases, it is being folded into subjects such as Math and English as a curriculum modification. 	of the States		Article V allows for ways to amend the Constitution. One is by Congress passing an amendment that's sent to the states to be ratified. The other way is to have two-thirds of the states pass legislation calling for a constitutional convention to discuss one or more issues. Once two-thirds or 34 states put in such a request, then according to Article V Congress is supposed to convene a constitutional convention.

One of the major concerns that Tom has with the idea of holding a constitutional convention is that once one is called, there is no controlling of what is discussed. As Tom noted, our Constitution is the only governing document that says you have rights you are born with and it's the job of government to protect those rights. That's what makes us a republic, not a democracy. The reason this is a concern is because there are those who feel our Constitution is old, outdated and needs to be modernized. The people saying these kinds of things want to change our Constitution because they don't like what it says. It's restricting what they want to do and they want it out of the way. One of the ways that's being used to do away with it is to simply ignore it. Those who appreciate our Constitution see this taking place and the answer for some is to initiate an Article V convention. Tom doesn't see how this solves anything any differently than a constitutional convention. You're still bringing a group of people together, you have to decide how the delegates are chosen and there's no way to control what happens once they convene. The problem is, why does this have to be done in the first place? Again, it's because those in power are ignoring the Constitution. Tom described a scenario where he imagined we had an Article V convention and we passed a balanced budget amendment, we made English the official language, stopped illegal immigration, etc., and now these things are in the Constitution. At that point, what changes? The people ignoring the Constitution are opposed to these things. What under an Article V convention model forces anyone to adhere to the Constitution? Under this scenario, just because the American public would have passed these things doesn't force legislators to suddenly have to govern properly. She is a public speaker and author of several articles including, 'The Abortion-Breast Cancer Link: How Politics Trumped Science and Informed Consent'. She has provided testimony before state legislatures and has conducted numerous interviews in print, radio and television on this topic as she is a breast cancer expert.
			Karen is optimistic that the court will give some protection to Hobby Lobby and Conestoga Wood Specialties because of their First Amendment rights of religious freedom.
			She noted how the government's attorney said that women's rights would be undermined and they would be treated as 'second class citizens' if companies like Hobby Lobby are allowed to opt out of providing abortion inducing drugs.
			The attorney for Hobby Lobby responded by saying that if it's the government's goal to provide such drugs to all women in America, there are other means that the government could use in order to achieve that goal.
			The Coalition on Abortion/Breast Cancer has filed an amicus brief with the court on this issue. The thrust of the amicus brief is that in order for the Obama administration to be successful in coercing corporations to provide abortion inducing drugs and contraceptives against their religious beliefs, the Religious Freedom Restoration Act requires that the government must show that it has a compelling interest in this matter. The compelling interest that the Obama administration has claimed is that use of contraceptive steroids and abortion inducing steroids constitutes women's preventative health care.
			If this is true, then why did the World Health Organization classify the birth control pill as a group one cancer causing substance nearly 9 years ago? That's the highest level of carcinogenicity. That's on the same level as mustard gas, benzine, cadmium and tobacco.
			The pill raises the risk for cancer of the breast, liver and cervix. Karen admits that the World Health Organization says that the pill does reduce the risk for two cancers; cancers of the endometrium and ovaries. However, in the U.S. there are four times as many cases of breast cancer every year than there are total cases of ovarian and endometrial cancers put together. In other words, the cases of cancer that the pill causes are far greater than the number of cancers that it may prevent.
			8 medical groups have issued statements stating that abortion itself raises the risk by leaving the breast with more places for cancer to start. Karen also noted that it's universally recognized that child-bearing, an early first full-term pregnancy and breast feeding all help to reduce the cancer risk.
