

## 2016-2017 EEO PUBLIC FILE REPORT

<sup>1</sup> All stations are licensed to Sanpete County Broadcasting Co. ("SCBC"). Facility ID 72769 (now KMGR, formerly KUDE) was included in the SEU as of January 31, 2017, on which date SCBC purchased the station pursuant to prior FCC consent. Facility 65377 (now KUTC, formerly KMGR) was previously included in the SEU because its programming was brokered by SCBC under a time brokerage agreement. However, SCBC purchased that station on April 19, 2017, pursuant to prior FCC consent.
