Imagine giving birth to a child, only to see him whisked away to neonatal ICU for an unexpected mass found in his neck. Lymphatic Malformation, which affects 1 in 2,000 to 4,000 births, is a condition where the lymphatic vessels do not form properly and can cause cysts throughout the body. The cause is unknown. And when the child of a local nurse was born with LM she searched for information but found very little. So she founded Liam's Land ~ a 501(c)(3) non-profit dedicated to supporting LM research and creating an international registry of patients to help doctors and researchers learn more fight the disease.
