

Dear Sir or Madam:

As you know, WHNT-TV is the primary network affiliate of the CBS Television Network for the Huntsville-Decatur-Florence, Alabama television market. Our affiliation agreement expires June 30, 2015. Recently, we entered into an amendment to our affiliation agreement that protects WHNT-TV through the term of the agreement against the duplication of CBS network programming from another television station during the period beginning one day before and ending seven days after the delivery the network program. The terms of our network non-duplication rights are set forth in the attachment.

WHNT-TV broadcasts regularly scheduled CBS Television Network programming during the following time periods:

Monday-Friday	2:05 – 4:30 am, 7:00 am – 9:00 am, 10:00 am – 12:00 pm, 12:30 – 3:00pm, 5:30 – 6:00pm, 7:00 – 10:00pm, 10:35pm – 12:35am
Saturday	8:30 – 11:30 am, 5:30 – 6:00 pm, 7:00 – 10:00 pm
Sunday	8:00 – 10:00 am, 5:00 – 5:30pm, 6:00 – 10:00 pm

From time to time, WHNT-TV broadcasts CBS network programs, including news and sports, in additional time slots.

FCC rules prevent local cable systems from carrying the signal of any other television station when such other station broadcasts CBS programming. If your cable system has been honoring WHNT-TV's network exclusivity rights, we thank you for your cooperation and request that you continue these efforts through the duration of our affiliation agreement. If your cable system has not been honoring WHNT-TV's rights (for example, by importing out-of-market CBS signals), we hereby assert our right to require your cable system to begin providing program exclusivity at the earliest practical date, but in no event later than sixty days from your receipt of this letter.
