Dear Barry:

This letter confirms that Fox Broadcasting Company ("Fox") and the current FCC Licensee ("Licensee") for the television station(s) listed on the attached Exhibit A ("Station") agree that, notwithstanding anything to the contrary in the current Station Affiliation Agreement ("Agreement") between Licensee and Fox, the Agreement is hereby amended as follows:



ET/PT, Saturday (or Sunday, if applicable) (MT/CT, one hour earlier) (collectively, the "Time Period"), will cease as a Fox Programmed Time Period (as defined in the Agreement) and revert to Licensee for Station to fulfill as Station's local Time Period throughout the term of the Agreement.

The parties hereby agree that, except as modified by this amendment, all other terms and conditions of the Agreement remain in full force and effect.


