Re: Response to Notice of Violation for WDSI-TV (Chattanooga, TN) Facility #71353  
File No. EB-10-AT-0099 NOV No. V201032480007

To Whom It May Concern:

New Age Media of Tennessee License, LLC ("Licensee"), licensee of WDSI-TV, received notice on or about August 20, 2010 that it had inspected the station's main studio and observed potential FCC violations. In accordance with such notice, Licensee is submitting the following response. For ease of reference, the lettering herein refers to the lettering of the inspection letter.

a.

47 C.F.R. § 11.52(d): "EAS participants must monitor two assigned EAS sources."

The station was monitoring only one of the two assigned EAS sources.

**ANSWER: Resolved.** Upon moving the TFT EAS system into the new console we replaced all the antenna wiring feeding the receiver and we are now receiving both assigned sources and NOAA.

b.

47 C.F.R. § 11.61: "(a)... All tests will conform with the procedures in the EAS Operating Handbook. ... (b) Entries shall be made in EAS Participant records, as specified in Sections 11.35(a) and 11.54(b)(13)." The EAS Operating Handbook requires EAS participants to log all received and transmitted EAS tests. In addition, Section 73.1820(a)(1)(iii) states that "[e]ntries must be made in the station log either manually by a person designated by the licensee ... or by automatic devices. ... The following information must be entered: An entry of each test and activation of the EAS pursuant to the requirement of part 11 of this chapter and the EAS Operating Handbook."

The station's EAS logs contained no entries for transmitting weekly tests or receiving and retransmitting monthly tests.

**ANSWER:** We are now printing reports of the tests from the ENDEC unit. We have a fully functional crawl. We have received and installed the necessary software update that allows our IS 750 to pass the AES audio produced by the EAS unit. This gave us a functional tone on air and this issue is fully resolved.
