Re: **Election of Retransmission Consent Status**

Dear Brad:

Univision Communications Inc. ("Univision"), parent company of the licensees of the television stations listed in the attached Exhibit A (each, a "Station" and collectively, the "Stations") hereby gives notice to Buckeye Cable System that, pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC's Rules, Univision elects to assert its right, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC's rules, to have the broadcast signals of the Stations carried on your cable system(s) in each of the Stations' respective defined markets only if we have provided our express written consent. Accordingly, none of your cable systems (or other video distribution systems) may retransmit the broadcast signals of the Stations, or any portion(s) thereof, without Univision's express written consent. Univision's election of retransmission consent applies to all Buckeye Cable System systems with respect to each Station and to all other systems under common control or affiliated with, or owned and operated by Buckeye Cable System.

Each Station sent individual retransmission consent election letters to all known Buckeye Cable System systems in its market on or about September 5, 2014. This election of retransmission consent is for the period of January 1, 2015, through December 31, 2017.
