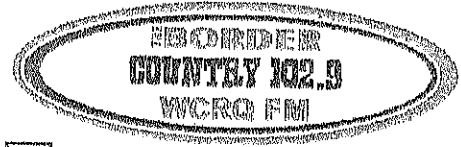
The free scholarship is being provided to all high school

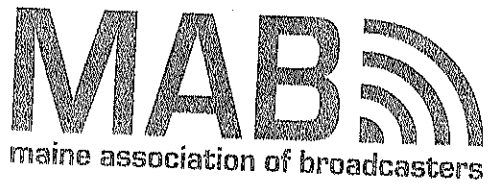
