## PUBLIC SERVICE ANNOUNCEMENTS

WZAK-FM airs a variety of Public Service Announcements in unsold commercial avails on a wide assortment of topics of community interest. A description of some of these announcements follows:

**Adopt Foster Kids:** Discusses, via humorous vignettes, the importance of adopting children out of the foster system and the advantages these children have as a result. (:60 seconds, airs 3+ times weekly, April 1 through June 30)

**Caregiver Assistance:** Discusses some of the difficulties a family caregiver might experience, and directs the listener to a section of the AARP website with resources that may be able to assist. (:60 seconds, airs 3+ times weekly, April 1 through June 30)

**Gynecological Cancer Awareness:** Discusses the importance of being aware of one's body, and that certain changes may be signs of gynecological cancers and should be brought to the attention of a physician. (:30 seconds, airs 3+ times weekly, April 1 through June 30)

**Teens and Marijuana:** Discusses the deleterious effects of using marijuana among teens, under the current scenario of increased legalization of medicinal and recreational marijuana use. (:60 seconds, airs 3+ times weekly, April 1 through June 30)

**Adult Vaccinations:** Discusses the advantages of adults receiving vaccinations, including, but not limited to, the flu vaccine. (:60 seconds, airs 3+ times weekly, April 1 through June 30)

**Indoor Allergens:** Discusses common indoor allergens and directs listeners to a website with information on reducing their impact. (:30 seconds, airs 3+ times weekly, April 1 through June 30)

**Voices for Recovery:** Gives information on referrals for treatment for mental health and substance abuse disorders (:20 seconds, airs 3+ times weekly, April 1 through June 30)

**Childhood Asthma:** Directs listeners to a website with information on prevention and treatment of childhood asthma. (:20 seconds, airs 3+ times weekly, April 1 through June 30)

**Don't Text & Drive:** Highlights the dangers of texting while driving (:30 seconds, airs 3+ times weekly, April 1 through June 30)

**National Fair Housing Alliance:** A series of PSAs that discuss a number of discriminatory housing practices based on national origin, disability, sex, race, color, religion or familial status. (:60 seconds, airs 3+ times weekly, April 1 through June 30)

Type 2 Diabetes Prevention: Presents a checklist of factors that may indicate that the listener is pre-diabetic, and directs the listener to a website for more information (:60 seconds, airs 3+ times daily, April 1 through June 30)

LGBT Discrimination: Raises awareness of LGBT discrimination, and the fact that it remains legal in 31 states. (:30 seconds, airs 3+ times daily, April 1 through June 16)

Gun Storage Safety: Directs listeners to information regarding safe gun storage, and discusses statistics of accidental death as a result of guns not being safely stored. (:30 seconds, airs 3+ times daily, April 1 through June 30)

Social Security Administration: A series of PSAs discussing what SS beneficiaries can do on the Social Security website (planning, apply for benefits, check account, etc.) (:15 seconds, airs 3+ times daily, April 1 through June 30)

CDC – Antibiotic Usage: Provides information on proper use of antibiotics, and when antibiotics are and are not appropriate to use. (:30 seconds, airs 3+ times daily, April 1 through June 30)

CDC – HIV Awareness: Points listeners to the CDC website for detailed information regarding HIV prevention and lessening the stigma of those afflicted by the disease. (:30 seconds, airs 3+ times daily, April 1 through June 30)

BrightFocus Foundation: Encourages listeners to get regular eye exams to detect early stage macular degeneration, which often starts without obvious symptoms. (:30 seconds, airs 3+ times daily, April 1 through June 30)

Lung Cancer Awareness: Messages encouraging smokers to get screened for lung cancer, and informs the listener that screenings are easier than ever with modern techniques. (:30 seconds, airs 3+ times daily, April 1 through June 30)

Saving for Retirement: Message directs African American women to a website with information about saving for retirement. (:15 seconds, airs 3+ times daily, April 1 through June 30)

Coronavirus Response: Messages encouraging social distancing, and several suggestions on how to do it. (:30 seconds, airs 3+ times daily, March 26-31)

CDC/COVID-19: Message discusses the basic hygiene that will help to diminish the spread of coronavirus. (:30 seconds, airs 3+ times daily, April 1 through June 30)

Suicide Prevention: Messages encourage listeners to pay attention to the moods of their associates, and to reach out to them. Directs the listener to online resources that may be helpful to break the ice. (:30 seconds, airs 3+ times daily, April 1 through June 30)

Alzheimer's Awareness: Messages encourage listeners to be aware of early signs of dementia and directs them to resources to help. (:30 seconds, airs 3+ times daily, April 1 through June 3)
