THE MAINE LEGISLATURE RETURNED TO WORK ON WEDNESDAY FOR THEIR SECOND REGULAR SESSION. LAWMAKERS HAVE MORE THAN 400 BILLS TO CONSIDER. AS THE STATE MANDATED MORATORIUM ON RECREATIONAL MARIJUANA SALES IS SET TO EXPIRE ON FEBRUARY 1ST, LAWMAKERS SAY A REGULATORY SYSTEM NEEDS TO BE IN PLACE SOON OR THE MORATORIUM NEEDS TO BE EXTENDED. PAUL MCCARRIER, WITH LEGALIZE MAINE, TELLS TV5 THE PUBLIC WILL ONCE AGAIN BE ABLE TO WEIGH IN ON THE PROPOSED ENFORCEMENT PROTOCOLS AND DETAILS OF THE ADULT-USE LAW ON FRIDAY AT THE STATE HOUSE.

AMONG THE OTHER ISSUES BEING CONSIDERED THIS SESSION ARE MEDICAID EXPANSION, THE FUTURE OF SOLAR POLICY, AND THE OPIOID CRISIS. THIS SESSION IS EXPECTED TO ADJOURN IN MID-APRIL. 128TH 2 1/4 PA

LAWMAKERS RETURNED TO AUGUSTA WEDNESDAY TO BEGIN WORK ON MANY BIG ISSUES. MEDICAID EXPANSION IS EXPECTED TO BE AN UPHILL BATTLE BETWEEN REPUBLICANS, SOME OF WHOM WANT TO REPEAL IT OR ENSURE IT'S NOT FUNDED BY RAISING TAXES OR RAIDING SURPLUS FUNDS, AND DEMOCRATS WHO ARE STILL TRYING TO DETERMINE HOW MUCH IT WILL COST AND WHERE THAT MONEY WILL COME FROM. HOUSE MAJORITY LEADER, REPRESENTATIVE ERIN HERBIG SPOKE WITH TV5.

WHILE RECREATIONAL MARIJUANA SALES WILL ALSO TAKE UP MUCH ATTENTION, VARIOUS ADVOCACY GROUPS ARE PUSHING LAWMAKERS TO ADDRESS THE OPIOID CRISIS, A CRIME-VICTIM BILL OF RIGHTS, AND THE FUTURE OF SOLAR POLICY. 128TH 3 1/4 PA

WEDNESDAY MARKED THE FIRST DAY OF THE SECOND SESSION OF THE 128TH LEGISLATURE. WHILE MEDICAID EXPANSION AND RECREATIONAL MARIJUANA SALES WILL TAKE UP MUCH ATTENTION, LAWMAKERS ARE ALSO CONSIDERING A CONTROVERSIAL BILL BROUGHT FORWARD BY MAINE'S SECRETARY OF STATE MATT DUNLAP THAT WOULD BAN SIGNATURE GATHERING AT MAINE POLLS. HE SPOKE WITH TV5.

BESIDES THE FUTURE OF SOLAR POLICY AND THE OPIOID CRISIS, LAWMAKERS WILL ALSO NEED TO CONTEND WITH THE RECENTLY APPROVED FEDERAL TAX PLAN. THIS SESSION IS EXPECTED TO ADJOURN IN MID-APRIL.

THE MAINE DEPARTMENT OF AGRICULTURE, CONSERVATION, AND FORESTRY SAYS THE FIRST DAY OF THE STATE'S ANNUAL FARM SHOW WILL FOCUS ON LINKING PEOPLE WITH CAREERS IN AGRICULTURE. THE AGRICULTURAL TRADES SHOW WILL HOLD ITS SECOND AGRICULTURAL CAREER FAIR ON TUESDAY IN AUGUSTA. THE EVENT WILL TAKE PLACE AT THE CIVIC CENTER. ORGANIZERS SAY EMPLOYERS WILL INCLUDE 'UNITED FARMER VETERANS OF MAINE', 'THE MAINE ORGANIC FARMERS AND GARDENERS ASSOCIATION', AND 'HAMMOND TRACTOR COMPANY'. THE STATE AGRICULTURE DEPARTMENT IS HOSTING THE CAREERS EVENT IN COLLABORATION WITH THE MAINE DEPARTMENT OF LABOR. GOV. PAUL LEPAGE SAYS THE CAREER FAIR IS A GREAT WAY FOR JOB SEEKERS TO FIND OUT ABOUT THE AGRICULTURE INDUSTRY IN MAINE. THE MAINE PUBLIC UTILITIES COMMISSION HAS DELAYED ACTION ON A POWER CONTRACT FOR THE AQUA VENTUS OFFSHORE WIND PILOT PROJECT NEAR MONHEGAN ISLAND. REGULATORS ON TUESDAY CITED CHANGING ENERGY MARKETS THE FOR DELAY. AQUA VENTUS COUNSEL ANTHONY BUXTON SAYS THE ELECTRICITY TARGET PRICES WILL BE COMPETITIVE IF THE PROJECT REACHES COMMERCIAL SCALE. HE SAYS MILLIONS OF DOLLARS HAVE BEEN SPENT ON THE DEMONSTRATION PROJECT AND THAT THE UNIVERSITY OF MAINE-DESIGNED FLOATING WIND TURBINES ARE CRITICAL TO THE STATE'S ECONOMY WITH THE POTENTIAL TO CREATE THOUSANDS OF JOBS. MORE PUBLIC COMMENTS WILL BE TAKEN BEFORE A FINAL DECISION IS MADE. BAD ROOFER 2/8 PA

A NORTHPORT MAN IS GOING TO PRISON FOR TAKING MORE THAN \$4,000 FROM TWO PEOPLE TO FIX THEIR ROOFS, THEN SKIPPING OUT ON THE JOBS. 47-YEAR-OLD STEPHEN BOYLE PLEADED GUILTY THIS WEEK TO HOME REPAIR FRAUD AND THEFT. HE WAS SENTENCED TO 15 MONTHS IN PRISON AND ORDERED TO PAY \$4,300 IN RESTITUTION. LAST APRIL A HOMEOWNER IN BELFAST SIGNED A CONTRACT WITH BOYLE FOR \$6,300 FOR A ROOF REPAIR. BOYLE GOT HALF THE MONEY BUT NEVER DID ANY OF THE WORK. POLICE ALSO LEARNED BOYLE DID THE SAME THING TO ANOTHER PERSON IN 2015 BY TAKING A \$1,000 DOWN PAYMENT AND STEALING SHINGLES FROM THE JOB SITE. THE THIRD LARGEST BREWING COMPANY IN MAINE IS EXPANDING ITS TAPROOM TO 10 TIMES ITS ORIGINAL SIZE. LEWISTON'S BAXTER BREWING CO. WILL OPEN THE NEW 4,800-SQ. FOOT TAPROOM THIS SUMMER, AND IT WILL INCORPORATE MACHINERY FROM THE BUILDING'S PRIOR HISTORY AS A HISTORIC MILL. FOUNDER LUKE LIVINGSTON SAYS THE TAPROOM'S CURRENT SIZE HAS BEEN A CONTINUING ISSUE FROM THE BEGINNING, BEING ONE OF THE SMALLEST AMONG MAINE'S OVER 100 BREWERIES. BAXTER BREWING EMPLOYS 33 PEOPLE. LIVINGSTON SAYS THE EXPANSION WILL ADD NEW JOBS, THOUGH HE ISN'T SURE HOW MANY YET. ACCORDING TO A 2017 REPORT FROM THE MAINE BREWERS' GUILD, CRAFT BEER IS A GROWING INDUSTRY IN MAINE WITH AN ECONOMIC IMPACT OF MORE THAN \$225 MILLION. BILL DIES 1/10 PA

THE GOVERNOR'S BILL TO ENCOURAGE THE GROWTH OF FOREST PRODUCTS AND WOOD MANUFACTURING JOBS DIED IN COMMITTEE AT THE REQUEST OF ITS SPONSOR. SENATOR JAMES DILL SAYS THE BILL WAS CARRIED OVER FROM LAST SESSION AND A FEW ISSUES STILL NEED TO BE RESOLVED BEFORE IT CAN BE REINTRODUCED. HE SPOKE IN FRONT OF THE COMMITTEE ON ENERGY, UTILITIES, AND TECHNOLOGY TUESDAY.

THE BILL WOULD HAVE ENSURED THAT THE COST OF LONG-TERM CONTRACTS FOR MANUFACTURING JOBS COULDN'T EXCEED THE PROJECTS' COSTS PLUS A REASONABLE RATE OF RETURN ON INVESTMENT. IT ALSO PROMISED TO PROVIDE CREDITS OR LONG-TERM ENERGY CONTRACTS FOR ENERGY PROJECTS PROVIDING A CERTAIN NUMBER OF JOBS. DCF BILL FAILS 2/16 PA

AN EMERGENCY BILL TO FUND THE DOWNEAST CORRECTIONAL FACILITY WAS VOTED ON AND SUPPORTED LAST WEEK, BUT FAILED TO GET THE NECESSARY TWO-THIRDS VOTE IN THE HOUSE THURSDAY IN AUGUSTA. THIS COMES IN THE WAKE OF THE PRISON'S CLOSURE ON FRIDAY. REPRESENTATIVE CHARLOTTE WARREN SPOKE BEFORE YESTERDAY'S VOTE.

2001 WARREN :16 ... OF CORRECTIONS.

THE BILL ISN'T TECHNICALLY DEAD YET. AN AMENDED VERSION COULD COME BACK TO THE HOUSE, AND WOULD TAKE A SIMPLE MAJORITY TO PASS. EVEN THEN IT COULD STILL BE VETOED AND HOUSE REPUBLICANS SAY THEY HAVE MORE THAN ENOUGH VOTES TO UPHOLD ONE. DCF BILL FAILS 2/16 PA

A ROUND OF VOTES IN AUGUSTA THURSDAY SHOWS THAT MAINE LAWMAKERS WILL NEED MORE SUPPORT TO ENSURE FUNDING FOR THE DOWNEAST CORRECTIONAL FACILITY. THE SENATE VOTED 31-3 WHILE THE HOUSE VOTED 87-59 ON A BILL TO PROVIDE \$5.5 MILLION IN FUNDING FOR THE PRISON. LAWMAKERS NEED A TWO-THIRDS MAJORITY IN BOTH CHAMBERS TO OVERRIDE LEPAGE'S LIKELY VETO. HE AND HOUSE REPUBLICANS, LIKE REPRESENTATIVE ELLIE ESPLING, ARGUE THE PRISON IS UNNECESSARY.

EVEN THOUGH THE FACILITY WAS FUNDED THROUGH JUNE, LAST FRIDAY LEPAGE TRANSFERRED ABOUT 60 INMATES AND LEFT MORE THAN 50 STAFF MEMBERS WITHOUT JOBS.

DCF BILL FAILS 3 2/16 PA

A MEASURE TO REOPEN THE DOWNEAST CORRECTIONAL FACILITY IN MACHIASPORT FELL SHORT IN THE MAINE HOUSE THURSDAY. THE ENTIRE DEMOCRATIC CAUCUS SUPPORTED THE EMERGENCY LEGISLATION, BUT ALL BUT 7 REPUBLICANS VOTED AGAINST IT, DOOMING THE BILL'S CHANCE OF SURVIVING AN ALL BUT CERTAIN VETO FROM GOVERNOR PAUL LEPAGE. THE MEASURE WOULD KEEP THE FACILITY OPEN FOR ANOTHER YEAR BY PROVIDING \$5.5 MILLION IN FUNDING. ANDREA GUERRA, A WASHINGTON COUNTY BUSINESS OWNER, SPOKE WITH TV5 AFTER YESTERDAY'S VOTE.

GOVERNOR PAUL LEPAGE SAYS THE FACILITY IS OUTDATED AND TOO EXPENSIVE TO RUN. IT WAS A WEEK AGO HE HAD STATE POLICE TRANSFER THE INMATES AND LAID OFF MORE THAN 50 STAFF MEMBERS WITHOUT WARNING. DECF REACTION 2/12 PA

RESIDENTS OF MACHIASPORT AND SURROUNDING COMMUNITIES ARE REACTING TO GOVERNOR PAUL LEPAGE'S ORDER TO REMOVE THE INMATES FROM DOWNEAST CORRECTIONAL FACILITY ON FRIDAY. LOCAL OFFICIALS, INCLUDING WASHINGTON COUNTY COMMISSIONER CHRIS GARDNER, SAY HE'S OVER-REACHING HIS POWER.

THE INMATES WERE BUSED TO THE MOUNTAIN VIEW CORRECTIONAL FACILITY IN CHARLESTON. FORMER STAFF AT THE PRISON SAY THE FACILITY WAS NOT NOTIFIED OF THE MOVE. THE PRISON WAS SLATED TO CLOSE IN JUNE, BUT A BILL WORKING ITS WAY THROUGH THE LEGISLATURE WOULD FUND THE FACILITY THROUGH NEXT YEAR. DECF REACTION 2 2/12 PA

GOVERNOR PAUL LEPAGE HAS AGAIN MOVED TO EMPTY DOWNEAST CORRECTIONAL FACILITY AS LAWMAKERS DEBATE THE FACILITY'S FUTURE. 51 PRISON STAFFERS WERE PLACED ON ADMINISTRATIVE LEAVE AND RECEIVED LAYOFF NOTICES EFFECTIVE MARCH 2ND. EARLY FRIDAY MORNING STATE POLICE HELPED TO TRANSFER THE INMATES TO MOUNTAIN VIEW CORRECTIONAL FACILITY IN CHARLESTON. FORMER-WORKERS SAY THEIR FUTURES ARE NOW IN THE AIR. KEVIN MILLAY SPOKE WITH TV5.

THE FACILITY WAS DUE TO CLOSE IN JUNE, UNLESS FUNDING WAS APPROVED. A BILL TO PROVIDE THAT FUNDING IS CURRENTLY MAKING ITS WAY THROUGH THE STATE HOUSE.

MORE THAN 50 WORKERS AT DOWNEAST CORRECTIONAL FACILITY GOT LAYOFF NOTICES EARLY FRIDAY MORNING. WORKERS FROM THE DOWNEAST CORRECTIONAL FACILITY IN MACHIASPORT WERE IN AUGUSTA ON TUESDAY TO SPEAK WITH LAWMAKERS FOLLOWING THE PRISON'S CLOSURE ON FRIDAY. FOR A REGION THAT LOSES MANY YOUNGER RESIDENTS DUE TO LACK OF EMPLOYMENT OPPORTUNITIES, THE SUDDEN CLOSURE LEAVES SINGLE DAD OF TWO JOEL HOLMES WORRIED AFTER BUYING A HOME JUST TWO YEARS AGO. HE SPOKE WITH TV5.

A PENDING BILL TO KEEP THE FACILITY OPEN WAS VOTED ON AND SUPPORTED LAST WEEK AND IS EXPECTED TO BE TAKEN UP AGAIN LATER THIS WEEK.

MORE THAN 50 STAFF MEMBERS OF THE DOWNEAST CORRECTIONAL FACILITY ARE WITHOUT JOBS IN MAINE'S MOST ECONOMICALLY-CHALLENGED COUNTY. GOVERNOR PAUL LEPAGE'S DECISION TO SHUT DOWN THE PRISON WITHOUT WARNING HAS LEFT THOSE WORKERS CONFUSED AND ANGRY. LIKE CLOCKWORK, EACH WINTER WE DEAL WITH THE FLU. BUT THIS YEAR IS OF PARTICULAR CONCERN, BOTH IN THE NUMBER OF CASES OF INFLUENZA AS WELL AS ITS SEVERITY. THE LATEST REPORT FROM THE MAINE CENTER FOR DISEASE CONTROL AND PREVENTION SHOW CLOSE TO 1,200 PEOPLE TESTING POSITIVE FOR THE FLU SO FAR THIS SEASON. OF THOSE, 21 CASES RESULTED IN DEATH. DR. FELICITY HOMSTED, CHIEF PHARMACY OFFICER FOR PENOBSCOT COMMUNITY HEALTH CARE, SPOKE WITH TV5.

IF YOU THINK YOU HAVE THE FLU, HOMSTED SAYS GET TO A DOCTOR RIGHT AWAY. THEY CAN PRESCRIBE TAMIFLU WITHIN THE FIRST 24 TO 48 HOURS TO HELP REDUCE THE SEVERITY OF THE ILLNESS. THAT'S ALSO THE CASE FOR PEOPLE EXPOSED TO PATIENTS WITH INFLUENZA. FLU CASES 2/8 PA

MAINE SAW A RISE IN THE NUMBER OF FLU CASES AND HOSPITALIZATIONS LAST WEEK. THE STATE HAD 876 NEW CASES OF INFLUENZA, WHICH WAS A RISE OF MORE THAN 60 PERCENT FROM THE PREVIOUS WEEK. THE MAINE CENTER FOR DISEASE CONTROL AND PREVENTION SAYS THIS FLU SEASON'S TOTAL IS CLOSE TO 3,300, INCLUDING 667 HOSPITALIZATIONS AND 34 DEATHS. ACCORDING TO THE PRESS HERALD, THIS FLU SEASON, WHICH IS REACHING ITS PEAK RIGHT NOW, IS WORSE THAN LAST YEAR AT THIS TIME. THE MAINE CDC SAYS IT'S NOT TOO LATE TO GET A FLU SHOT. FLU DEATHS 2/2 PA

28 MAINERS HAVE DIED FROM THE FLU THIS SEASON, FOLLOWING FOUR DEATHS LAST WEEK. THE MAINE CENTER FOR DISEASE CONTROL RELEASED THE FLU REPORT WEDNESDAY. ACCORDING TO THE AGENCY, THERE HAVE BEEN 2,307 INFLUENZA CASES IN THE STATE THIS YEAR. THERE HAVEN'T BEEN ANY PEDIATRIC INFLUENZA DEATHS. UNIVERSITY OF NEW ENGLAND'S CLINICAL AFFAIRS VICE PRESIDENT DR. DORA ANNE MILLS SAYS MAINE HASN'T SEEN AN OUTBREAK AS SEVERE AS THE REST OF THE COUNTRY. HOWEVER, MILLS WARNS THAT THE SPREAD IS "HEATING UP." PUBLIC HEALTH EXPERTS SAY PEOPLE SHOULD WASH THEIR HANDS OFTEN TO AVOID CONTACTING OR SPREADING THE FLU. EXPERTS SAY IF YOU'RE EXPERIENCING SYMPTOMS TO CONTACT A DOCTOR. FLU PRECAUTIONS 2/19 PA

THE FLU IS CONSIDERED WIDESPREAD IN MAINE AND HOSPITAL OFFICIALS AT EASTERN MAINE MEDICAL CENTER IN BANGOR ARE IMPLEMENTING TEMPORARY MEASURES IN AN EFFORT TO REDUCE THE RISK OF SPREADING IT EVEN MORE. BEGINNING ON TUESDAY, THEY'LL LIMIT VISITORS TO TWO PATIENTS AT A TIME ANYWHERE IN THE HOSPITAL. THE MINIMUM VISITOR AGE WILL BE 12 YEARS OLD. ACCESS TO PATIENTS EXHIBITING FLU-LIKE SYMPTOMS WILL BE LIMITED. AND THE PUBLIC WILL BE DIRECTED TO SPECIFIC ENTRANCES WHERE SCREENING FOR FLU-LIKE SYMPTOMS WILL TAKE PLACE. SENIOR V-P DR. JAMES JARVIS SAYS THE TEMPORARY MEASURES WILL CREATE SOME CHALLENGES FOR VISITORS AND MAY CAUSE A BIT OF INCONVENIENCE, BUT E-M-M-C BELIEVES THE PRECAUTIONS ARE NECESSARY TO PROTECT THEIR PATIENTS, STAFF, AND THE PUBLIC. FLU SEASON 1/3 PA

WHILE DATA SHOWS LOWER SEASONAL FLU CASES IN MAINE COMPARED TO OTHER STATES, THE STRAIN THAT IS CIRCULATING IS MORE SEVERE AND LEADING TO MORE HOSPITALIZATIONS. THE STATE CENTER FOR DISEASE CONTROL AND PREVENTION HAS REPORTED 373 FLU CASES THROUGH DECEMBER 23RD, WITH 99 REQUIRING HOSPITALIZATION. STATE EPIDEMIOLOGIST DR. SIIRI BENNETT TELLS THE PORTLAND PRESS HERALD 80 TO 90 PERCENT OF CASES THIS YEAR ARE INFLUENZA A, WHICH HE SAYS IS MORE LIKELY TO CAUSE DEATHS AMONG ADULTS OVER 65 AND YOUNG CHILDREN. FLU SEASON LASTS FROM OCTOBER TO MAY. BENNETT SAYS IT'S STILL TOO SOON TO PREDICT WHAT THE SEASON WILL BE LIKE. THE MAINE DEPARTMENT OF EDUCATION, THE MAINE OFFICE OF INFORMATION TECHNOLOGY, AND GOVERNOR PAUL LEPAGE ARE BACKING A NEW PROGRAM TO GET HIGH SCHOOL GIRLS INTERESTED IN CYBERSECURITY. "CYBER START" WAS CREATED BY A NATIONAL COMPANY AND WAS FIRST PILOTED LAST SUMMER. ONLY 5 PERCENT OF THE 3,500 PARTICIPANTS WERE GIRLS. THAT PROMPTED CREATION OF THE "GIRLS GO CYBER START" PROGRAM DESIGNED FOR HIGH SCHOOL GIRLS. MAINE STUDENTS WHO PARTICIPATE IN THE PROGRAM WILL BE DOING SO ALONGSIDE STUDENTS FROM MORE THAN A DOZEN OTHER STATES. "GIRLS GO CYBER START" USES ONLINE GAMES OF DISCOVERY TO INTRODUCE HIGH SCHOOL GIRLS TO THE FIELD, WHICH IS POISED FOR JOB GROWTH IN COMING YEARS. BUSINESS OWNERS IN HALLOWELL SAY THEY'RE CONCERNED ABOUT AN UPCOMING CONSTRUCTION PROJECT THAT COULD HAMPER THEIR BUSINESSES. THE STATE DEPARTMENT OF TRANSPORTATION'S RECONSTRUCTION OF THE CITY'S HISTORIC DOWNTOWN BEGINS IN APRIL, AND CONTRACTORS WILL WORK FULL-TIME THROUGHOUT THE WORK WEEK UNTIL THE EXPECTED COMPLETION DATE IN OCTOBER. BUSINESS OWNERS IN THE IMPACTED AREA SAY THEY HOPE PEOPLE CONTINUE TO VISIT DESPITE EXPECTED TRAFFIC AND PARKING ISSUES. ANDREW SILSBY, THE C-E-O OF KENNEBEC SAVINGS BANK, SAYS BUSINESSES SHOULD PLAN FOR A 25 PERCENT LOSS IN SALES. THE D-O-T WILL HOST AN OPEN HOUSE AT 5:30 WEDNESDAY NIGHT AT HALLOWELL CITY HALL TO DISCUSS FINAL PLANS. TWO LAWS AIMED AT LOWERING HEALTH CARE COSTS ARE COMING INTO EFFECT IN THE NEW YEAR. STARTING YESTERDAY, MAINE HEALTH INSURANCE CARRIERS MUST ALLOW ENROLLEES TO GET COST AND QUALITY DATA FOR COMPARABLE HEALTH CARE SERVICES THROUGH A WEBSITE AND TOLL-FREE TELEPHONE NUMBER. CARRIERS CAN SATISFY THAT REQUIREMENT BY DIRECTING ENROLLEES TO THE MAINE HEALTH DATA ORGANIZATION WEBSITE. ALSO, CARRIERS CAN NO LONGER DENY PAYMENT FOR A COVERED HEALTH CARE SERVICE JUST BECAUSE AN OUT-OF-NETWORK PROVIDER MADE THE REFERRAL. ANOTHER NEW LAW IS AIMED AT UNEXPECTED MEDICAL BILLS. MAINERS WHO LOST HEALTH CARE COVERAGE WHEN HEALTH INSURER ANTHEM STOPPED SELLING PLANS THROUGH THE FEDERAL MARKETPLACE CAN STILL PURCHASE A NEW PLAN. LEGISLATION WAS PASSED IN 2016 TO ALLOW THE DRUG TO BE GIVEN OUT BY PHARMACISTS WITHOUT A DOCTOR'S PRESCRIPTION, BUT THE BILL HAD AN ERROR. IT TOOK A YEAR FOR THE CORRECTION TO BE MADE. THEN THE RULES STALLED ON GOVERNOR PAUL LEPAGE'S DESK AFTER BEING SENT TO HIM LAST YEAR. LEPAGE'S SENIOR POLICY ADVISOR SIGNED OFF ON THE RULES THURSDAY AFTER THE AGE-CHANGE.

JOE BRUNO, CHAIR OF THE MAINE BOARD OF PHARMACY TELLS TV5 THE RULES NOW HEAD TO THE SECRETARY OF STATE'S OFFICE, THEN ARE SUBJECT TO A PUBLIC COMMENT PERIOD BEFORE MAKING IT TO THE ATTORNEY GENERAL'S DESK.

BRUNO SAYS IF THE RULES GO INTO EFFECT, THOSE BUYING NALOXONE WOULD STILL NEED A PRESCRIPTION TO DO SO, BUT A PHARMACIST ON SITE WILL HAVE PRESCRIPTIVE AUTHORITY TO DISPERSE THE DRUG. NALOXONE RULES 2 2/2 PA

A STATE LAW, MAKING AN OVERDOSE-REVERSING DRUG AVAILABLE WITHOUT A PRESCRIPTION, IS BECOMING REALITY DUE TO A COMPROMISE BETWEEN THE MAINE BOARD OF PHARMACY AND GOVERNOR PAUL LEPAGE. THE GOVERNOR'S SENIOR POLICY ADVISOR SIGNED OFF ON THE RULES THURSDAY AFTER THE BOARD LIFTED THE AGE LIMIT TO OBTAIN NALOXONE. EARLIER THIS WEEK, LEPAGE SAID THE AGE LIMIT SHOULD BE LIFTED FROM 18 TO 21, THE SAME AS THE NEW LIMIT FOR TOBACCO PURCHASES. LAWMAKERS APPROVED THE BILL IN 2016 BUT IT HAD BEEN IN RULE-MAKING LIMBO ON THE GOVERNOR'S DESK SINCE LAST YEAR. PHIL BARTLETT, CHAIRMAN OF THE MAINE DEMOCRATIC PARTY, TELLS TV5 HIS COLLEAGUES HAVE BEEN FRUSTRATED BY THE ADMINISTRATION'S STALLING OF THE RULES.

THE LAW AUTHORIZES GROUPS WORKING WITH DRUG USERS TO ESTABLISH OVERDOSE PREVENTION PROGRAMS, WHICH COULD GIVE AWAY NALOXONE AND TRAIN PEOPLE TO USE IT. A MOVE TO MAKE THE OVERDOSE ANTIDOTE NARCAN AVAILABLE TO MAINERS WITHOUT A PRESCRIPTION IS STALLED ON THE GOVERNOR'S DESK. A SPOKESWOMAN FOR GOVERNOR LEPAGE SAYS THE RULES ARE "PENDING" AND WILL NOT GIVE A TIMELINE FOR WHEN HE WILL ACT ON THEM. THE STATE BOARD OF PHARMACY SENT THE RULES TO THE GOVERNOR'S OFFICE IN AUGUST. THE GOVERNOR HAS VOICED HIS OPPOSITION TO MAKING NARCAN MORE WIDELY AVAILABLE. HOUSE SPEAKER SARA GIDEON SPOKE WITH TV5. SHE SAYS THE GOVERNOR SHOULD DO HIS JOB.

LAWMAKERS TOOK EIGHT MONTHS TO PASS THE BILL THAT CREATED THE NEW RULES.

A LAW PASSED LAST YEAR WOULD LET PHARMACISTS SELL THE NARCAN WITHOUT A PRESCRIPTION, BUT RULES IMPLEMENTING THE LAW REMAIN TIED UP WITH THE GOVERNOR. THEY SAY THE TRACK'S NEW OWNERSHIP WON'T IMPACT SCARBOROUGH'S CURRENT PROPOSAL TO HOST A SECOND HEADQUARTERS FOR AMAZON.COM. OFFICIALS PLAN TO DISCUSS THE PROJECT AT A PLANNING BOARD MEETING MONDAY.

A FEDERAL JUDGE HAS ORDERED THE LEPAGE ADMINISTRATION TO RELEASE MILLIONS OF DOLLARS IN FEDERAL FUNDING FOR JOB TRAINING. IN A RULING WEDNESDAY, THE JUDGE SAYS THE GOVERNOR IS REQUIRED TO RELEASE THE MONEY BY LAW. THE JUDGE ALSO RULED THAT HOLDING THE FUNDS COULD CAUSE "IRREPARABLE HARM" TO COASTAL COUNTIES WORKFORCE INC. COASTAL COUNTIES, A BRUNSWICK-BASED NONPROFIT ORGANIZATION, FILED A LAWSUIT AGAINST LEPAGE IN OCTOBER FOR \$3 MILLION IN FUNDING PROVIDED THROUGH THE WORKFORCE INNOVATION AND OPPORTUNITY ACT. THE PROGRAM SENDS ABOUT \$9 MILLION TO THE STATE EVERY YEAR. LEPAGE HAS PREVIOUSLY CALLED THE PROGRAM WASTEFUL AND WANTED TO ORGANIZE THE THREE REGIONAL BOARDS RECEIVING THE MONEY INTO A SINGLE STATEWIDE BODY. LEPAGE HAS DECLINED TO COMMENT ON THE RULING.
