

**ISSUES and PROGRAMS

Issues covered include: family relationships, race relations, women's issues, health, community ventures and co-ops; teenage issues; as well as finances, adult education, substance abuse – prevention – recovery; soup kitchens, homeless ministries, and help for impoverished people. This program has proven to be an ideal opportunity to help and minister to the lonely, hurting, distressed and struggling.

"You & Me" is not scripted and therefore has no specified format so it isn't possible to include a rundown or analysis of each program for this report. There are numerous other categories covered that are not mentioned here due to the fact that the host often selects a specific theme for the night.
