### Instructions for Broadcast of Post-Filing Public Announcements In Connection with License Renewal

As you know, license renewal applications for stations in DC/MD/VA are due to be filed with the FCC by June 1, 2011. The FCC's Rules require stations to broadcast announcements about the renewal application beginning on the date the renewal application is filed, and five more times during the three months following the filing.

The text of this post-filing announcement is enclosed with this memo. Set forth below are the dates and times during which the announcement should be broadcast -- once on each of the specified dates during the indicated time slots:

<i>Wed</i> June 1, 2011	7:00 p.m. – midnight
<i>Thu</i> June 16, 2011	7:00 a.m. -- 9:00 a.m. [OR 4:00 p.m. – 6:00 p.m.]
<i>Fri</i> July 1, 2011	7:00 a.m. – 9:00 a.m. [OR 4:00 p.m. – 6:00 p.m.]
<i>Sat</i> July 16, 2011	7:00 a.m. – 9:00 a.m. [OR 4:00 p.m. – 6:00 p.m.]
<i>Mon</i> August 1, 2011	9:00 a.m. – noon
<i>Tue</i> August 16, 2011	Noon – 4:00 p.m.

The FCC's rules require that the licensee place in the station's public inspection file, within seven days of broadcasting the last post-filing announcement, a statement certifying the times that the announcements were made. Enclosed is a "Certification of Broadcast of Post-Filing Announcements in Connection with License Renewal Application" for your station. Please record on it the actual times that the announcement was broadcast on the required dates. Then forward a copy of the certification to me and place the original in the station's public inspection file by **August 23, 2011**.
