Unused ITINS PKG

Description of Program:

One of the main requirements to request a driver's license for people without documentation in Colorado is to count with an ITIN number. If you are part of the millions of people who have not used your ITIN number to declare federal taxes for five consecutive years, you may be in danger of it being deactivated, according to a recent press release by the department of Internal Revenue. In order for all interested people to have time to make changes and allow the IRS to reprogram their systems. The agency will not start to disable the ITINS until the year 2016, however it is crucial to prepare so that this change does not catch you off guard.

DMV Latest on Driver's License PKG

Description of Program:

The department of motor vehicles announced that those immigrants with temporary legal permission in the United States will be able to request a driver's license in any of its offices without a prior appointment. This has raised many concerns in our community. Lawyer Shawn Meade states, "This includes many temporary visas, for example the student visa F1, the work visa H2B, H2A, H1B. There are many work visas and most of these allow you to obtain a license because they are used in the state with a valid and legal status." There are two types of immigrants that will be able to obtain their license and facilitate their proceedings for this document in Colorado. According to authorities the new five offices opened by the department of motor vehicles, will be for undocumented immigrants only.

Description of Program:

The controversy continues for the residents of the shooting that ended the life of the young Ryan Ronquillo on Wednesday July 2nd in front of the Romero Funeral Home. After the police intervened him and ended with his death, according to witnesses by several bullets he received. This afternoon, at a community meeting where the mayor of Denver, Michael Hancock and representatives of the Police Department participated, not only family members but the community in general raised their opinions with respect to the conduct of its agents in this case. "We as a community don't trust the police, we have lost trust, they proceeded incorrectly, and they endangered the lives of the people that were in the funeral home. Why did they shoot? They could have simply arrested him and that's it, but they shot, and they have not been dismissed, are not sanctioned, and not even disciplined," Said Shante Gomez a witness at the scene.

Co. Judge Strikes Down State's Gay Marriage PKG

After the demand brought by the General Attorney of Colorado John Sutters to Boulder County by issuing licenses for same-sex couples marriages, the legal battle was analyzed today in a local court of the district. A judge from the county of Adams, Scott Crabtree, declared that the prohibition of Colorado about marriage between partners of the same sex violates the equal protection clause of the Constitution of the United States and said to be in accordance with 23 other federal courts who so far have come to the same conclusion about such ban in other states. Crabtree said that this ban "Is no more than an excuse for discrimination against same-sex marriages."

Dozens of same-sex couples, their families and community leaders met today at the Judicial Center Ralph L. Carr so that for once and for all, General Attorney John Suthers stops intervening. This appeal could tie the hands of personnel in courts for months delaying the freedom to join together in marriage thousands of couples throughout the state.

The National Association for the Protection of Civil Rights, A.C.L.U, together with pro immigrant organizations and groups of immigration lawyers have filed a lawsuit against the federal government for failing to provide legal defense optimum for minors who have to be brought before an immigration judge, especially after the crisis in the border of Mexico. Plaintiffs claim that the minors have no ability to perform trials with maturity and have no knowledge or experience to understand the world around them. Bringing them before a judge without any legal representation is unfair.

More details about the announcement that the county of Denver has requested 12 million dollars to take care of approximately a thousand eight hundred children of the border during three years have been revealed. The minors will live an average of one month in a hostel called Family Crisis Center in spite of the fact that organizations like the Tea Party Patriots of Colorado have spoken against this measure because of the spending of tax dollars that the almost one hundred thousand undocumented that will come to the country at the end of this year will generate. Also, the Denver Health Hospital, organization of Lutheran social services and Ariel Clinical Services have requested approval for this purpose. 220 Central American children have already been sent to Colorado to live with relatives, according to the department of health and human services.

Children return to school and so do transit police. Authorities of Aurora indicated that there will be a strict control of the speed limits in school zones. "We will have several agents patrolling school zones to punish those who do not respect the speed limits. We do it to provide security for students and young people," stated Jeff turner Aurora Police. But in Aurora we are studying the possibility of having a radar van that would be placed in nine schools around the area so if a driver does not respect the speed limit in a school zone, through photographic evidence taken by the van, they will be fined. This technology would approximately the city 110 thousand dollars including the pay of the personnel who would work in this detecting system of speeds but it will generate about 256 million dollars in fines.

Immigrants are the economic force that sustains Medicare, says a study of the New American Economy, a pro-immigrant organization. In which was published in the blog of the prestigious daily newspaper “The Washington Post” and recognized by the most prestigious economists in the United States. The numbers are skyrocketing; immigrants have contributed about 183 billion dollars between 1996 and 2011. This is considered a positive push to Medicare since they have put money they have not used meanwhile people born in the United States have done the opposite. In numbers accounted for by people, you may say that an immigrant contributes to the Medicare fund 62 dollars more per individual than a citizen born in the United States and consumes 172 dollars less in benefits.

Did you know that more than 50 million people in the country use food stamps and 83 million benefit from the health program names Medicaid? New information from the Census revealed that almost 110 million people are living on public assistance, including housing grants, food-aid programs, and Medicaid. According to the Institute CATO, in eight of the most generous states the aid benefits surpass the average minimum wage of 7 dollars and 25 cents. Now that people receive help equivalent to a salary of 20 dollars an hour. For many, this aid is crucial for survival.

The Internal Revenue Service (IRS) and the General Treasury Inspector for tax administration known for its acronym in English TIGTA continue hearing that taxpayers are receiving unsolicited phone calls of individuals demanding payment indicating that they are representatives of the IRS. There have been 90,000 complaints that TIGTA has received on behalf of their direct phone line. Until this day, the general treasury inspector for the administration has identified approximately 1,100 victims who have lost an estimated five million dollars from these frauds.

DL Letter to Governor

Almost half of those who had an appointment for a license were not able to obtain it. Today activists asked democrats and the governor to fix the situation and inclusive warned the Chief Executive of the State to be careful because he might lose the Latino vote. Through a letter, activists of Licenses for All asked Governor Hickenlooper to immediately fix the difficulties faced by undocumented applicants to obtain their driver's licenses. The protests did not wait in the offices of the Democratic Party of Colorado and also in the Capital, inclusive they politically threatened Governor Hickenlooper saying that if he did not listen and answer to their petitions the Latino vote would sanction him in the elections of November.

The transit center and the remodeling of the Union Station was of 500 billion dollars and opened the 26th of July and was remodeled after a job of four years. It is hoped it will serve 15,000 passengers each day increasing to 200,000 passengers each day in 2030. Julie Reiskin, of the organization for the disabled people in Colorado showed us the letter they sent to the people in charge of the construction of the area saying that there is no direct access for the disabled in the remodeled Union Station. Today the organizations of the disabled in Colorado have filed a law suit against the Regional Transportation Department.

Co Shooting Lawsuit PKG

Description of Program:

The parents of Jessica Ghawi expect that the stores that sold lethal weapons and military equipment to James Holmes, reform their practices when it comes to selling their merchandise, according to them to prevent tragedies like these. Two years after the massacre in the theater of Aurora where James Holmes entered and killed 12 people and injured 58 others, the parents of the young Jessica Ghawi who died in the shooting, have filed a lawsuit against the online shops that sold him the ammunition, anti-bullet vests, and tear-gas that he used during his cold blood attack. The lawsuit announced today by Brady Center to prevent gun violence and Arnold and Porter LLP, argued that the stores Lucky Gunner, The Sport's Guide, Bullet Proff Armor.com and BTP Arms negligently sold more than 4 thousand rounds of ammunition, 100 high capacity porters, anti-bullet clothing, and 2 containers of tear-gas to James Holmes by internet. Edgar Antillon the leader of the organization that promotes freedom of arms said that this lawsuit will not change anything.

DOG SHOT BY COPS Retract PKG

What started as an arrest of a young adult of sixteen years ended in the death of a Rottweiler. According to Denver Police, the young adult ordered his dog to attack a police during the arrest intent yesterday night so that he could escape and not be arrested. The incident happened close to 7:30 pm on 920 Sheridan Boulevard. Animal control arrived on scene to bring the dog treatment. Police informed that the dog was still alive after receiving the shots and according to witnesses that where at the scene, they heard five gun shots and were able to observe the dog being transported in a bed and still moving. Police announced this morning that the dog of two years passed away.

These are the 17 people who, according to authorities were arrested and face 64 charges after being accused of drug trafficking. According to the General Attorney Office in “operation cargo” the 17 involved sold methamphetamine and cocaine. Investigations showed that the leader of these operations was Juan Carlos Gonzales who along with others, 9 people of Hispanic origin distributed the drug in the city of Denver; the other 7 arrested were of American origin. But according to authorities, in this taco place they sold more than the popular and Mexican dish, this business El Paisa located on Federal and 8th Avenue was syndicated as the place where methamphetamine was sold by Maria Arellano.
