In the period from April 1, 2013 through June 30, 2013, KJTH/KXTH/KZTH/KTHF/KTHL addressed the following issues of public concern. Numerous public service announcements were made on behalf of various local nonprofit organizations and churches from around the listening areas. We also passed along public information on severe and inclement weather for all of our Oklahoma listening areas & Southern Kansas. On the attached sheets other issues are listed which were broadcast over the program "Focus on the Family". "Focus on the Family" airs each weekday morning at 6:00 and 9:00, and in the evening at 6:00. The station also hosted tours to various school, church, and scouting groups. On April 14th the stations participated in the Great Day of Service in Ponca City. This day was designed to pool the efforts of various churches & community organizations to provide clean-up & rebuilding around the community. On April 27th the stations participated in the Ponca City YMCA's annual Healthy Kids Day & on the 28th we provided music & water to those participating in the Oklahoma City Memorial Marathon. In May the stations provided our listeners with a list of local National Day of Prayer gatherings & one of our DJs spoke at an area school in Wichita. We also participated in the Ponca City Police Department's Take 25 program advocating the importance of safety in all areas of life. On June 13th we hosted our annual Kid DJ Day. We saw over 1,100 kids and adults from over 32 different Oklahoma communities come to our studios in Ponca City. The kids were given the opportunity to talk live on the radio & have fun outside at the various activities.
