**INFORMAL OBJECTION**

Goodrich Quality Theaters, Inc. ("GQTI"), by its attorneys, hereby lodges this Informal Objection to the above-referenced application for renewal of the license of Television Station KMIZ, Columbia, Missouri.

GQTI is the owner and operator of a multi-screen movie theater, known as the Capitol 8, in Jefferson City, Missouri. For purposes of an Informal Objection, it is not necessary for the objector to demonstrate standing.<sup>1</sup>

On May 9, 2013, Station KMIZ broadcast a news program titled "ABC 17 News at 6" including a segment which purported to show an event which occurred at the Capitol 8 theater on May 3, 2013. In fact, what was broadcast was not the event it purported to be. Attached hereto as Attachment A is a copy of the relevant portions of a

complaint filed with the FCC by the manager of the Capitol 8 theater dealing with this matter.<sup>2</sup>

The May 3 “event” was actually a promotion for the newly-released “Iron Man 3” film. It consisted of some actors, in costume, and carrying fake weapons, walking across a parking lot and into the theater. The same promotion had also been carried out the day before, on May 2. Apparently some onlooker mistook the promotion for something more sinister and called the police. As noted in the Complaint, a total of three patrol cars, with six officers in total, arrived. The third left almost immediately, and only two officers actually entered the theater. Within two minutes the entire investigation was completed.

What was shown on the KMIZ news program on May 9 was entirely different. The footage shown was stock footage of an earlier SWAT team training exercise. No SWAT team actually appeared on May 3.

As noted in the Complaint, the Station KMIZ News reporter acknowledged that what was broadcast was not the actual May 3 incident, but stock footage. Thus, the station knew that the broadcast was not what it was purported to be, but failed to let the viewing public know of that fact. The false telecast caused severe embarrassment to the theater and friction between GQTI and the management of the shopping center in which the theater is located.

The Complaint to the FCC was summarily rejected, citing Constitutional and statutory prohibitions of censorship. However, censorship was never the issue.

The “event” which was the subject of the news report was a small, and quickly resolved, incident which involved two police officers entering the building, and emerging a few minutes later. What viewers of the news report saw was a full-scale SWAT team



assault upon the building. The issue, therefore, is whether a knowing and deliberate falsification of a news "event" should be condoned by the FCC.<sup>3</sup>

It may well be that the KMIZ broadcast was not in violation of the Communications Act or of the Rules and Regulations. Notwithstanding, it cannot reasonably be considered that such a knowing, deliberate and intentional falsification of a purported news event is operation "in the public interest". Insertion, in a news broadcast, of "stock footage" to convey the impression that the scene was the actual event being reported cannot be done without the knowledge and consent of station or news department management. Even if the station is not subject to a monetary forfeiture, it should certainly be subject to admonishment which will become a part of its record.

Headline: "Movie Theater stunt triggers officers to respond to active shooter situation."

Video footage used of a SWAT team was not depicting the Friday May 3, 2013 circumstances at Capital 8. 17 News reporter Daniel Winn told Bob Wilkins, Capital 8 Manager that the SWAT footage used in his news feature that initially broadcasted on Thursday 5/9/13 was a training sequence of the Jefferson City Police Department. This "stock" SWAT footage had nothing to do with any police presence at the Capital 8. The use of SWAT footage sensationalized Mr. Winn's report. This stock SWAT footage presented a false inference of how the police responded to a call assumed to be from a moviegoer at the Capital 8.

Officers in two patrol cars responded to the 911 call on Friday 5/3/13 who were in the immediate area. A third patrol car arrived after the first two and left almost immediately. There were three cars with six officers total. Only two officers entered the Capital 8 building. The other four officers didn't leave their cars.

The officers checked the theater in less than two minutes.

KMIZ-TV Channel 17 (ABC) Jefferson City, MO's nearly three minute "news" report by means of deliberate news staging deceived all its viewers: those watching live, those seeing it repeated on-air and those who watched it by streaming it online.

This 5/9/13 news report was principally created to make a routine police response sensational. The totally false use of a rifle and then SWAT team footage manipulated the viewers both on-air and those streaming that there were serious dangers at the Capital 8 such that the police had to make an armed and enforced response.


The local (in costume IRON MAN 3) players known as Cosplacon were in the Capital 8 as movie characters for photo opportunities when the police checked the Capital 8. Cosplacon players had been at the Capital 8 in IRON MAN costumes Thursday May 2<sup>nd</sup>. Cosplacon players have frequently been at the Capital 8 dressed in costumes depicting characters of various movies.

A KMIZ-TV General Manager's admission of improper news staging and an apology to the viewers must be provided.

**RESPONSE TO INFORMAL OBJECTION**

NPG of Missouri, LLC, licensee of KMIZ (TV) (hereafter “KMIZ” or “Station”), hereby submits this Response to the “Informal Objection,” dated December 31, 2013 (“Objection”), by Goodrich Quality Theaters, Inc., owner and operator of multi-screen “Capitol 8 Theater,” in Jefferson City, MO<sup>1</sup> (hereafter “Theater”).<sup>2</sup>

Not only does the Theater’s pleading contain factual errors, it lacks any substantive basis for the FCC even to delay the grant of KMIZ’s pending license renewal application -- much less, as the Theater asks, for the FCC to “admonish” the Station.<sup>3</sup>

Indeed, it challenges one’s memory to recall *any* Objection, ever filed against *any* TV station’s license renewal in the FCC’s eight-decade history, that is based on a more bizarre, perverse and disquieting factual record than is revealed in this matter. In short, this Objection

involves an incendiary May 3, 2013 publicity stunt whereby the Theater hired costumed and (fake) weapon-carrying actors to stage a simulated armed attack on the Theater's premises, where the movie "IRON MAN 3" was opening.<sup>4</sup> Thus, this outrageous stunt, which triggered an immediate emergency response by six local police officers to what they were told was an "active shooter situation," reasonably appeared to be yet another gun incident at an American movie theater.<sup>5</sup> The Theater's staged armed attack was instantly and roundly condemned by theater patrons, local citizens and local police.<sup>6</sup>

In such circumstances, what is the basis for the "Objection" filed last month by the Theater against KMIZ's license renewal with respect to the horrific stunt that the Theater itself had perpetrated? It is, namely, an assertion that KMIZ's coverage of this outrageous stunt, on KMIZ's May 9, 2013 "ABC17 News at 6,"<sup>7</sup> contained video footage that was misleading!<sup>8</sup>

While the Theater asserts that KMIZ's usage of "stock footage"<sup>9</sup> constituted a falsification of a *purported news event*,<sup>10</sup> the facts are otherwise. First, although other contemporaneous broadcasts of this news story (after KMIZ's newscast at 6PM on May 9, 2013) did contain the local police video to which the Theater objects,<sup>11</sup> the local police video used in those other KMIZ broadcasts was NOT "stock footage" as that term is commonly used by local TV news departments;<sup>12</sup> rather, it was contemporaneous video featuring the *same local police force* that did, in fact, respond to the Theater's stunt on May 3, 2013. See Appendix A. Indeed, the video



was of the *local police force's* subsequent training exercise—only one week *after* the Theater's staged armed attack--about which local police had advised KMIZ *in advance* was being held on May 9, 2013, to train for any future shooting incident at a local theater; in fact, local police had expressly invited KMIZ to record video of this training exercise if the Station desired. *Id.* In sum, and even assuming that the subject "ABC 17 News at 6" broadcast on May 9, 2013 had contained the subject "footage" about which the Theater complains, KMIZ's brief use of contemporaneous video of the local police force responding to a shooting incident does not constitute a "deliberate falsification of a *purported* news event," as alleged by the Theater.<sup>13</sup>

#### CONCLUSION

In such bizarre and disquieting circumstances as are presented in this unusual case, it is decisively noteworthy that the Objection expressly concedes that the subject KMIZ broadcast<sup>14</sup> may NOT be "in violation of the Communications Act or the [FCC's] Rules and Regulations."<sup>15</sup> Indeed, the Objection should be summarily dismissed or denied.<sup>16</sup>



Sworn Statement of Gene Steinberg

My name is Gene Steinberg, a resident of Columbia, Missouri, and I am the General Manager of the "The Networks of Mid-Missouri," which include KMIZ (TV) (ABC) and KQFX-LD (FOX), Columbia, MO. I have read the "Informal Objection," dated December 31, 2013 ("Objection"), filed with the Federal Communications Commission ("FCC") by Goodrich Quality Theaters, Inc., owner and operator of a multi-screen movie theater described as Theater as "Capitol 8" [sic] in Jefferson City, MO ("Theater").

1. The Theater at issue is actually named "*Capital 8 Theater*," emphasis added.
2. The May 9, 2013 newscast on KMIZ (TV) at 6PM -- "ABC 17 news at 6" -- did not, in fact, feature any "video of the local police training" as asserted by the Objection. In fact, that video was taken *subsequent* to the May 3, 2013 faked attack. Indeed, KMIZ was alerted by local police officer Shoemaker on May 9, 2013, that a training exercise—would be held that day and that KMIZ could take video of that local police SWAT Team training for any future *actual* attack.
3. The video that is the subject of the Objection—which was used in *other* newscasts on KMIZ (TV) at other times and on other days—was not "stock footage," as alleged in the Objection. Rather, the video was of the *same local police force* that responded to the Theater's May 3, 2013 faked but realistic armed attack on the Capital 8 Theater. The Objection also inaccurately states that the video was from "an *earlier* SWAT team training exercise" by the local police when, in fact, the video of the local police was from a training exercise *after* the Theater's staged, May 3, 2013 armed attack. In such circumstances, the video at issue was not only contemporaneous with the Theater's outrageous stunt just the week before but also was video of the same police force that actually did respond to the Theater's May 3, 2013 faked armed attack on the Theater. In my 20 plus years in broadcasting, such video cannot fairly be described as "stock footage. It was contemporaneous video of the kind that often is used by TV news departments. Going forward, however, I have instructed the news staff of the Networks of Mid-Missouri to always caption such relevant, contemporaneous video as either previously or subsequently recorded.
4. Neither KMIZ nor I as General Manager have ever received a copy of any Complaint filed by the Theater at the FCC.


