These should be coded as LOCAL DIRECT POLITICAL ISSUE spots, 5x/day 30s spots ON EVERY CUMULUS STATION, Mon-Sun (not auto-weekly) 5a-Midnight full rotation, fully pre-emptible without notice P90, **starting this Wednesday March 30 and running through September 6. It is a no-charge order.**

This order WILL NOT impact your LUR given the broad rotation; also the FCC confirmed that this issue order on behalf of the industry should not be considered in setting your LUR for other political orders.

The link to the request to air to the broadcasters (which you can use in lieu of an insertion order for your records), downloadable spot creative, and the NAB's NAB form is below. I posted the NAB's NAB form last week as well.

Good morning. The NAB has asked that we extend their Performance Tax spots through the end of September because despite hitting the milestone of a majority of support in the House of Representatives opposing new performance taxes, it's still possible that the Judiciary Committee could hold a markup on the American Music Fairness Act and the Senate could introduce a companion bill. So please extend your current orders - which were set to expire on 9/6 - through 9/30. This applies to ALL CUMULUS STATIONS. As a reminder, these are considered political orders, but do not impact LUR. You will need to upload all relevant info as a revision onto your station FCC sites. See original link below to a post from earlier in the year that has full instructions and details. As before, you can follow the external link in the earlier post to the NAB site for the NAB form and spot creative, and you can take a screen shot of that external NAB page for your audit records as a proxy for an insertion order.
