3 April 2013 Bonding/changes JY (ATC/ME)

The House Appropriations committee this week removed all of the projects in the bonding bill and replaced them with two tribal water rights compacts.

Democratic Representative Galen Hollenbaugh is the sponsor of House Bill 14. He says that action keeps House Bill 14 alive as a back-up.

HOLLENBAUGH: cash is pretty much the way it seems like its going to be going and it looks like our EFB will most likely be able to accommodate most of those buildings so we can pay in cash. Ther'es still a lot to be doe on HB 2 – the state budget – and many other bills that are still floating around so we really don't have a good picture about how much cash we have so we need the option to be able to move a few of those projects back into bonding if it indeed don't have the cash at the end of the day (:28)

Most of the projects to be bonded were for the Montana University system. This includes new buildings for Missoula College and a new science building at MSU-Billings.

Last week, all of the projects were moved from House Bill 14 to House Bill 5. The later is known as the long-range building bill that pays for water and bridge projects with cash.

The amended House Bill 5 passed the House on a 72-to-27 final vote and now will be considered by the Senate.

The House, meanwhile, will take up the newly amended bonding bill – House Bill 14 – tomorrow (today).

On a basically 23-to-26 party-line vote, the Senate rejected former Congressman Pat Wiliams for the Montana Board of Regents.

Supporters urged colleagues to look past Williams' recent controversial remarks referring to "thugs" do describe some athletes at the University of Montana... and instead focus on his qualification. But opponents said those comments reveal a lot about the nominee.

8 April 2013 House blast/SB 107 – deviant sex law JY

The House tomorrow (today) will debate a bill that de-criminalizes gay sex between consenting adults.

On a 60-to-38 vote, Representatives voted to take Senate Bill 107 from the table in the House Judiciary Committee and to the floor for debate.

10 April 2013 H Final approval/SB 107 JY (ATC/ME)

A bill that officially seeks to remove an unconstitutional law from the books now goes to the governor for consideration.

That law says gay sex is a felony punishable by up to 10 years in prison and a fine of up to 50-thousand dollars.

The Montana House gave final approval today (yesterday) to Senate Bill 107 on a bipartisan 65-34 vote.

In reality, a unanimous Montana Supreme Court declared the law unconstitutional in 1997.

It stems from a case where Linda Gryczan (gr-eye-san) of Helena was the lead plaintiff in a case challenging the law.

But even with the legal victory, the language remained on the books, despite numerous attempts to have it removed.

Gryczan says she was overcome with emotion when Representatives gave preliminary approval to the bill Tuesday.

GRYCZAN: because it's a symbol, and I didn't realize until 64 lawmakers said 'yes' what a powerful symbol it is. And removing unconstitutional words from the book that's not the real change that happened. The real change that happened was the cultural change from the collective work that's been done over the last decade here and elsewhere that has created the culture that allows this to happen. (:28)

She says the next challenge will be to protect the Lesbian-Gay-Bisexual-and-Transgender community from discrimination.

First, Senate President Jeff Essmann defends Senate Bill 405, followed by Senator Larry Jent speaking against.

When Democrats were unsuccessful in defeating those two bills, they renewed efforts the next day. Their attempt at a procedural move led to this:

On Monday, the Senate Rules Committee met and on a series of party-line votes declared its actions Friday were proper.

Leading Senator Greg Jergeson to ask the members to drop any further recriminations and get back to work.

(TAPE: "we need to put aside any further circular firing squads...what went on last Friday and commit ourselves to working the way ... we can pick ourselves up and dust ourselves off and get back to work.")

Getting back to work and what that means for the major pieces of legislation before the Senate was the question put to the Senate leaders. Both agreed to talk about that yesterday in their offices.
