Section I. Issues

The station has identified the following issues as significant issues facing our community in this quarter:

- A. Crime/Public Safety:** Recent thefts, robberies, drug crimes, and violent crimes affecting the Magic Valley with police seeking the public's help in catching the suspects.
- B. Military:** Information updates about a local soldier and his upcoming military trial and other military and veteran information.
- C. Highway/Utility Repairs:** The status of highway, freeway, and utility repairs and improvements in our areas, including bridges. Utility repairs may affect customers and/or affect traffic patterns.
- D. Traffic Accidents:** Increase number of traffic accidents as the community heads into the summer, including road closures due to accidents, causes, and possible preventions to avoid injury and/or death.
- E. Education:** Issues relating to public school education in our state and community.
- F. Growth/Changes:** Businesses opening, closing, and changing hands in the Magic Valley.
- G. Politics:** Local, state, and national politics affecting the public and voter information for the November election; national politics affecting rights to citizens.
- H. Fish and Game:** Seasonal road closures by Idaho Fish and Game due to migration, fish stocked in local waters, and Fish and Game phone scam warning.
- I. Local Acknowledgement:** Local citizens have made positive impacts in their community.
- J. Medical/Fire/Emergency Services:** Local fire, medical, and emergency service news affecting the public. Such as blood drives, donations, new suicide hotline and more.
- K. Consumer Recalls/Information:** Issues relating to consumer product recalls and other information on products that may affect the community.

Section II. Responsive Programs

The station broadcasts news and public announcements with each of the above-referenced issues. Programming dealing with each issue is set out below.

A. Crime/Public Safety:

News Report October 3, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

A child was injured Friday evening trying to cross Highway 30. According to reports, Idaho State Police say John Busman, of Buhl, was headed west when he struck a child who had entered the crosswalk near Stevens Avenue in Filer. The child was taken to St. Luke's Magic Valley Medical Center. No other information was available at the time of this report.

A group of young men stepped in to prevent Antonio Venegas, of Shoshone, from reportedly kidnapping a former girlfriend Thursday night. Venegas fled the attempted kidnapping after punching a 15-year-old boy but crashed on Highway 26 west of Shoshone and was arrested. Venegas was arraigned Friday in Lincoln County Magistrate Court on a felony count of attempted second degree kidnapping and a misdemeanor count of battery.

Gooding County Sheriff's deputies are warning Magic Valley business owners and seeking the public's help to identify a woman suspected of cashing counterfeit checks using fake identifications. The woman reportedly cashed counterfeit checks three times between Sept. 18th and Sept. 21st at Simerly's Market in Wendell. Two of the checks were written against Wage Works out of Phoenix, Ariz., and the other was written against the Idaho Department of Correction out of Boise.

Police are still looking for a man from a high-speed chase turned foot chase Friday night. According to reports, the man was driving a silver-colored sedan when someone from the Jerome County Sheriff's Office stopped him for a minor traffic violation. He sped off northbound past the high school, eventually turning down a road where he got out and ran. When the man is found he is facing two felony charges of possession of marijuana and methamphetamine, a felony charge for alluding officers, and a misdemeanor for obstruction of justice.

News Report October 4, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Allen Ward, of Burley, who is accused of failing to deliver a load of calves to the Texas company, Primera Beef, or refund the owners, has been charged with two felony counts of grand theft. According to reports, Ward is scheduled for a first appearance in Cassia County Magistrate Court on Oct. 24th. The maximum punishment in Idaho for grand theft is 14 years in prison and a \$5,000 fine.

Jimmy Voss, of Rupert, is being accused with raping a Burley woman who is blind and punching a service dog belonging to another woman. Voss is charged with felony rape and misdemeanor counts of battery along with battery to a disabled person's dog, resisting or obstructing officers and possession of a controlled substance. A court date in the case hasn't been set. Voss is being held at the Mini-Cassia Criminal Justice Center in lieu of \$150,000 bond.

Two Twin Falls schools are taking extra security precautions after Twin Falls police found a possible scary clown threat. According to reports, police notified the schools yesterday that they found a possible threat on social media in the area surrounding Vera C. O'Leary Middle School and Lighthouse Christian School.

Former brand inspector Justin Archer, of Kimberly, who pleaded guilty to stealing from Producer's Livestock earlier this year was sentenced, yesterday to five years of supervised probation, 500 hours

community service and ordered to pay nearly \$5,000 in fines and restitution. His accomplice, Georgina Zamora, was sentenced last month to a suspended five-year prison term, three years of supervised probation, a \$1,000 fine and 100 hours of community service.

News Report October 4, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Cody Walker, of Twin Falls, who allegedly stole money from a safe at the Subway in the Magic Valley Mall, was arraigned in Twin Falls magistrate court yesterday after previously fleeing to California. Walker was charged with felony burglary after reportedly taking about \$540 from the safe on May 15th.

News Report October 5, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Twin Falls County sheriff's deputies used two drones yesterday to track Robert Ferreira, of Buhl, who reportedly fled into a corn field after he and Melissa Bedele, also of Buhl, fled police in a stolen pickup truck. Bedele was arrested on suspicion of eluding and possession of a stolen vehicle. Ferreira is being held on a parole violation, multiple warrants from Jerome and Twin Falls counties and will likely face additional charges stemming from the chase.

News Report October 6, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Police increased patrols around schools Wednesday after someone claiming to be a clown sent online messages to children. The threat had not been validated, but it frightened some students. The messages are similar to other hoax messages received across the country. More than a dozen people have been arrested for clown-related hoaxes in the past several weeks.

Joshua Wurzer, of Twin Falls, was charged Tuesday with battery after he allegedly beat up his victim in front of the man's child, then reportedly picked the boy up and apologized for beating up his father on August 29th. Wurzer was arraigned Tuesday in Twin Falls County Magistrate Court on a misdemeanor count of battery. Wurzer is being held in the Twin Falls County Jail in lieu of \$1,000 bond, and a pretrial conference is set for Nov. 29th.

Gabriel Reyes, of Malta, who was charged with three felony counts of rape has entered Alford plea on one count of rape as part of a plea agreement. By using an Alford guilty plea Reyes does not admit to all the elements of a charge but admits prosecutors have enough evidence to show he's guilty. Under the agreement, the state agrees to dismiss the remaining charges. The state will recommend two to 10 years in prison.

Reports say, Blaine County Sheriff Gene Ramsey is warning residents of a Visa scam. The scam comes as a phone call with someone claiming to be from the security and fraud department at Visa. They might say you've been flagged for an unusual purchase pattern. If they ask for the three digits on the back of your credit card and last four digits of your social security number, it could be a scam.

News Report October 7, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

The Gooding Police Department has been investigating and has identified several suspects in the recent clown threats in the area. According to reports, through posts on social media found over the weekend, school resource officer Sgt. Thiemann was able to identify and speak with those involved. The Gooding Police Department takes these threats very seriously and is working to document all citizen complaints and reports.

The trial set to begin Wednesday for Vadian Dougal, of Burley, the man police say attempted to abduct a girl has been delayed. Dougal is charged with second-degree attempted kidnapping and misdemeanor charges of battery and enticing a child. A status conference is set for Nov. 1st in Cassia County District

Court. Attempted second-degree kidnapping carries a maximum penalty of 12 years, six months in prison and a \$25,000 fine.

News Report October 10, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Jhoan Martinez of Buhl, who was arrested last week for vandalizing property with graffiti, plans to plead guilty and be sentenced tomorrow. Martinez was arrested Wednesday after police reportedly got a call about someone spray painting a stop sign at Falls Avenue and Harrison Street in Twin Falls. Officers responded to the area and found Martinez who admitted he was the one painting the graffiti. Martinez has been charged with five misdemeanor counts of vandalizing property with graffiti and a misdemeanor count of possession of paraphernalia.

Jeremiah Justesen, a former Heyburn police officer was sentenced Wednesday to 30 days in jail. According to reports, Justesen entered a plea agreement with the state and pleaded guilty to two misdemeanor counts of violation of a no-contact order. Justesen was convicted in September of misdemeanor domestic battery or assault in the presence of a child and sentenced to 10 days in jail with 355 days suspended on each of the three counts. He was also sentenced to 24-months of probation.

News Report October 11, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Jose Segundo, of Jerome, has been arrested after allegedly confessing to a gruesome murder of Carmen Magallanes, of Ryndon, whose body was found last month. According to reports, the Elko County Sheriff said searchers were led to the scattered remains Monday by Segundo who is being held without bail on suspicion of Open Murder. Segundo allegedly claims to have had an affair with the 34-year-old mother and told investigators he became angry when she refused his advances.

An Amber Alert was issued for an 11-year-old boy who authorities say went missing out of South Ogden Sunday night. According to reports, South Ogden police say Caden Rhew went willingly with suspect Weston Kubbe. However, the Amber Alert has classified the boy's disappearance as an abduction. Police took Kubbe into custody late yesterday afternoon and Caden was found safe.

News Report October 12, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Twin Falls Police responded to a call of man who barricaded himself inside of a storage shed yesterday afternoon on the 500 block of Madrona Street. The man – who had several warrants out for his arrest – gave in without incident after about 15 minutes. Although he was initially believed to be in possession of a gun, it was later determined the man was not in possession of a weapon. Police say Morningside, O'Leary and, Bridge Academy were locked down until the situation was cleared.

The Jerome County Sheriff's Office is looking for a missing woman out of Pocatello. 35-year-old Lilly Morse was reported missing/endangered on Sunday, Oct. 9 by Pocatello Police. Reports say, Jerome County Sheriff's deputies located Morse's car in Jerome County on Sunday evening with no sign of Morse. Anyone with information or who may have seen Morse is encouraged to call the Jerome County Sheriff's Office at 208-324-1911.

Robert Nevarez, of Buhl, is in custody after resisting arrest, damaging a police vehicle, and escaping from the vehicle. Nevarez had a warrant out for his arrest for failure to appear on a DUI court case. After police arrested Nevarez allegedly kicked the police car window open, broke it, and wiggled his way out and onto the ground. Reports say Nevarez was taken to St. Luke's where it was discovered that he was under the influence of meth.

News Report October 13, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Collin Ramsey, of Twin Falls, who was charged with threatening to stab a man in June during a racially-charged road-rage incident pleaded guilty Tuesday but said he pulled the knife in self-defense. As part of a plea deal, prosecutors dismissed a weapon enhancement that could have added up to 15 years to any potential prison sentence. Prosecutors also agreed to seek a two to five year prison term that Ramsey could avoid by successfully completing the Rider program through the department of correction.

Jack Omohundro, of Twin Falls, was arraigned into Twin Falls Magistrate Court yesterday for providing the methamphetamine that was sold to an undercover officer. Omohundro was charged with five counts of felony aiding and abetting delivery of methamphetamine and one felony count of possession of methamphetamine. Omohundro's preliminary hearing is scheduled for Oct. 21st.

News Report October 14, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

According to reports, Twin Falls Police say a body found yesterday in the City Park was the result of a suicide. The man likely died about 45 minutes before his body was found in the northeast corner of the park just before noon.

73-year-old Richard Sexton, of Twin Falls, pleaded guilty Wednesday in federal court to possession of child pornography and admitted to downloading more than 400 images and videos depicting child sex acts. The plea deal does not stipulate a prison term, but the federal crime of possession of child pornography is punishable by up to 20 years in prison, at least five years of supervised released and a \$250,000 fine.

The Jerome County Sheriff's Office has been getting reports of scammers calling residents saying they missed jury duty and must pay or they will be arrested. Another scam is the romance scam. The scammer makes an online love connection with the victim before asking them for money so they can visit, or for an emergency. Sheriff McFall warns residents to never give your money or information to anyone you don't know. A Jerome woman reportedly lost \$80,000 to a scammer.

David Higbee, of Pocatello, will spend at least three years in prison for sexually abusing a Twin Falls girl, but he could be there up to 15 years and, according to reports, District Judge Randy Stoker said Higbee will likely "die in the Idaho State Penitentiary" if he doesn't accept responsibility and seek treatment. Prosecutors also revealed that Higbee was convicted in 1985 of molesting a young girl in California.

New information was released yesterday on the DEA's plan to outlaw the popular herbal supplement Kratom and classify it as a Schedule 1 drug. Reports say, after strong public backlash the agency has decided to hold off on the ban and take public comment on the issue. Users claim Kratom is a natural pain reliever and it can help with symptoms of everything from depression to PTSD.

News Report October 17, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Aileen Medrano, of Rupert, has pleaded guilty to driving under the influence the night of January 24th which resulted a crash that threw several people from the minivan they were in. According to reports,

based on her plea agreement, after successful completion of the rider program Medrona will be on probation for 10 years and have her driver's license suspended for five years.

Twin Falls Police Detectives have identified and recovered a GPS device and a Radar Detector believed to be stolen during a vehicle burglary at the Magic Valley Mall or the Twin Falls Walmart. If, during the months of August and September 2016 you left your vehicle parked at the Twin Falls Walmart or at the Magic Valley Mall and discovered that either or both of these items were stolen from your vehicle, please contact Det. News Report October 18, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Andrew Brooks, of Portland, Ore., a parolee sentenced to prison for a three-day crime spree earlier this year is facing legal trouble again for having marijuana in the Jerome County Jail. Brooks is now facing two new felony charges and was charged with the crime last month and is set for a preliminary hearing in the case next month.

News Report October 19, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Gabriel Luna, of Jerome, and Dayna Canales, of Gooding, who were both wanted by police led officers and deputies on a pursuit yesterday that, reports say, ended with their arrests after deputies flattened their tires with spike strips. Luna was the driver and had a felony warrant in Gooding County for forgery and out of Jerome for a felony probation violation. Canales was wanted for violating her probation on a driving under the influence conviction earlier this year.

The sentencing hearing for Jose Lara, of Burley, was delayed yesterday. Lara pleaded guilty to second-degree murder in July for killing his wife in 2012. According to reports, the request came from Lara's defense attorney needed more time to prepare for the hearing. Under the agreement the state will recommend a sentence of 18 years in prison to life. The sentencing hearing is reset for Nov. 15 in Cassia County District Court.

Prosecutors will reportedly dismiss the case against Mohammed Hussein Eldai, of Twin Falls, who was charged with sexually assaulting a developmentally delayed woman in August. After conducting a more thorough investigation, Twin Falls Police determined there was insufficient evidence to continue "as the victim does not meet the statutory definition of a vulnerable adult."

Mary Huber, who was rescued early Monday from the Snake River Canyon when rescuers hoisted her to safety was wanted on a \$5,000 warrant and arrested after her rescue. Huber was scheduled to be arraigned yesterday in Twin Falls County Magistrate Court on a misdemeanor count of resisting or obstructing arrest. Reports say the charge stemmed from a July incident in which Huber was riding in a car with a Twin Falls man wanted by police. When a deputy tried to pull over the car, the pair fled at high speed, abandoned the car and escaped on foot.

The trial for Ronnie Kincaid Jr., of Declo, who is accused of murdering his wife, Melissa Kincaid, has been delayed again. Kincaid was set to go to trial Nov. 2nd, but his defense attorney reportedly said he needs time to go over more newly discovered evidence. The trial has been reset for Feb. 27th.

Trial dates have been delayed for Antonio Gallegos, of Twin Falls, and David Ceballos, of Jerome, who have been charged with attempted murder in an execution-style shooting of Francisco Javier in the desert southwest of Shoshone on Jan. 23rd. One trial has been rescheduled for November and the other has been rescheduled for early next year.

News Report October 20, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Prosecutors have dismissed an attempted murder charge against Juan Suarez, of Jerome, who is accused of shooting at a farmer on Easter Sunday night. Suarez reportedly faced up to 30 years in prison if convicted on the second-degree attempted murder charge, but his defense attorneys argued last month the farmer's identification testimony should be barred from trial because the identification procedure used by Jerome County Sheriff's deputies was allegedly "tainted and coercive."

News Report October 21, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Anita Taylor, and daughter, Kimberly Taylor, both of Twin Falls, were arrested Wednesday on forgery charges after a retail employee had questions about transactions. Both women were arraigned in Twin Falls County Magistrate Court yesterday. Anita Taylor was charged with felony forgery and is being held on a \$50,000 bond. Kimberly Taylor was charged with criminal possession of a financial transaction card and forgery, and she is being held on a \$50,000.

According to reports, Voices against Violence says one in three women will experience domestic violence in their lifetime. Yesterday evening Voices against Violence hosted a candlelight vigil to help bring awareness to the issue of domestic violence. The group read poems, talked and listened to music. Next to awareness, what the group needs most are donations and volunteers. If you would like to help, go to crisiscenterofmagicvalley.org.

The federal conspiracy case against Ammon Bundy and six co-defendants is now in the hands of jurors. Bundy in early 2016 led what turned out to be a 41-day occupation of a national wildlife refuge near Burns, Oregon. He and his co-defendants are charged with conspiring to impede Interior Department employees from doing their duties at the refuge.

On Monday, Brenda Jaime-Sainz, of Yakima, Washington was sentenced to 17.5 years in prison for conspiracy to distribute methamphetamine, distribution of methamphetamine, and possession of methamphetamine with intent to distribute undercover personnel seized about 10 pounds of methamphetamine headed to the Magic Valley in April. Mauro Morales, of Buhl, allegedly purchased methamphetamine from Sainz sentenced to 8 years in prison for conspiracy to distribute methamphetamine and possession of firearms in furtherance of a drug trafficking crime.

News Report October 24, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Following a trial that began Wednesday and ended Friday, a Twin Falls jury acquitted William Agnew, who was charged with a felony count of aggravated battery stemming from a fight which occurred in May. Agnew was accused of pulling out a knife and attacking a man. But it was proven in court that Agnew acted in self-defense after being struck with a pipe when he tried to talk to his girlfriend. Agnew faced up to 30 years if convicted. Instead, Agnew is now free after spending more than five months in custody in lieu of \$75,000 bond.

On Friday, a Lincoln County jury consisting of nine women and three men deliberated about 2 ½ hours acquitted Gooding father and registered sex offender Michael Page who was accused of raping his children's babysitter last summer.

Ruben Ortiz Jr., of Burley, who went on a burglary spree that included the homes of a judge and a probation officer, says he stole to cope with depression. According to reports, Bonneville County District Judge Jon Shindurling sentenced Ortiz to serve three to 10 years in prison for five felony

burglary charges. Ortiz started burglarizing homes shortly after he was released from the rider program run by the Idaho Department of Correction. He had been sentenced to the program because of previous burglary charges.

News Report October 25, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Jerry Cruz, of Twin Falls, who apparently hanged himself at the Idaho State Correctional Institution in Boise on October 13th, died Saturday. Cruz was convicted of felony burglary in Twin Falls last year and was sentenced to two to five years in prison. He would have been eligible for parole in March 2017. The Ada County Sheriff's Office is investigating the death, which is believed to be a suicide.

News Report October 25, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Kelsey Osborne, of Gooding, is facing a criminal charge and fighting to regain custody of her two children after she reportedly said she gave her daughter butter infused with marijuana to treat the girl's seizure-like symptoms. Osborne was arraigned last week in Twin Falls County Magistrate Court on a misdemeanor count of injury to child.

Chad Schiermeier, a former Blaine County Sheriff's deputy, has been indicted on six felony counts of misuse of funds over \$300 by a public employee. During summer, Schiermeier scheduled and organized Police Activities League, a non-profit program for children and he was in charge of the program's financial expenditures and budget. Discrepancies were discovered and the case was handed over to ISP. Schiermeier was arrested on Saturday and he is being held in the Mini-Cassia Criminal Justice Center on a \$200,000 bond.

A missing 6-year-old girl and her mother were found safe Monday afternoon after officials had issued an AMBER Alert for Danika Packard, who was pulled from school by her mother Tracy Packard. Both Tracy and Danika were unhurt when they were located by a citizen right after the Amber Alert was issued.

News Report October 26, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Andrew Hawley, of Twin Falls, who faced 38 child pornography charges made a last-minute deal with prosecutors to avoid trial and likely avoid prison. Prosecutors dismissed 34 of Hawley's charges in exchange for a guilty plea on four felony counts of possessing sexually exploitative material of a child. According to terms of the plea agreement, Hawley's sentence will be based on a psychosexual evaluation: if the evaluation shows he's a low risk to re-offend, prosecutors will seek a probation sentence; if it shows he's a moderate risk to re-offend, prosecutors will seek a retained jurisdiction program; if it shows he's a high risk to re-offend, prosecutors will seek a prison term.

News Report October 27, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Andres Amador, of Burley, who has been accused of sending an explicit picture of his ex-girlfriend to another man, has been charged with felony video voyeurism. According to reports, the Minidoka County prosecutor's office charged Amador for willfully and intentionally disseminating an intimate image of another person without their consent. Amador was taken into custody at the Mini-Cassia Criminal Justice Center on Sunday.

Daniel Mills of Jerome was convicted yesterday by a federal jury in Boise for unlawful possession of firearms. Mills was indicted in February of this year. Mills faces up to ten years in prison, a maximum

fine of \$250,000, and up to three years of supervised release for unlawful possession of firearms. Sentencing is set for January 12, 2017 at the federal courthouse in Boise.

News Report October 28, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Yesterday afternoon a jury exonerated brothers Ammon and Ryan Bundy and five others of conspiring to impede federal workers from their jobs at the Malheur National Wildlife Refuge. Some of the defendants also were charged with possession of firearms at a federal facility and were acquitted on that count as well. The standoff began Jan. 2nd and lasted nearly six weeks, bringing new attention to a long-running dispute over control of federal lands in the U.S. West.

News Report October 28, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Ammon Bundy's attorney was tackled by U.S. Marshals during a heated argument with the judge after his client was acquitted on all counts Thursday afternoon. After the verdict was read, attorney Marcus Mumford argued that Bundy was free to go. Mumford was yelling that his client was free to go. Ammon Bundy and his brother, Ryan, will remain in custody because they are still facing charges in Nevada stemming from a high-profile 2014 standoff with federal agents trying to round up their father Cliven Bundy's cattle.

Nevada McCutcheon, of Buhl, was arrested yesterday for allegedly driving a motorcycle in excess of 130 mph. After McCutcheon was taken to the Twin Falls County Jail a deputy reportedly found a syringe in McCutcheon's jacket pocket at the time of booking. He was arraigned in Magistrate Court in Twin Falls Thursday on charges of driving without privileges, reckless driving and possession of drug paraphernalia, all misdemeanor charges.

Twin Falls County Deputies arrested Catalina Garcia, of Twin Falls, after finding over 5 pounds of meth in a home. Garcia was taken into custody on a charge of trafficking methamphetamines, after deputies served a search warrant Wednesday to a trailer on Grandview Drive. Garcia has been charged with trafficking methamphetamine.

News Report October 31, 2016 – Broadcast at 6AM, 7AM, and 8AM Duration 1 minute

Clarence Bowlin, of Burley, who is accused of using a baseball bat to hit a Murtaugh high schooler in the leg, is closer to trial after his case was bound over to district court Friday after a preliminary hearing. According to reports, Bowlin was originally charged with felony aggravated battery. Prosecutors amended Bowlin's charge to felony aggravated assault before Friday's hearing.

The Justice Department and FBI officials are reportedly working to secure approval that would allow the FBI to conduct a full search of top Hillary Clinton aide Huma Abedin's newly discovered emails. Government lawyers haven't yet approached Abedin's lawyers to seek an agreement to conduct the search, but plan to get a search warrant from a judge to conduct the search of the computer. Investigators believe that the computer will include emails that were deleted from the Clinton server before the FBI took possession of it as part of that earlier investigation.

Holly Morrissey, of Twin Falls, was charged with two felony counts of delivering methamphetamine after allegedly selling methamphetamine to a confidential informant. She was arraigned in court Friday

in Twin Falls County Magistrate Court. Morrissey is being held on a \$100,000 bond. Her preliminary hearing is scheduled for November 4th.

According to reports, police said it appeared both officers were taken by surprise in the Wednesday shootings and had no opportunity to defend themselves. The 46-year-old suspect, identified as Scott Michael Greene.

Reports say Cheyann Mardell-Evans was shot the evening of Nov. 27th outside her home at 2710 E. 3700 N., about a half-mile west of Grandview Drive South. Mardell-Evans was taken to St. Luke's Magic Valley Hospital with non-life-threatening injuries and was later released. The suspect is male, about six feet tall with a medium build. He is described as having a "distinct, protruding forehead" and dark eyebrows.

Cody Meade, of Twin Falls, has been charged with two felony counts of propelling bodily fluid or waste after he allegedly spit at deputies who were trying to restrain him on Nov. 16th. This isn't his first charge while in jail. He was charged with injuring the jail after allegedly breaking a window in July.

Consumers should not open these emails or click on any links, but delete the emails and contact his office to report the scam.

Cody Meade, of Tennessee, an armed robbery suspect in custody at the Twin Falls County Jail, reportedly broke a mirror and window, climbed out of his cell and took an inmate hostage by holding the jagged, broken mirror frame around the man's neck and throat. Jail deputies rushed to rescue the hostage when the inmate tried adjusting the mirror frame at the victim's neck. Meade was arrested in May on suspicion of robbing an Oasis Stop 'N Go at gunpoint and has racked up six additional felony charges while in custody. In total, Meade now faces seven felonies for robbery, aggravated battery, two counts of injury to jail, and three counts of propelling bodily fluid or waste at a law enforcement officer.

The third of three sisters that, according to reports, police say stole \$221,000 in public assistance benefits has taken a deal offered by the state. Olivia Munoz, of Burley, has pleaded guilty to one count of felony public assistance fraud for obtaining public assistance by making false statements to Health and Welfare and not disclosing all income from July 2008 to April 2015. Two counts of the same charge will be dismissed under the plea agreement. Munoz is set to be sentenced Jan. 31 in Cassia County District Court.

Jason Anderson, of Jerome, a cattleman, is being charged with more than one dozen grand theft and branding violations. According to reports, a California owner transported more than 60 cattle to Idaho for pasture in 2011 for Anderson to take care of. During 2013 and 2014 Anderson reportedly sold the owner's cattle, butchered several steer and sold the meat without the permission or knowledge of the owner.

The 17 men accused of conspiring in an armed standoff against federal agents near Nevada rancher Cliven Bundy's property in April 2014 are looking at three trials in Las Vegas. According to reports, U.S. Magistrate Judge Peggy Leen reversed the order that federal prosecutors proposed, and she accelerated the schedule. The six followers and gunmen of the standoff will start their trial on February 6th. Thirty days after their trial ends, six alleged "mid-level" standoff leaders and organizers will stand trial. Thirty days after that trial ends, proceedings will begin for Cliven Bundy, sons Ammon and Ryan Bundy, and co-defendants Peter Santilli and Ryan Payne.

Skylar Meade was arraigned in Twin Falls County Magistrate Court on a felony count of major contraband in a correctional facility. Meade also faces nine felony counts stemming from an incident Nov. 4 when deputies said he fled from a sheriff's sergeant, firing three shots at the sergeant during the pursuit. Meade's older brother, Cody Meade, is also charged with a slew of felonies, including robbery and aggravated battery. He's accused of the armed robbery of an Oasis Stop 'N Go in May and also charged with escaping from his cell Dec. 5 and using a broken mirror frame to take another inmate hostage.

A jury in Charleston, S.C., has found Dylann Roof guilty on all 33 counts of federal hate crimes he faced for murdering nine people and attempting to kill three others during Bible study at a South Carolina church in June of 2015. Roof has asked to represent himself in the penalty phase of the trial, which is scheduled to begin Jan. 3rd.

A police officer assassinated Russia's ambassador to Turkey, Andrey Karlov, at an art exhibition in Ankara on yesterday. According to reports, the gunman shouted "Do not forget Aleppo!" as he opened fire. Russian President Vladimir Putin called the assassination a "provocation," vowing to step up security at diplomatic missions.
