

POST-FILING RENEWAL ANNOUNCEMENT INSTRUCTIONS

The following contains instructions for the broadcast of post-filing renewal announcements for Sinclair's **South Bend, IN** station. Pre-filing announcements are no longer required. Included with these instructions are the text of the post-filing announcements and a Statement Certifying Compliance that needs to be completed, dated, executed and **placed in the station's online public inspection file within seven (7) days** after the last post-filing renewal announcement has been aired. If for any reason the station did not air the announcements as required, please contact the company's communications counsel before the Statement Certifying Compliance is finalized, dated and executed.

Post-filing Renewal Announcements for WSBT-TV, South Bend, IN, Facility ID 73983

Instructions:

The station is required to broadcast **a total of six post-filing announcements**, beginning no later than Tuesday, **April 8, 2021**. The announcement must air on the station at least once per week (Monday through Friday) for four consecutive weeks, with no more than two broadcasts in the same week. Broadcasts made in the same week cannot air on the same day. Announcements must air between the hours of **7:00 am and 11:00 pm** local time. The station must use visuals with full text of the on-air announcement when the information is being orally presented by the announcer.

Text:

"On April 1, 2021, WSBT Licensee, LLC, licensee of WSBT-TV, 560 MHz, South Bend, IN, filed an application with the Federal Communications Commission for renewal of its broadcast license. Members of the public wishing to view this application or obtain information about how to file comments and petitions on the application can visit publicfiles.fcc.gov, and search in WSBT-TV's public file."
